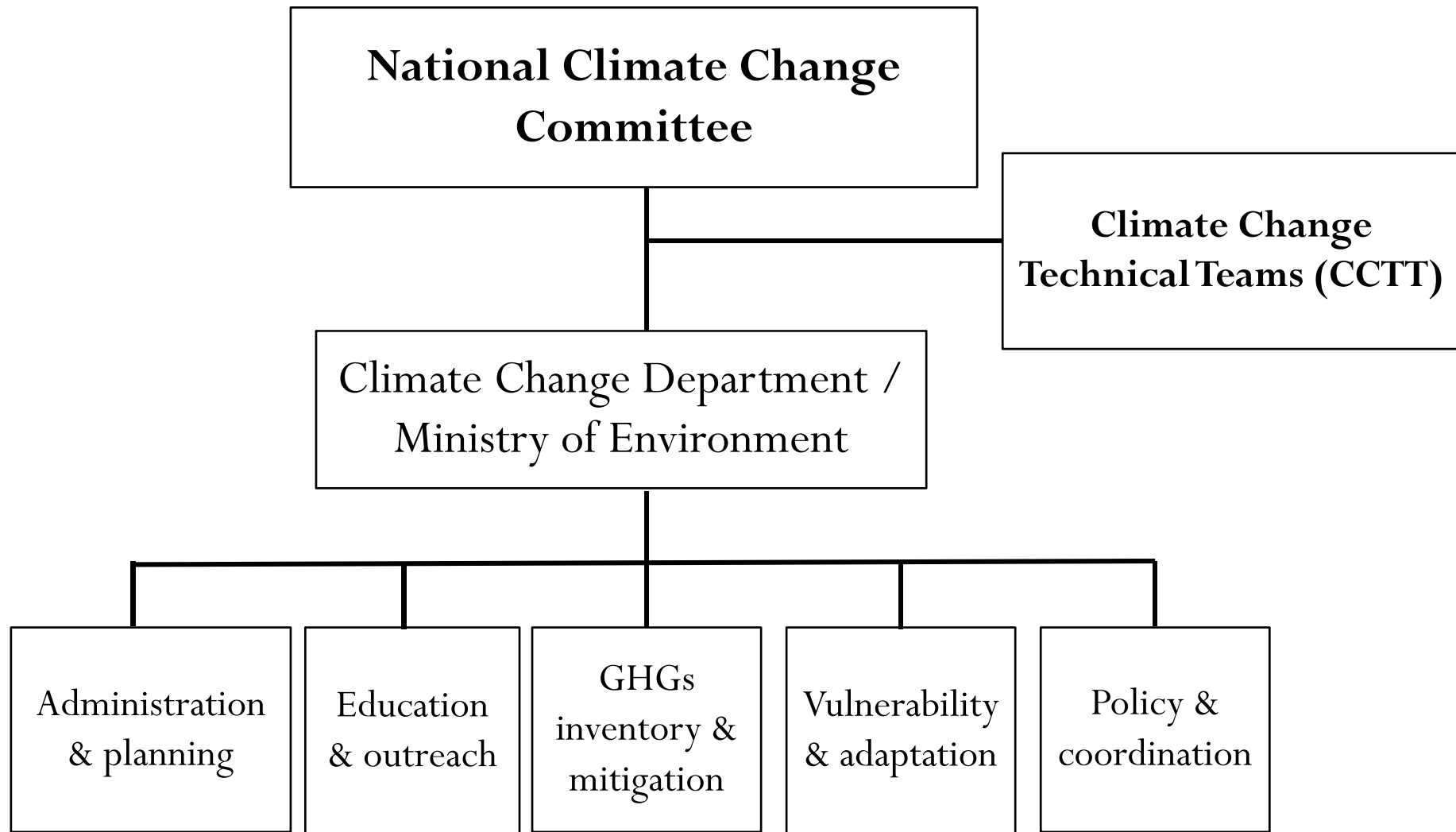
Current adaptation work in Cambodia

- Main streaming climate change into the National Sustainable Development Plan-update (2009-2013)
- National adaptation programme of action (NAPA) published in 2007 – Four (4) LDCF are under way to implement part of the Cambodia NAPA;
 - The projects address adaptation issues on agriculture, early warning, coastal zones, food security for rural communities
- Cambodia Climate Change Alliance (CCCA) 2010-2014, part of the EU Global Climate Change Alliance (GCCA);
- Cambodia Climate Change Strategic Plan (CCCSP) is being developed with focus on 8 strategic objectives.

Current CC institutional arrangements

- Inter-Ministerial National Climate Change Committee (NCCC) was established in April 2006: to prepare, coordinate and monitor the implementation of policies, strategies, legal instruments, plans and programmes to address climate change issues.
- Climate Change Technical Team (CCTT) was established with a representative from 20 line Ministries.
- Climate Change Department, established in 2009 within the Ministry of Environment to support the NCCC. This indicates government's strong commitment to strengthen climate change institution in the country.

Policy drive to address climate change

The National Strategic Development Plan (NSDP) of 2009-2013 emphasizes that:

‘To effectively deal with the implications of climate change, the capacity of RGC institutions needs to be strengthened to identify and develop a strategy to deal with the anticipated impact of the climate change, and strengthening disaster management capabilities.’

- Engaging the participation of Stakeholders
- Building public-private partnership and national ownership
- Aligning the process with national development goals
- Ensuring linkages with climate change strategies of sectors
- Capturing gender and vulnerable groups and ecosystems
- Using programme-based approaches with medium and long-term adaptation responses
- Developing M&E, and learning pathways
- Identifying public and international financing modalities
- Public climate change expenditure and costing for adaptation assessment is under way.
- Conducting consultation and review for validation

- The Cambodia Climate Change Strategic Plan (CCCSP) presents an opportunity to move towards the above mentioned goals
- Cambodia is ready to embark on the NAP process, building on the existing frameworks
- The NAP process will help address gaps in existing work, including the CCCSP that only serves as a strategic objectives.
