# The thirty-second session of the Subsidiary Body for Scientific and Technological Advice (SBSTA)

#### Bonn, 31 May-10 June 2010

#### Discussions on the NWP

During the thirty-second Subsidiary Bodies meeting that took place in Bonn from 31 May to 10 June, the SBSTA recognized the work of the NWP in advancing scientific and technical knowledge on adaptation, impacts and vulnerability; as well as in engaging stakeholders, catalyzing action, and disseminating relevant information and knowledge. It also noted the importance of continuity of these activities.

The SBSTA invited Parties and organizations to submit views and information on the effectiveness of the NWP to the secretariat by 16 August 2010. These submissions will be compiled into a miscellaneous document to inform discussions at an informal meeting to take place before the thirty-third session of the SBSTA (please see "Upcoming NWP milestones" below for further details of this meeting).

#### Other negotiations on adaptation

Negotiations on adaptation under the Ad hoc Working Group on Long-term Cooperative Action under the Convention (AWG-LCA) progressed with Parties considering issues related to adaptation, including possible institutional arrangements for adaptation. Negotiations were facilitated by a <u>text</u> prepared by the Chair. The next <u>AWG-LCA</u> meeting will take place from 2-6 August in Bonn.

Under the Subsidiary Body for Implementation (SBI), Parties continued to look into ways to enhance the implementation of adaptation, with a view to adopting a decision at COP 16 in Cancun, based on the <u>draft decision text</u> on progress on the implementation of decision 1/CP.10, contained in the annex of the draft conclusions proposed by the Chair.

#### The third NWP Focal Point Forum, 4 June 2010

The third NWP Focal Point Forum was held during SB 32 in Bonn, on the evening of the 4<sup>th</sup> of June. It was chaired by the SBSTA Chair, Mr. Mama Konaté and attended by over 80 participants representing Parties and NWP partner organizations. The participants engaged in in-depth discussions on the various aspects of the implementation of the NWP. The <u>summary note</u> is available on-line.

#### **Background of the Forum**

In June 2008 the SBSTA requested the secretariat to regularly organize Focal Point Forums to take stock of activities undertaken by organizations and institutions in support of the objectives of the NWP and to promote a periodic dialogue between Parties and engaged organizations and institutions (FCCC/SBSTA/2008/6, paragraph 29). At the same session, concrete mandates were established to further engage organizations, with a greater focus on catalyzing actions at the community, national and regional levels; and action on education, training and awareness-raising. These were key themes dealt with at the third Focal Point Forum.

The NWP is the only multilaterally agreed initiative on adaptation in place. The Focal Point Forums are a valuable place to share information, knowledge, experience and practices on adaptation under a multilateral umbrella.

#### Outcomes and key messages

Participants exchanged ideas on how to further enhance their work on the assessment and understanding of climate change impacts and vulnerability, and on how to make informed decisions on adaptation to climate change. Representatives from NWP partner organizations shared information on relevant activities being carried out within their respective organizations, especially activities aimed at reaching adaptation practitioners at the national, subnational and community levels. Delegates from Parties and a large number of partners were able to benefit from learning about the multitude of adaptation-related activities taking place.

Participants also contributed to an interactive brainstorming session by sharing views and ideas on how to capitalize on the success of the NWP to date, and by discussing adaptation needs that have been identified during the course of the NWP.

It was highlighted that a multitude of tools, methodologies and knowledge products have been generated through the NWP, and that these need to be harnessed even more in the future through the facilitative mechanism of the NWP. Participants noted that the NWP is a good mechanism for catalyzing action on adaptation, and it has been highly effective in facilitating the exchange of experiences, knowledge and information among partner organizations. They added that there is a lot of multi-thematic and cross-sectoral work taking place by partners, and there are opportunities for the NWP to further facilitate partnerships in this regard.

# Technical Workshop on costs and benefits of adaptation options Madrid, Spain, 22-24 June 2010

The technical <u>workshop</u> on costs and benefits of adaptation options involved representatives from Parties, relevant organizations, communities and experts, and was held from 22-24 June in Madrid, Spain. This workshop was the last technical workshop to be held under the current implementation phase of the NWP.

#### **Background of the workshop**

At its 28th session, the SBSTA requested the secretariat to organize this workshop, under the guidance of the Chair of the SBSTA, with a view to facilitating the identification of appropriate adaptation practices and measures and avoiding maladaptation. The workshop took into account <u>submissions</u> by Parties and organizations, a <u>synthesis report</u>, and a <u>technical paper</u>.

The workshop was held under NWP work area number 5, "Socio-economic Information", under which activities are undertaken with a view to promoting the availability of information on the socioeconomic aspects of climate change and improving the integration of socio-economic information into impact and vulnerability assessments.

#### Outcomes of the workshop

Participants at the workshop noted that the identification of costs and benefits of adaptation options fits into a larger context of selecting and prioritizing adaptation options, which may use one of a variety of decision-making tools, including: cost-benefit analyses; cost-effectiveness analyses; multi-criteria analysis, and/or alternative risk assessment methods.

While a body of work is emerging and important lessons have been learned, more needs to be done to address issues of uncertainty, equity, and the technicalities of the valuation process itself. Participants recommended enhancing the sharing and dissemination of experience and capacity-building on the different tools available, and on the appropriateness of their use in different contexts.

#### The NWP Focal Point survey

#### A new NWP publication on: "Adaptation Assessment, Planning and Practice"

Under the guidance of the Chair of the SBSTA, the secretariat has facilitated and made available a new publication entitled: "Adaptation Assessment, Planning and Practice: an overview from the Nairobi work programme on impacts, vulnerability and adaptation to climate change". It synthesizes information and knowledge generated through the implementation of mandated NWP activities, such as workshops. This information and knowledge includes further needs, good practices, and lessons learned for the provision of information and data, impact and adaptation assessments, and adaptation planning and practices.

The sixteenth session of the Conference of the Parties (COP 16) and the sixth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP 6) will be held in <u>Cancún</u>, Mexico, together with the thirty-third sessions of the subsidiary bodies, the fourteenth session of the AWG-KP and twelfth session of the AWG-LCA.
