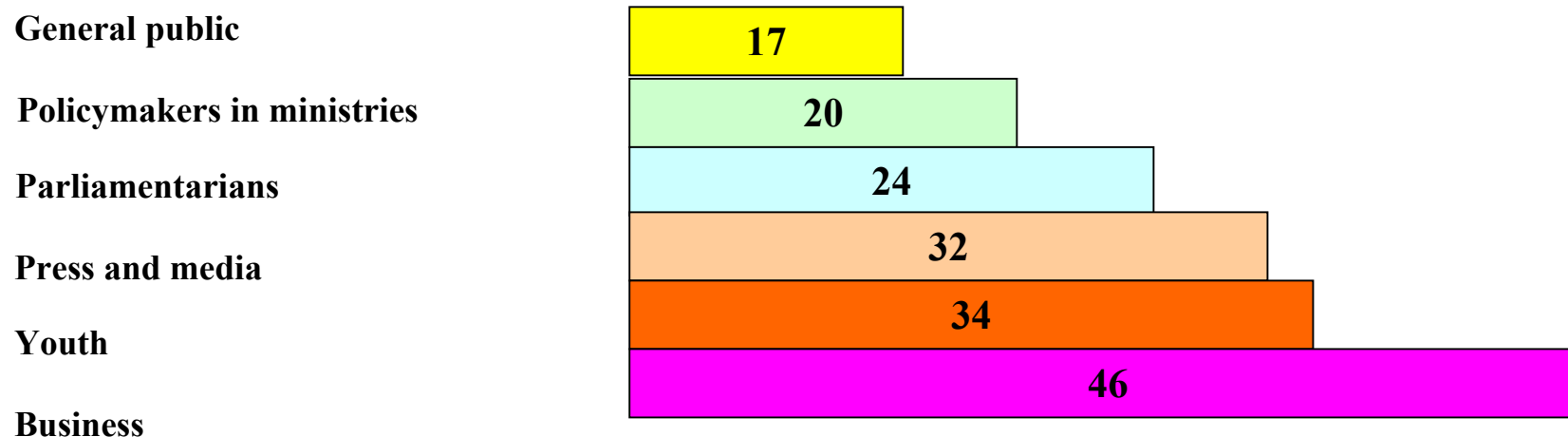

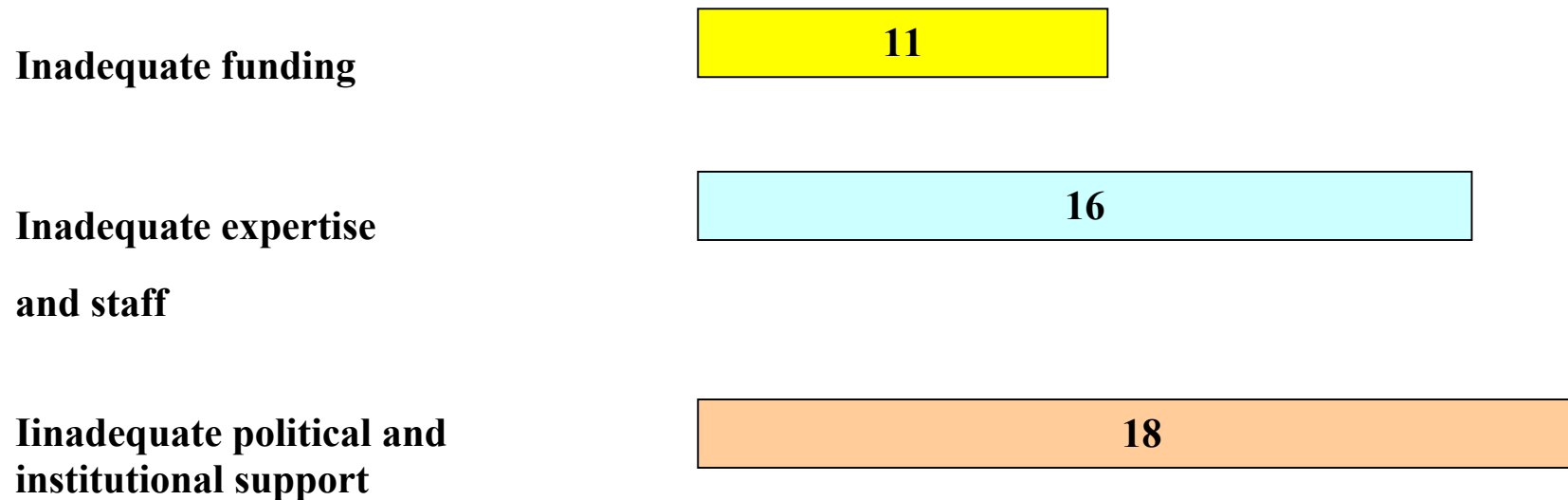

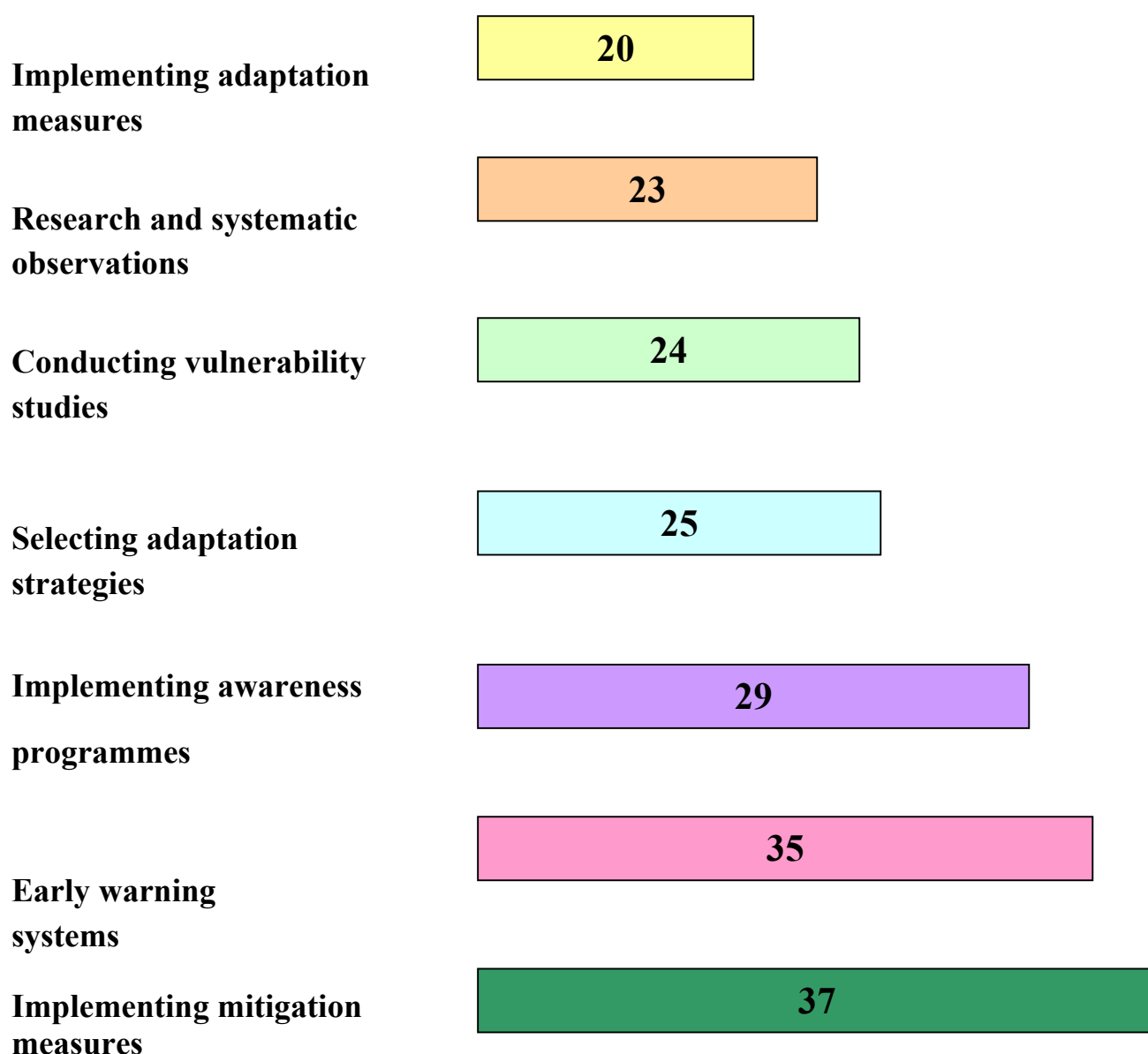
3. BARRIERS TO PROMOTING PUBLIC AWARENESS

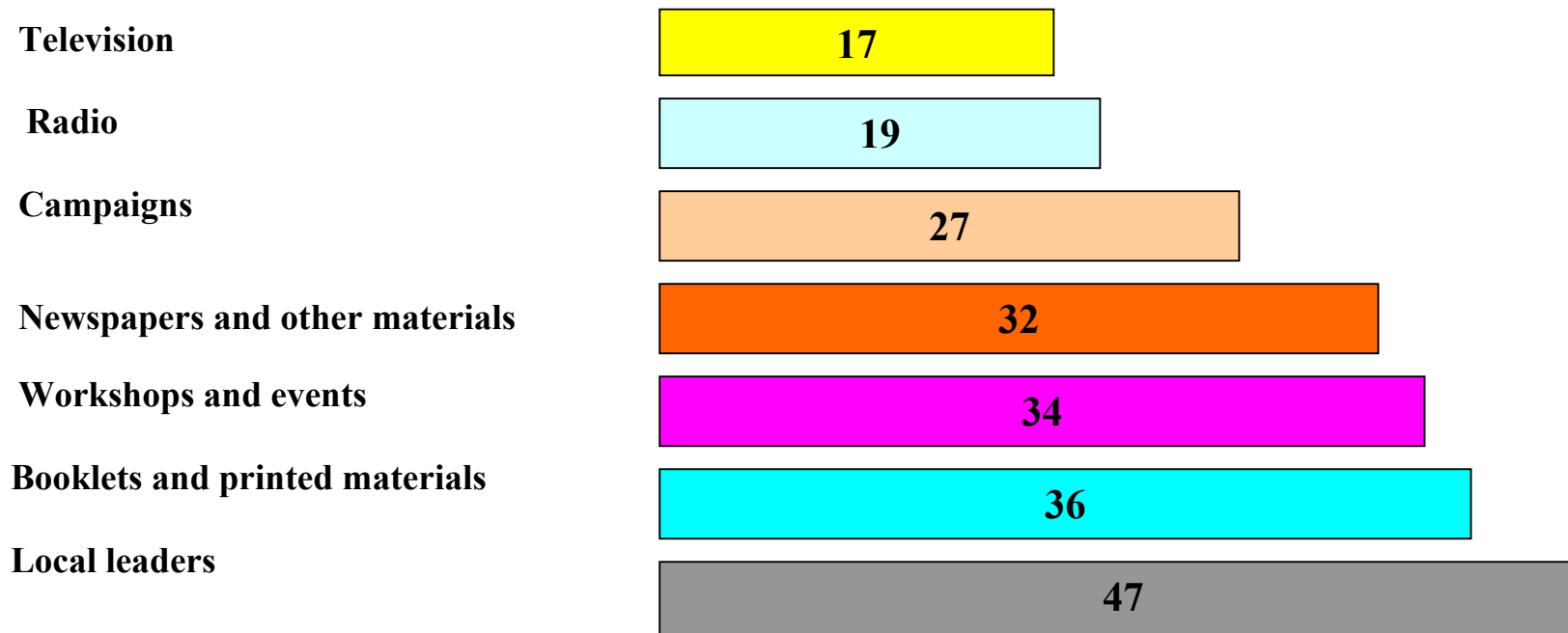
4. TRAINING PRIORITIES

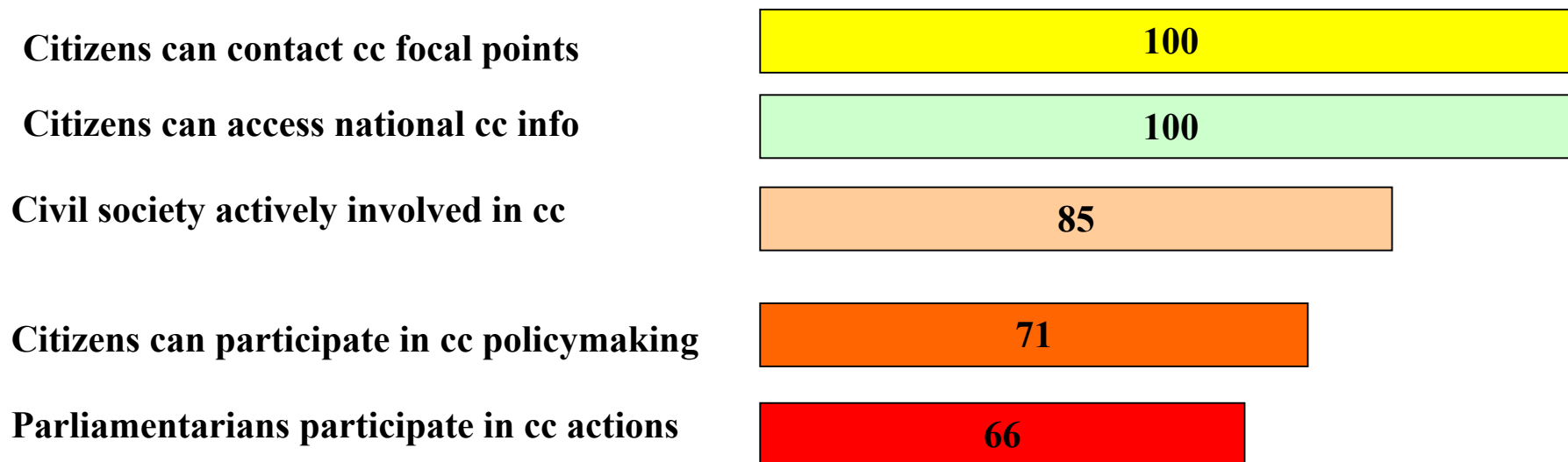

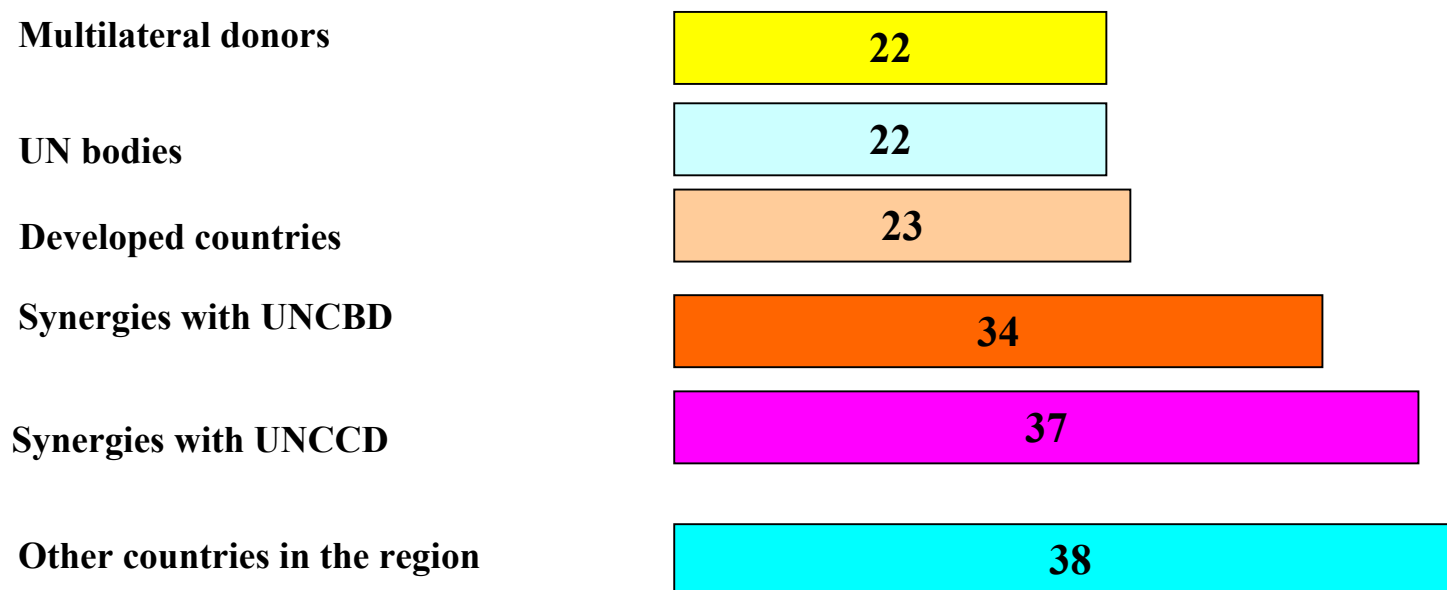
**6. PUBLIC PARTICIPATION AND ACCESS TO INFORMATION
