OBJECTIVES

The purpose of this special event is to present the Summary and Recommendations of the Standing Committee on Finance (SCF) on the 2016 Biennial Assessment and Overview of Climate Finance Flows (BA). More specifically, the event aims to:

- enhance the collective understanding of the state of play with regard to climate finance flows;
- highlight recent developments related to transparency and consistency of climate finance information in general and of support provided and received more specifically;
- discuss how the future BAs can provide useful information on global progress on the goals outlined in Article 2 of the Paris Agreement, inter alia, information on consistency of climate finance flows with a pathway towards low greenhouse gas emissions and climate-resilient development.

FOCUS

The special event presents an opportunity for the SCF to present the key findings and recommendations of the 2016 BA to a broader audience. It will focus on climate finance flows for the period 2013-2014, areas for further improvements in climate finance tracking and reporting, and implications of these flows, including composition, purpose and emergent trends relevant to the UNFCCC objectives, including the new goals set out in the Paris Agreement.

A keynote presentation and a panel discussion will discuss information contained in the *“Summary and Recommendations by the Standing Committee on Finance on the 2016 Biennial Assessment and Overview of Climate Finance Flows”* included in Annex II of the SCF report to COP22.

PARTICIPATION

The special event will be chaired by the co-chairs of the SCF with active participation of other SCF members, senior negotiators and senior representatives of the data producers and aggregators community.

The event will be open to Parties and observers, including the climate finance tracking and reporting community.
