

Information, views and proposals on the work of ADP of Republic of Uzbekistan

The Republic of Uzbekistan acknowledges the importance of activities of Ad Hoc Working Group on the Durban Platform for Enhanced Action (ADP) and highly appreciates its achievements and contribution.

In elaboration of the new climate Agreement it is needed to regard the importance of integrated approach to the issues of international cooperation in the field of climate change keeping to the principle of common but differentiated responsibility, as well as to determine the country capacity on climate change prevention considering the social-and-economical development of each country. For reaching this goal, in the framework of its future work program – particularly, in 2014 - ADP should comprehensively consider the financing issues via the Green Climate Fund for the development of national strategies on the climate change prevention alongside with the structural and organizational document shaping of new agreement. With this it will be feasible to assess the country capacity on climate change prevention.

In contrast to the Kyoto Protocol the coverage of the new climate Agreement should be much wider and monitor the global emissions and emissions of the key emitters separately.

It is required to develop the flexible mechanisms for the enhancement of ambitions of developed countries and the key emitters.

In the working out of the new climate Agreement it is required to pay attention to the importance of the balanced distribution of resources between the adaptation to climate change and mitigation of its consequences.

Regardless that the developed countries confirm the mobilizing of promised funds in the amount of 100 billion USD annually up to 2020, the results of the last discussions and negotiations give the reason to realize the slow advance in this direction. That is why it is required to consider this matter in parallel at each ADP meeting.

Uzbekistan welcomes the strengthening of the existing and creation of new financial mechanisms aimed at the provision of measures for the climate change prevention and adaptation, as well as technology transfer, capacity building and continuation of financing of different funds for the developing countries and countries with the economy in transfer by the developed countries for the elaboration and implementation of the regional and national action NAMA and NAPA plans on the mitigation and adaptation, preparation of their national communications.

Regarding the need in financial support to the developing countries in the implementation of measures aimed at adaptation to climate change, climate change prevention, technology transfer and capacity building it is important to activate international efforts for the increase of climate financing, also via Green Climate Fund. Scheme and priority directions of climate financing, distribution of funds, also of Green Climate Fund should be transparent to all parties.

Uzbekistan supports the efforts on the creation and development of MRV system for the comparison of actions of countries (both developed and developing ones) both related to emissions and financial support of developing countries.

Acknowledging the importance of technical and technological issues in reaching the global goal of UNFCCC it is needed to activate the actions on technologies' development and transfer in support of measures on climate change and adaptation, to support efforts aimed at elimination of barriers and to ease the access to new technologies.
