

The information, opinion and proposals of Republic of Uzbekistan on the issues related to ADP activities including inter alia the issues on mitigation of consequences, adaptation, funding, development and transfer of technologies, capacity strengthening and transparency of activities and support including the aspect indicated in ADP conclusions as adopted, Planning of work, paragraph 13 (a)–(d)

and

opinion and proposals of Republic of Uzbekistan on the activities, initiatives and options of enhancing the degree of activities' ambition including also the work plan on enhancing the degree of activities' ambition related to the mitigation of consequences, with special emphasis on 2013 year including the aspects in ADP conclusions as adopted, Planning of work, paragraph 15 (a)–(c)

For reaching the quantitative goals on the issues of prevention of climate change, adaptation, funds, development and transfer of technology, capacity building and also for the provision of logic duration of activities started within the other working groups and Convention programs it is necessary to include these issues to the agenda of ADP in the development of new Agreement.

Though the developed countries confirm mobilization of the promised funds to 2020 (100 billion USD), the results of the last discussions and negotiations show that the progress in this direction is very slow. That is why it is needed to consider this issue in parallel at each meeting of ADP.

Regarding the need in financial support for the developing countries in implementation of measures aimed at adaptation to climate change, prevention of climate change, technology transfer and capacity building it is important to invoke the international efforts for the increase of climate funding, including also the way via the Green Climate Fund. Apart from the other funds of climate financing the scheme and priority directions of funding, distribution of funds of Green Climate Fund should be transparent to all Parties.

Considering the importance of technical and technological issues in the process of reaching the global goal of UN FCCC it is also required to promote the measures on the development and transfer of technologies to support the actions on climate change and to support the efforts directed to the elimination of barriers and facilitation of the access to the new technologies.

In the elaboration of the new climate Agreement it is required to consider the integrated approach to the issues of international cooperation in the area of climate change keeping to the principle of general but not the differentiated responsibility as well as to define the country capacity on the climate change prevention for each country regarding the social-and-economical development of this country. For reaching this goal ADP in the framework of its work program should perform the comprehensive discussion of financial matters via development of national strategies on the prevention of climate change with Green Climate Fund, considering that such strategy will enable to objectively assess the country capacity on climate change.

Apart from Kyoto Protocol the coverage of the new climate Agreement should be wider and control the global emissions and the emissions of the main emitters separately.

With this the development of flexible mechanisms it is required to increase the ambitions of developed countries.

The other incentive for increasing the ambitions of developed countries and the main emitters is the development and introduction of the tax system to be applied to the private and government enterprises-emitters and mobilizing of funds in special fund which will be aimed at step-by-step introduction of up-to-date power-effective technologies in this country. Such approach will expedite the process of transfer to the resource-effective production.
