#### **Purpose**

This note provides participants with information on the content of the Regional Workshop on CDM and NAMAs, and contains links to relevant documentation. It will help participants prepare for the workshop, increasing the value of the event.

# **Background**

This first of a kind workshop on CDM and NAMAs will aim to facilitate sharing of experiences, lessons learnt and good practices in the process of preparation and implementation of NAMAs. It will also update DNAs and other stakeholders on recent development on priority areas of the CDM, as identified by the Conference of the Parties serving as the Meeting of the Parties to the Kyoto Protocol (CMP) at its last session, as well as to provide an opportunity for exchange of knowledge and experience among DNAs and practitioners to enable them to carry their role in the promotion and the implementation of the mechanism. Bilateral and multilateral agencies present at the workshop will provide participants with information on their NAMA support programmes. And countries will also be provided a platform -"NAMA Market Place"- to initiate dialogue with international organizations on potential support opportunities for implementation of their NAMAs. Further the workshop will also facilitate sharing of valuable lessons learned from CDM which are relevant for coordination of NAMA implementation.

The agenda comprises of 2 main pillars, "Training" and "Promotion of the CDM and NAMAs" with focus on finance, sustainable development co-benefits, stakeholder consultation, CDM PoAs, standardized baselines and the process of issuing letters of approval/authorization.

## **Objectives:**

#### I. Training

Enhance capacity of DNAs and mitigation experts to identify areas of improvement with regards to CDM LoAs approval process, on engaging in NAMA registry, conducting analysis of the sustainable development co-benefits of CDM and NAMAs, and on conducting an effective stakeholder consultation process. In addition, the aim is to update the participants on the current CDM requirements for PoAs and the recent developments in the regulatory framework; and to obtain their views and input for the improvement of this framework.

## II. Promotion of the CDM and NAMAs

Showcase good practices in implementation of NAMAs, including on institutional arrangements to coordination preparation and implementation of NAMAs and national MRV systems. Showcase the current possible sources of finance for CDM and NAMAs, including from the Green Climate Fund (GCF), multilateral banks, national development agencies, and Nairobi Framework Partners. Additionally, to present the CDM Executive Board's current strategy to increase demand for CERs through cooperation with the public and private sectors in compliance and voluntary markets.

# **Guiding Notes**

## **Opening Ceremony**

This breakout session is divided in two groups.

- Group 1 will discuss the CDM National Approval Process. This session will allow DNA representatives to share experiences and get a better understanding of the approval process of CDM projects and PoAs: find alternatives to improve the approval process, discuss best practices and the standard content of LoAs for different projects and PoAs based on their scale, type, and if they are multi-country or single-country projects or PoAs.

Participants will solve the case studies with support from a facilitator.

**Role of the DNA representatives:** DNA representatives are invited to participate actively in the resolution of case studies that will illustrate the appropriate content of LoAs based on scale, type, and whether they are multi-country or single-country projects or PoAs.

Group 2 will have a discussion on overview, status, role and importance of NAMA registry. In accordance with the COP decisions (1/CP16, paragraph 53, 2/CP17 paragraph 45), UNFCCC secretariat has set up NAMA registry to facilitate matching of mitigation actions in the developing countries with the International support and to provide recognition to NAMAs that are implemented with domestic resources.

Participants will identify barriers related to submission of information on NAMAs and support to the registry and identify solutions to those barriers. The break out session will also focus on areas of improvements in the existing web-based platform. In addition to that participants will brainstorm to visualize the vision or the role of registry and its operation in pre-2020 and post 2020 climate change regime.

**Role of participants:** Participants are invited to participate actively in the brainstorming session to contribute for further improvement in the NAMAs registry operation and guide the future direction and role for the registry in pre and post 2020 climate change regime.

# Plenary 3: Enhancement of participation of stakeholders, key to success of mitigation activities

Goal of the session: the right to public participation in decision-making is recognized in the context of environmental issues, including climate change. Robust stakeholder consultation standards are required under existing international obligations and under the CDM. This session is focused on exploring the benefits of enhanced consultation process and the current rules and to provide room for improvements on how to conduct and assess local stakeholder consultation in the context of CDM and NAMAs.

## Breakout session 2 - Local Stakeholder Consultation process + Financing

This breakout session is divided in two groups.

- Group 1 will discuss the CDM Local Stakeholder Consultation process. This session aims at sharing the experience in the local stakeholder consultation process having different views from DNAs and project participants: key elements for proper consultation processes that enhance the engagement of stakeholders; requirements set by DNAs and how the results of the consultations are assessed; reaching at joint conclusions on the most relevant elements of best practices of local stakeholder consultation.

Role of the DNA representatives: DNA representatives are invited to participate actively in the discussions after the presentations on local stakeholder consultation from different actors involved and to ask questions they may have about the DNA's requirements for the local stakeholder consultation process, exploring the benefits of enhanced consultation process.

Group 2 will consider investment approaches for leveraging financing from private sector. 95% of all investment in developing countries is from private-sector sources. Private sector finance is essential if we are to decarbonise the world economy and achieve climate-resilient development. Participants will discuss policy measures to incentivize private sector investment.

## Plenary 5: Sustainable Development co-benefits of mitigation actions

Goal: there are no defined procedures outlining how the assessment of Sustainable Development (SD) co-benefits should be conducted by a DNA in the context of CDM or by NAMA developers in the context of NAMAs. This session aims at sharing different approaches to identify and monitor SD co-benefits. Furthermore, views and expectations on the SD tool approved by the CDM Executive Board and the SD Monitoring Guidelines for DNAs (to be developed by the secretariat) will be shared among participants.

DNAs expressed the need for guidance in the development of relevant standardized baselines (SBs) in their countries. The goal of this session is to follow up with DNAs who have already submitted standardized baselines, and to provide guidance for DNAs who wish to submit a standardized baseline or are interested in getting familiar with this concept and the process to submit SBs. A presentation to provide support for submitting a proposed standardized baseline will be provided (Proposed standardized baseline submission form developed using the: 1) "Guidelines for the establishment of sector specific standardized baselines" and 2) "Methodological approach contained in an approved methodology").

Role of the DNA representatives: DNA representatives that have already submitted standardized baselines are invited to ask any questions they may have on post submission steps of SB evaluation and approval and DNAs who wish to get familiar with SBs and/or wish to submit a standardized baseline are invited to ask for guidance as needed, including specific questions on how to choose either of the two options for the proposed standardised baseline submission form and how to complete it.
