1. The branch may wish to consider the provisional agenda for adoption.

3. Requirement to submit a plan pursuant to the final decision of the enforcement branch with respect to Croatia

2. On 26 November 2009 the enforcement branch adopted a final decision with respect to Croatia (document CC-2009-1-8/Croatia/EB), which confirmed the preliminary finding (document CC-2009-1-6/Croatia/EB) and stated that the consequences set out in paragraph 23 of the preliminary finding shall take effect forthwith. Paragraph 23 (b) of the preliminary finding required Croatia to develop a plan referred to in section XV, paragraph 1, of the "Procedures and mechanisms relating to compliance under the Kyoto Protocol".¹ In accordance with section XV, paragraph 2, such a plan was due on 2 March 2010.

3. In response to a letter from the secretariat dated 3 March 2010 inquiring about Croatia's intentions to submit a plan, Croatia, by a letter dated 8 March 2010, informed the secretariat that it did not intend to submit such a plan in view of its submission of an appeal against the final decision of the enforcement branch.

4. At the seventh meeting of the plenary, a suggestion was made to include an item on the provisional agenda of the eleventh meeting of the enforcement branch concerning the plan referred to in paragraph 23 (b) of the preliminary finding with respect to Croatia.²

5. The branch may wish to consider Croatia's intention not to submit such a plan in light of its appeal against the final decision and decide what, if any, action it could take.

4. Review and assessment of the plan submitted by Bulgaria pursuant to the final decision of the enforcement branch

6. On 28 June 2010 the enforcement branch adopted a final decision with respect to Bulgaria (document CC-2010-1-8/Bulgaria/EB), which confirmed the preliminary finding (document CC-2010-1-6/Bulgaria/EB) and stated that the consequences set out in paragraph 20 of the preliminary finding shall take effect forthwith. Paragraph 20 (b) required Bulgaria to develop a plan referred to in section XV, paragraph 1, in accordance with section XV,

paragraph 2 and rule 25 bis, paragraph 1 of the “Rules of procedure of the Compliance Committee of the Kyoto Protocol”.³

7. The branch may wish to consider document CC-2010-1-11/Bulgaria/EB, which was submitted by Bulgaria on 12 August 2010 for review and assessment by the branch pursuant to section XI, paragraph 2 and rule 25 bis.
