4. Consideration of the question of implementation with respect to Croatia

(a) Consideration of the request to reinstate Croatia's eligibility

3. At its sixteenth meeting, the enforcement branch adopted a decision on the review and assessment of the plan submitted by Croatia pursuant to the final decision of the enforcement branch (CC-2009-1-11/Croatia/EB). It was the assessment of the branch that the measure reflected in Croatia's plan (CC-2009-1-10/Croatia/EB), if implemented in accordance with the decision, is expected to remedy Croatia's non-compliance. Pending the implementation of the measures referred to in paragraph 5 of that decision, the enforcement branch decided to keep the request to reinstate Croatia's eligibility under consideration.

4. On 27 December 2011, the secretariat received a document entitled "Submission of revised plan for reinstatement of Croatia's compliance related to the calculation of the assigned amount and commitment period reserve" (CC-2009-1-12/Croatia/EB; hereinafter referred to as the "revised plan"). In its revised plan, Croatia reiterated its request for the reinstatement of its eligibility to participate in the mechanisms under Articles 6, 12 and 17 of the Kyoto Protocol.

5. The secretariat confirmed in a letter dated 30 December 2011 (CC-2009-1-13/Croatia) that the value of the assigned amount and the initial value of the commitment period reserve, as determined by the expert review team during the review of Croatia's initial report (FCCC/IRR/2008/HRV) had been entered into the compilation and accounting database, as requested by Croatia in its letter dated 21 December 2011 (see annex to CC-2009-1-12/Croatia/EB).

(b) Elaboration and adoption of a decision under section X, paragraph 2, with respect to Croatia

6. The branch is to elaborate and adopt a decision pursuant to section X, paragraph 2.



5. Stocktaking exercise

7. At its sixteenth meeting, the branch agreed that it would have a stocktaking exercise in early 2012, provided that the workload and scheduling of meetings would allow for such an exercise. At its seventeenth meeting, the branch agreed on a list of possible issues for consideration at the stocktaking exercise (see Annex to the report on the seventeenth meeting of the enforcement branch, CC/EB/17/2011/2) and requested the secretariat to prepare an annotated list of these issues. The branch also agreed that, at the stocktaking exercise, priority should be given to issues relating to the structure of its decisions.

8. A stocktaking exercise is scheduled as part of the eighteenth meeting of the branch. The list of issues for consideration at the stocktaking exercise, with the annotations prepared by the secretariat in consultation with the chairperson and vice-chairperson, will be made available as document CC/EB/18/2012/2.
