# Addendum to the provisional agenda

### I. Introduction

- 1. On 14 July 2012, in response to a request submitted by Lithuania for the branch to reinstate its eligibility to participate in the mechanisms under Articles 6, 12 and 17 of the Kyoto Protocol (document CC-2011-3-12/Lithuania/EB), the enforcement branch adopted a decision under section X, paragraph 2, of the "Procedures and mechanisms relating to compliance under the Kyoto Protocol". The branch decided that there continued to be a question of implementation with respect to Lithuania's eligibility under Articles 6, 12 and 17 of the Kyoto Protocol and, therefore, also decided not to reinstate Lithuania's eligibility, and to initiate the procedure referred to in section X, paragraph 1, unless Lithuania requests the branch before 31 July 2012 not to initiate this procedure.
- 2. On 18 July 2012, the secretariat received a request from Lithuania for the enforcement branch not to initiate the procedure referred to in section X, paragraph 1, "before the report of the review of the National Greenhouse Gas Inventory, submitted in 2012, will be published" (CC-2011-3-15/Lithuania/EB).
- 3. On 31 July 2012, the branch decided not to initiate the procedure referred to in section X, paragraph 1, pending the receipt by the branch of the report of an in-country review of Lithuania's national system in conjunction with the review of its annual inventory report submitted in 2012 (CC-2011-3-16/Lithuania/EB).

- 4. Following a request from Lithuania, an expedited review took place from 28 to 29 September 2012 in Vilnius and Kaunas, Lithuania. On 11 October 2012, the report on the expedited review for Lithuania (2012) (FCCC/EXP/2012/LTU) was published.
