4. Consideration of the questions of implementation with respect to Ukraine

- 3. The questions of implementation with respect to Ukraine are contained in document FCCC/KP/CMP/2016/TPR/UKR, which was received by the Compliance Committee on 11 April 2016 under section VI, paragraph 1, of the "Procedures and mechanisms relating to compliance under the Kyoto Protocol" ² and rule 10, paragraph 2, of the "Rules of procedure of the Compliance Committee of the Kyoto Protocol". The questions of implementation indicated in this document were allocated to the enforcement branch on 18 April 2016 and sent to the branch on 19 April 2016 under section VII, paragraph 1.
- 4. On 3 May 2016, the branch decided to proceed under section VII, paragraph 2, and section X, paragraph 1 (a) (CC/2016/1-2/Ukraine/EB).
- 5. Ukraine did not submit any written submission in accordance with paragraph 1 of section IX, paragraph 1 (b) of section X, and rule 17 of the rules of procedure, and did not request a hearing under paragraph 1 (c) of section X.
- 6. The branch adopted a preliminary finding of non-compliance on 21 June 2016 (CC-2016-1-4/Ukraine/EB).

(a) Consideration of a written submission from Ukraine

- 7. The diplomatic agent of Ukraine received the written notification of the preliminary finding on 22 June 2016. The deadline for a written submission of Ukraine under section X, paragraph 1 (e) was 21 July 2016.
- 8. On 21 July 2016, a written submission under section X, paragraph 1 (e), was received from Ukraine.
