## Annotations to the provisional agenda

### 1. Opening of the meeting

1. This meeting of the enforcement branch relates to the question of implementation with respect to Greece, contained in document FCCC/IRR/2007/GRC, which was received by the Compliance Committee on 31 December 2007 under section VI, paragraph 1 of the procedures and mechanisms relating to compliance under the Kyoto Protocol<sup>1</sup> and rule 10, paragraph 2 of the rules of procedure of the Compliance Committee.<sup>2</sup> The question of implementation indicated in this document, together with comments from Greece, was allocated to the enforcement branch on 7 January 2008 and sent to the branch on 8 January 2008 (CC-2007-1-1/Greece/EB) under section VII.

2. On 22 January 2008, the branch decided to proceed under section VII, paragraph 2 and section X, paragraph 1(a); and it agreed to seek expert advice under section VIII, paragraph 5 and rule 21 (CC-2007-1-2/Greece/EB). Greece made a request for a hearing on 11 February 2008 (CC-2007-1-4/Greece/EB), and also made a written submission (CC-2007-1-5/Greece/EB) on 26 February 2008, both under section X, paragraph 1. The branch adopted a preliminary finding of non-compliance on 6 March 2008 (CC-2007-1-6/Greece/EB) and agreed that if Greece makes a further written submission by 8 April 2008, the branch will meet from 16 to 17 April 2008. Greece made a further written submission (CC-2007-1-7/Greece/EB) on 8 April 2008.

### 2. Adoption of the agenda

3. The branch may wish to consider the provisional agenda for adoption.

With respect to this item, the branch may wish to take into account that it agreed to discuss, at its next meeting, the implications of a determination by the branch, in accordance with section XV, paragraph 4, that a Party included in Annex I does not meet the eligibility requirement under Articles 6, 12 and 17 of the Kyoto Protocol to have in place a national system in accordance with Article 5, paragraph 1, of the Kyoto Protocol and the requirements in the guidelines decided thereunder, taking into account paragraph 24 of the Guidelines for the implementation of Article 6 of the Kyoto Protocol contained in the annex to decision 9/CMP.1.
