



## Status of submission and review of reports under the Kyoto Protocol

### Note by the secretariat

1. This note provides information on the status of submission and review of true-up period<sup>1</sup> reports for the first commitment period of the Kyoto Protocol, sixth national communications (NC6s), the report to facilitate the calculation of the assigned amount for the second commitment period, and the annual greenhouse gas (GHG) inventories submitted in 2015 and 2016 by Parties included in Annex I (hereinafter, Annex I Parties)<sup>2</sup> in accordance with decision 15/CMP.1, as at 26 August 2016.

#### *Annex I Parties in the first commitment period*

2. Altogether, there are 42 Annex I Parties to the Kyoto Protocol.<sup>3</sup> Thirty-seven of the 42 Annex I Parties had a quantified emission limitation or reduction commitment (QELRC) inscribed in Annex B to the Kyoto Protocol for the first commitment period. Supplementary information was submitted by these Parties pursuant to Article 7, paragraph 1, of the Kyoto Protocol, and in accordance with decision 15/CMP.1.

3. Five of the forty-two Annex I Parties (Belarus, Cyprus, Kazakhstan,<sup>4</sup> Malta and Turkey) did not have a QELRC for the first commitment period. Although Belarus, Cyprus, Kazakhstan, Malta and Turkey are considered Annex I Parties for the purposes of the Kyoto Protocol, in the absence of commitments under Article 3 of the Protocol for the first commitment period, their reporting obligations under Article 7, paragraph 1, of the Protocol do not appear to be triggered in relation to that period. At the same time, the reporting obligations under Article 7, paragraph 2, where these are related to commitments under the Protocol other than those under Article 3, appear to be applicable to these five Parties, including in the context of supplementary information in their NC6s.<sup>5</sup>

#### *True-up period for the first commitment period*

4. In accordance with paragraph 49 of the annex to decision 13/CMP.1, upon expiration of the true up period, each Party included in Annex I shall report to the secretariat and make available to the public the information on the total quantity and serial numbers of the Kyoto Protocol units (Assigned Amount Units (AAUs), Emission Removal Units (ERUs), Certified Emission Reduction Units (CERs) and Removal Units (RMUs)) until the end of the true up period commitments, the total quantity and serial number of units in its retirement account and the total quantity and serial number of units the Party requests to be carried over to the subsequent commitment period. The purpose of this information submitted in a form of a true-up period report is to demonstrate that each Party has fulfilled its obligations under Article 3 of the Kyoto Protocol.

5. The dates of the true-up period for the first commitment period under the Protocol, as well as the deadlines for the submission and review of the true-up period reports were based on decision 3/CMP.10. After the end of the true-up period (18 November 2015), the results were officially reported by Parties under the true-up period report submission and then extensively verified and reviewed by ERTs during three centralized reviews that took place in Bonn in February 2016. The true-up period review reports (TPRs) for all 37 Parties referred to in paragraph 2 have been published and are available on the UNFCCC website.<sup>6</sup>

6. The ERTs concluded for 36 of these 37 Parties that:

- (a) the information submitted covers all elements required;
- (b) the respective Party's aggregate GHG emissions in the first commitment period did not exceed the quantity of Kyoto Protocol units valid for the first commitment period placed in the retirement account;
- (c) the requested amounts of assigned amount units (AAUs), certified emission reductions (CERs) and emission reduction units (ERUs) to be carried over to the second commitment period are consistent with the requirements;
- (d) there were no questions of implementation.

7. Questions of implementation were raised by the ERT in relation to one Party and these were forwarded to the Compliance Committee for further resolution in accordance with the procedures set out in decision 27/.CMP.1. As on 26 August 2016, the questions of implementation are under consideration by the enforcement branch of the Committee.

8. In accordance with paragraph 62 of the annex to decision 13/CMP.1, following the publication of the true-up period review reports, the secretariat published the final compilation and accounting report for each of the 36 Parties in relation to which no questions of implementation were raised. The compilation and accounting report for the Party in relation to which questions of implementation were raised, is expected to be prepared following the resolution of the questions of implementation. The compilation and accounting reports provide the final information for the first commitment period about: the aggregated GHG emissions; the quantity of units retired; the quantity of units available for carry-over to the second commitment period, if applicable; and the quantity by which GHG emissions exceed the units retired, if applicable.

9. These reports have been forwarded to the Compliance Committee and have been published on the UNFCCC website<sup>7</sup> on 2 August 2016 and will be considered at the session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) in November 2016. Publication of the compilation and accounting report constitutes the conclusion of all reporting, review and accounting processes for the first commitment period of the Kyoto Protocol for each Party referred to in paragraph 2 above.

*Annex I Parties in the second commitment period*

10. Thirty-eight Annex I Parties have a QELRC inscribed in the third column of the table in Annex I to the Doha Amendment for the second commitment period. Supplementary information is submitted by these Parties pursuant to Article 7, paragraph 1, of the Kyoto Protocol, and in accordance with decisions 15/CMP.1, 2/CMP.8, 6/CMP.9 and 3/CMP.11.

11. Japan, New Zealand and the Russian Federation are Annex I Parties that do not have a QELRC for the second commitment period. However, through decision 3/CMP.11, the CMP requested that these Parties continue to have certain limited reporting obligations in relation to elements of the information usually reported under Article 7, paragraph 1, of the Protocol.<sup>8</sup> The reporting obligations under Article 7, paragraph 2, where these are related to commitments under the Protocol other than those under Article 3, appear to be applicable to these three Parties, including in the context of supplementary information in their sixth national communications (NC6).<sup>9</sup>

*Submissions of national communications*

12. In accordance with decision 9/CP.16 and following the requirements of Article 12, paragraphs 1 and 2, of the Convention, Parties included in Annex I to the Convention are required to submit to the secretariat a sixth national communication by 1 January 2014 and a seventh national communication no later than four years after this date. Therefore, the submission of the seventh national communications by Annex I Parties is due, at the latest, by 1 January 2018. In accordance with decision 8/CMP.3, Parties included in Annex I to the Convention that are also Parties to the Kyoto Protocol are to include in the national communications the necessary supplementary information under the guidelines established under Article 7 of the Kyoto Protocol.<sup>10</sup>

13. As on 26 August 2016, the secretariat has received the NC6s from 44 Parties, of which 42 are Annex I Parties to the Kyoto Protocol.<sup>11</sup> Since the previous report to the Compliance Committee,<sup>12</sup> only one additional Party submitted its NC6 (see table 2 below).<sup>13</sup>

14. All received NC6s were reviewed during in-country reviews or centralized reviews in the course of 2014, 2015 and the first half of 2016. The reviews of NC6s were held in conjunction with the reviews of the first biennial reports (BR1) under the Convention, except for one Party whose NC6 has been reviewed in conjunction with the reviews of the second biennial reports in June 2016. The technical review report of the NC6 of this Party is under preparation and will be published on the UNFCCC website later this year.

### **Greenhouse gas inventory submissions 2015**

15. The secretariat received 42 annual inventory submissions for 2015 from Annex I Parties to the Kyoto Protocol. Table 3 shows the submission and resubmission dates.

16. As indicated in the previous report on status of submissions and review of reports under the Kyoto Protocol, there were delays in the submissions (due to the delay in the delivery of the CRF Reporter by the secretariat) and the guidance for conducting annual reviews under Article 8 in the second commitment period had not been finalized.<sup>14</sup> Given these challenges, the secretariat considered

itself as not being in a position to conduct annual reviews under Article 8 in 2015, including the preparation of status reports on the 2015 submissions. Despite the challenges noted, the secretariat organized the 2015 reviews under the Convention of CRF and NIR submissions from Australia, Canada (not a Party to the Kyoto Protocol), New Zealand and Ukraine under the guidelines adopted by decision 13/CP.20.<sup>15</sup>

17. The CMP through decision 10/CMP.11 noted the delays and requested the secretariat to organize the review of the 2015 and 2016 greenhouse gas inventory submissions, including the review of the supplementary information submitted under Article 7, paragraph 1, of the Protocol, in conjunction with each other and with the review of those inventory submissions under the Convention.<sup>16</sup> The process of this review is described in paragraph 19 below.

***Greenhouse gas inventory submissions 2016***

18. As at 26 August 2016, the secretariat has received 42 annual inventory submissions for 2016 from Annex I Parties (see table 4 below) and 40 status reports have been prepared and published on the UNFCCC website.<sup>17</sup> Forty of these submissions contain supplementary information under Article 7, paragraph 1, of the Kyoto Protocol for 2014 provided in accordance with decision 15/CMP.1.

19. The secretariat is coordinating reviews under the Kyoto Protocol of 40 of the submissions referred to in paragraphs 15 and 18 above (for the 2015 and 2016 annual submissions, respectively). Nine reviews will be conducted as in-country reviews, twenty-nine as centralized reviews and two as desk reviews.<sup>18</sup> The reviews are planned for the period from 29 August to 22 October 2016.

***Submission of the reports to facilitate the calculation of the assigned amount for the second commitment period of the Kyoto Protocol***

20. Decision 2/CMP.8, paragraph 2, required each Party with a quantified emission limitation and reduction commitment inscribed in the third column of Annex B in the Doha Amendment to the Kyoto Protocol, to submit to the secretariat by 15 April 2015, a report to facilitate the calculation of its assigned amount pursuant to Article 3, paragraphs 7bis, 8 and 8bis, of the Doha Amendment, for the second commitment period and to demonstrate its capacity to account for its emissions and assigned amount (the “initial report” for the second commitment period).

21. As indicated in the previous report on status of submissions and review of reports under the Kyoto Protocol, there were significant delays in the submissions of the reports to facilitate the calculation of the assigned amounts for the second commitment period (due to the delay in the delivery of the CRF Reporter by the secretariat)<sup>19</sup> and the full set of the accounting, reporting and review rules referred to in paragraph 16 above was only adopted by the CMP at its 11<sup>th</sup> session in 2015. This impeded calculation of the assigned amount within the timelines foreseen in decision 2/CMP.8.

22. The CMP, through decision 10/CMP.11, noted the delays and requested the secretariat to organize the review of the reports to facilitate the calculation of the assigned amount for the second commitment period in conjunction with the reviews indicated in paragraph 17 above.<sup>20</sup>

23. As on 26 August 2016, the secretariat has received 34 reports to facilitate the calculation of the assigned amounts for the second commitment period (see table 5 below). The secretariat is organizing the reviews of these reports in conjunction with the reviews of the 2016 submissions (see para. 19 above).
