# Programme of activities (PoA)

- Current M&P
  - No reference to the concept of PoA
- Inputs
  - > Set out general and specific principles, but not detailed rules, of PoAs in M&P
  - Develop a separate section for PoAs in M&P, and separate methodologies for PoAs
  - ➤ Simplify rules for PoAs comprising microscale CPAs
  - Clarify rules on erroneous inclusions of CPAs into a PoA, be part of the same process as for standard CDM project activities, and with acceptable liability risks for DOEs
  - Move PoAs into a NAMA framework



#### > Standardized baselines

- Current M&P
  - > No reference to the concept of standardized baselines
- Inputs
  - ➤ Incorporate section on standardized baselines in decision 3/CMP.6 in M&P
  - ➤ Update regularly the standardized baselines (e.g. every 3 years) according to transparent/objective criteria
  - Make the use of a sector-specific standardized baseline mandatory for new projects



### > Additionality

- Current M&P
  - Additionality is defined but means to demonstrate additionality are not provided
- Inputs
  - ➤ Include in M&P the current practice of the Board to establish a "positive list" of project types/scale deemed automatically additional with simplified validation requirement on additionality
  - ➤ Improve, streamline and encourage additionality assessment by relying on standardized approaches (e.g. performance benchmarks, positive lists, market penetration rates)
  - > Reform or abandon E+/E- rule, first-of-its-kind step
  - ➤ Exclude certain project types (e.g. HFC-23, N2O, coal-fired power plants without CCS)



#### > Other

- Inputs
  - Simplify project cycle for small-scale projects using standardized baselines (e.g. ex-post assessment after registration)
  - Review the thresholds on project scale (small-scale and microscale)
  - ➤ Abandon the concept of small-scale project activities as they are no easier than large-scale project activities
  - Simplify methodologies in general, using conservative approaches
  - ➤ Develop principles for the management of conservativeness in CDM methodologies to be applied consistently across methodologies
  - ➤ Introduce pre-established automatic baseline adjustments



#### > Other (cont.)

- Inputs (cont.)
  - > Reflect the project cycle timeline recently adopted by the Board
  - ➤ Remove the condition requiring a description of project activity when submitting a new methodology
  - Include the concept of clarifications of methodologies
  - ➤ Reflect the current practice of the Board to develop, revise and clarify methodologies on its own initiative (top-down), and to allow any stakeholder to submit a new or revised methodology and clarification requests
  - Streamline Appendix C (ToR for establishing guidelines on methodologies) by leaving key principle and move to the main body of M&P
  - Revise the list of approaches baseline methodologies to a nonexhaustive list
