Reflections of the Co-Facilitators on the discussion in the informal consultations

Note: This informal note is our attempt to informally capture views expressed by Parties, including in their submissions. The informal note has been prepared under our own responsibility and thus has no formal status. The content of the informal note is not exhaustive and neither represents agreed views, ideas or text nor attempts to draw any conclusions on possible areas of convergence or divergence. This informal note does not prejudice Parties' views regarding the outcome of related agenda items. We also recognize that nothing is final until all the MPGs are final, and that nothing in this informal note prejudices Parties' views on the final outcome of the MPGs. The Co-facilitators recognize that there are varying views on the structure of the MPGs, including differentiation, and this informal note is not intended to prejudge the position of Parties on this issue. The Co-facilitators recognize that Articles 13.7 to 13.12 of the Paris Agreement vary in their legal nature (i.e., "shalls" and "shoulds") and that this will be reflected in the MPGs. The Co-facilitators also note that the MPGs will provide flexibility to those developing country Parties that need it in the light of their capacities. The Co-facilitators understand that Parties may modify the "headings and sub-headings" in their submissions, as appropriate, and that the "headings and sub-headings" do not represent negotiation text. The Co-facilitators note that there are varying views on the operationalization of the provisions in Article 13.3 and consideration of developing country Parties' transition to the enhanced transparency framework.

I. Overview of the informal consultations on this item

- 1. During the third part of the first session of the Ad-hoc Working Group on the Paris Agreement (APA 1.3) at SB46 (May 2017), Parties continued the consideration of this agenda item.
- 2. The Co-facilitators, under their own responsibility and guidance of the APA Co-Chairs, prepared a tool containing possible "headings and sub-headings" (see annex), drawing from Parties' submissions and views expressed by Parties at the informal consultations. This annex does not prejudge the position of Parties on the structure of the MPGs.
- 3. Throughout the week, Parties discussed the following areas:
 - a) Overarching considerations of the modalities, procedures and guidelines (MPGs);
 - b) National inventory report on anthropogenic emissions by sources and removals by sinks of greenhouse gases;
 - c) Information necessary to track progress made in implementing and achieving nationally determined contributions under Article 4 of the Paris Agreement;
 - d) Information related to climate change impacts and adaptation under Article 7 of the Paris Agreement, as appropriate;
 - e) Information on financial, technology transfer and capacity-building support provided under Articles 9-11 of the Paris Agreement;
 - f) Information on financial, technology transfer and capacity-building support needed and received under Articles 9-11 of the Paris Agreement;
 - g) Technical expert review; and
 - h) Facilitative, multilateral consideration of progress.

4. Parties also agreed to forward to the APA Co-Chairs the next steps contained in Section II: targeted submissions and a pre-sessional workshop (see section II below for further details).

II. Next steps following APA 1.3

In submitting their views, Parties are also invited to elaborate, as appropriate, the specific operational details under the possible "headings and sub-headings".
- 6. A pre-sessional workshop focusing on issues covered in Parties' submissions, referred to in paragraph 5 above, and also including technical discussions on how cross-cutting issues listed in Article 13, including, *inter alia*, paragraphs 2 4, were considered in Parties' submissions.
