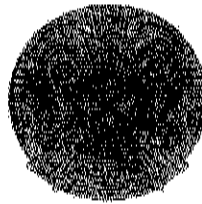

Ministry of Environment Protection of the Republic of Kazakhstan informs, that the Republic of Kazakhstan wishes to associate itself with the Copenhagen Accord and requests to include it in the chapeau of the Accord.
