Background

Longstanding request from SBSTA

Invitation to IPCC in Marrakech Accords LULUCF Decisions (11/CP.7, para 3 a and 3b)



3(a)

To elaborate methods to estimate, measure, monitor, and report changes in carbon stocks and anthropogenic greenhouse gas emissions by sources and removals by sinks resulting from land use, land-use change and forestry activities under Article 3.3 and 3.4, and Articles 6 and 12 of the Kyoto Protocol on the basis of the Revised 1996 Intergovernmental Panel on Climate Change Guidelines for National Greenhouse Gas Inventories, taking into account the decisions -/CMP.1 and -/CP.6, to be submitted for consideration and possible adoption to the Conference of the Parties at its ninth session;



3(b)

To prepare a report on good practice guidance and uncertainty management relating to the measurement, estimation, assessment of uncertainties, monitoring and reporting of net carbon stock changes and anthropogenic greenhouse gas emissions by sources and removals by sinks in the land use, land-use change and forestry sector, taking into consideration decisions -/CMP.1 and -/CP.6, to be submitted for consideration and possible adoption to the Conference of the Parties at its ninth session;



The IPCC Good practice work covers paras 3a&b, but not the issues that are included in the requests to SBSTA in the decision 11/CP.7 in para 2(d) and 2 (e)

...definitions and modalities for including afforestation and reforestation project activities under Article 12 in the first commitment period, taking into account the issues of non-permanence, additionality, leakage, uncertainties and socio-economic and environmental impacts, including impacts on biodiversity and natural ecosystems...



- The invitations to IPCC on methodological work on
- "degradation of forests and devegetation of other vegetation types" (3c) and
- "factoring out direct human-induced effects of others" (3d)
 - \checkmark IPCC XIX decisions expected on these tasks
 - ✓ 3c (Task 2) parallel with LULUCF Good Practice guidance (Task 1) from July 2002
 - ✓ 3d (Task 3)expert meeting in July 2002 to assess scientific knowledge available to develop practicable methodologies
