Nairobi 2006: United Nations Climate Change Conference

On behalf of the Executive Secretary, I am pleased to notify Parties to the United Nations Framework Convention on Climate Change and its Kyoto Protocol and observer States of the forthcoming sessions that will take place from 6 to 17 November 2006 at the United Nations Office at Nairobi Headquarters (Gigiri Complex), United Nations Avenue, Gigiri, Nairobi, Kenya:

- The twelfth session of the Conference of the Parties (COP 12)
- The second session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (COP/MOP 2)
- The second session of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG 2)
- The twenty-fifth session of the Subsidiary Body for Scientific and Technological Advice (SBSTA 25)
- The twenty-fifth session of the Subsidiary Body for Implementation (SBI 25).

¹ At the fourth session of the Conference of the Parties (COP), it “proved impossible to reach any agreed conclusions or decisions” on this matter (FCCC/CP/1998/16, para. 64) and the item was therefore included in the provisional agenda for the COP at its fifth session in accordance with rule 10 (c) and rule 16 of the draft rules of procedure being applied. The COP, at its fifth session, could not reach a conclusion on this matter (FCCC/CP/1999/6, para. 18), and following rule 10 (c) and rule 16 of the draft rules of procedure being applied, the item was included in the provisional agenda for the sixth, seventh, eighth, ninth, tenth and eleventh sessions with a footnote reflecting a proposal made by the Group of 77 and China to amend the item to read “Review of the adequacy of implementation of Article 4, paragraph 2 (a) and (b), of the Convention”. At its eleventh session, the COP decided to include the item in the provisional agenda for its twelfth session, with an appropriate explanatory footnote (FCCC/CP/2005/5, para. 24).

Annex II Protocol Issues

Credentials of States Parties to the Convention

In accordance with rule 19 of the draft rules of procedure being applied (FCCC/CP/1996/2), the credentials of representatives of Parties, as well as the names of alternate representatives and advisers, shall be submitted to the secretariat not later than 24 hours after the opening of the session. Any later change in the composition of the delegation shall also be communicated to the secretariat.

The credentials must be issued by the head of State or Government or by the Minister of Foreign Affairs or, in the case of a regional economic integration organization, by a competent authority of that organization.

The secretariat wishes to remind Parties that, in accordance with decisions 17/CP.9 and 36/CMP.1, only one set of credentials is necessary to cover the participation of Parties of the Convention and Parties of the Kyoto Protocol in the COP at its twelfth session and the COP/MOP at its second session.

Parties are requested to provide their representatives with full powers to participate in the sessions, including the authority to adopt decisions, to vote and to serve as officers of the COP, the COP/MOP and their subsidiary bodies, and as officers of any sessional bodies, where applicable.¹

Observer States to the Convention

States that are not Party to the Convention are not required to provide their representatives with credentials.

¹ At COP 12 and COP/MOP 2, new members will be elected to the following bodies under the Convention and the Protocol

- The Bureau of the COP, including any additional member from amongst Parties to the Kyoto Protocol
- The Bureaux of the SBI and the SBSTA, including any additional member from amongst Parties to the Kyoto Protocol
- The Bureau of the Ad hoc Working Group on further commitments for Annex I Parties under the Kyoto Protocol
- The Executive Board of the clean development mechanism
- The Compliance Committee
- The Consultative Group of Experts on national communications from non-Annex I Parties

Nominations to these bodies are to be submitted by the Regional groups and AOSIS, accordingly.



High-level segment of the session

The high-level segment, to be attended by ministers and other senior officials, will be held from 15 to 17 November 2006. National statements by ministers and other heads of delegation will be heard in joint meetings of the COP and the COP/MOP during the high-level segment.

The recommended time limit for statements is three to four minutes. Statements made on behalf of groups of Parties, where individual members of the group do not speak, would be welcome, in order to reduce the overall number of speakers. Such groups will be granted two additional minutes and will be accorded preference in the speaking order. Full texts of the official statements will be circulated if a sufficient number of copies is provided to the secretariat during the course of the session.
