Pursuant to decision 1/CP.16, I am pleased to notify Parties and observer States to the United Nations Framework Convention on Climate Change (UNFCCC) that the first meeting of the Technology Executive Committee (TEC) will take place from 31 August to 2 September 2011.

The above mentioned meeting will be held at Langer Eugen at Hermann-Ehlers-Strasse 10, 53175 Bonn, Germany.

The provisional agenda, as well as further details of the meeting, are being finalized and will be communicated shortly. Additional information will soon be made available on the UNFCCC website at: <http://unfccc.int/tclear/jsp/TEC.jsp>.

In accordance with the above mentioned decision, the meetings of the TEC will be open to observers. Such observers include Parties, observer States and UNFCCC admitted organizations. Given space limitations, access may have to be limited. However, a webcast of the meeting of the TEC (31 August–2 September) will be available on the website of the UNFCCC secretariat.
