The above-mentioned meeting will be held at Langer Eugen at Hermann-Ehlers-Str. 10, 53175 Bonn, Germany.

In accordance with the above-mentioned decision, the meetings of the TEC will be open to observers. Such observers include Parties, observer States and UNFCCC admitted organizations.
