FIRST MEETING OF THE TECHNOLOGY EXECUTIVE COMMITTEE REGISTERS PROGRESS

Important progress was made at the first meeting of the Technology Executive Committee (TEC), the policy component of the Technology Mechanism. The meeting in Bonn saw three days of key deliberations on how the TEC will assess policy and technical issues related to technology development and transfer, share information on new and innovative technologies, provide overviews of developing countries' technology needs, facilitate and catalyze action on technology, and find ways to engage stakeholders to build the momentum on the Technology Mechanism. FOREST MANAGEMENT REFERENCE LEVELS REVIEWS ALMOST COMPLETED

The technical assessments of Forest Management Reference Levels submitted by Annex I Parties earlier this year are almost completed. A synthesis report of the results will be considered by the CMP in Durban in December. [More...](#)
