1. OVERVIEW

1.1. About the Nairobi Framework Partnership

The Nairobi Framework Partnership (NFP) was initiated a decade ago by the UN Secretary-General, Kofi Annan at the second Conference of the Parties Serving as the Meeting of Parties to the Kyoto Protocol 2. Its original goal was to support developing countries to improve their level of participation in the clean development mechanism (CDM) through inter-agency cooperation and collaboration. The NFP have since evolved to embrace a much more ambitious role in the climate change arena. Today the NFP, through its partners¹ and cooperating agencies,² has positioned itself as a recognized global platform with an extended and solid inter-agency collaboration track record for ongoing climate action.

1.2. Purpose of the report

The purpose of this report is to document the activities completed by partner agencies and cooperating organizations of the NFP during 2016. It includes both the activities comprised in the 2016 work plan and activities that were additionally developed throughout the year.

2. GOVERNANCE

In 2016 the partnership held three governance meetings (in person) in which major decisions were made. The series of governance meetings started with the revision of its terms of reference (ToR) and agreement on a more realistic set of objectives in the beginning of the year, and concluded with partners reiterating their commitment to continue efforts towards a common goal under the NFP umbrella and setting the direction and vision that the NFP should take in the next three to five years. More information on the meetings is given in the sub-sections that follow.

2.1. Revision of Terms of Reference

After the adoption of the Paris Agreement in December 2015, a series of discussions among partners and a call for the NFP to review its original goals and roles were initiated. As a result, partners felt the need to determine new priority areas that were more aligned with the 21st Conference of the Parties outcomes. Discussion culminated in the revision of the ToR³ of the NFP during the partners' meeting held in January 2016 in Copenhagen. The meeting provided an opportunity not only to revisit the various aspects related

to NFP operations but also prompted a discussion on the path for implementing a long-term strategy for the NFP after Paris.

The new overarching purpose of the NFP was then established in early 2016, when partners agreed to *“maximize the efficiency in the provision of support to developing countries in implementing their Nationally Determined Contributions (NDCs) in the areas of climate finance technology transfer and capacity building for mitigation, through creating enabling environments at national level, regulatory mechanisms and carbon markets, including the CDM”*.

2.2. Second coordination meeting and High-level Round Table

The second meeting of the partners was held on 26 and 27 May 2016 in Cologne to discuss the yearly workplan and activities to be conducted in 2016-2017 to support NDC implementation. One of the goals of this meeting was to translate the ambition expressed at the meeting in Copenhagen into concrete actions.

In summary, partners agreed to focus on the following five priority areas to achieve the new goals of the NFP under the revised ToR:

- a) Assistance to develop roadmaps for the effective implementation of NDCs;
- b) Development of legal and regulatory frameworks to drive interventions of the private sector in the implementation of mitigation action;
- c) Technical support for the design and implementation of existing and new mitigation activities in order to achieve financial closure;
- d) Development of carbon markets and economic instruments for mitigation action; and
- e) Technical assistance to develop Monitoring, Reporting and Verification (MRV) systems.

Partners then worked together to further develop the project ideas into project proposals during each regional forum. The proposals developed during the forums were then presented in the Global Designated National Authorities (DNA) forum at COP22. Section 4.2 of this report gives more detailed information on the project proposals.

On the second day of the meeting, partners interacted with other agencies that could potentially add to the work of the NFP. The round table facilitated the identification of possible areas of collaboration with other agencies that could complement the NFP’s 2016 activities.

2.3. High-level meeting

The rapid entry into force of the Paris Agreement triggered the urgent need to intensify actions on climate change. In light of these calls for action and with the aim to reiterate the partners’ commitment to continue joint efforts, the last Governance meeting of the year was held in Marrakesh during COP22. The focus of the meeting was to translate the NFP’s set of objectives into a medium- to longer-term strategy for the intensification of efforts in the implementation of the Paris Agreement.

The high-level meeting was attended by six senior directors of the NFP (AFDB, UNEP, UNEP DTU, UNDP, UNFCCC and WB) and concluded that for the following years the partnership should have a clear focus on market-based approaches and economic instruments that can directly contribute to mitigation, and to remain supportive to CDM as its role evolves under the Paris Agreement climate architecture.

This outcome of this meeting is being adapted to a more comprehensive information paper to be circulated to partners and further used as a basis for the activities to be designed and selected under the 2017 workplan.


3. NAIROBI FRAMEWORK PARTNERSHIP ACTIVITIES IN 2016

A summary of the activities carried out under the NFP in 2016 is presented in the sub-sections that follow. The complete list, including a description and more details of each activity, is included in Annex 1 of this report.

3.1. Status of activities

In 2016 the NFP planned to deliver 43 activities in the three main regions (Africa, Asia, Latin America and the Caribbean - LAC). As of December 2016, 30 activities have been accomplished, 11 are ongoing and 2 are in the planning stage.

The ongoing activities as well as the activities under planning were originally scheduled to be carried out through 2017 and beyond. Information will therefore continue to be updated in the future reports of the partnership.


3.2. Distribution per theme

The activities included in this year's workplan were distributed in the following seven themes, in which there might be some overlapping:

As can be seen in figure 2, this year the NFP concentrated efforts mainly in activities related to promoting the better understanding of the Paris Agreement and its related political discussions around NDCs (14 activities), followed by CDM-related actions (11 activities) and implementation of climate change finance (8 activities).

The CDM-related activities, which contributed to 20 per cent of the NFP's efforts, included mainly capacity building and training events as well as the production of reports and maintenance of the CDM database.


In addition, this year partners acted together to support the calculation of standardized baselines in the Asia-Pacific region.

It is important to note that although partners are moving towards broader themes, such as NDC implementation, the CDM still played an important role in 2016 as the key mechanism to support countries in the implementation of their plans.

3.3. Regional distribution

The NFP continue to act globally, delivering and promoting capacity-building activities across all regions, while remaining faithful to the priority regions and least developed countries. This is demonstrated in figure 4, which shows that most activities were still focused on Africa, with 14 of the workplan’s activities dedicated to promoting climate action in Africa only, followed by Asia and Pacific and LAC regions, with eight activities each.

It can also be seen that a high number of activities (14) have had a global coverage due to the recent shift of the NFPs to widely support the implementation of NDCs and the Paris Agreement. Activities with global coverage developed in collaboration under the NFP included the development of guidance to prepare NDCs’ readiness implementation plans, MRV of NDC implementation, global/regional workshop to promote south-south dialogue on the implementation of NDCs, and sharing of awareness building of and funding options for NDC implementation.

The highlight of the year was the new approach to the way the events were conducted, which were led by the NFP partners targeting government representatives (e.g. CDM DNAs and national focal points), to elaborate project proposals for the region. The NFPs used the series of Carbon Forums organized in the three regions (Africa, Asia and Pacific, LAC) to strengthen relationship with Parties and deepen the understanding of opportunities and barriers to support implementation of NDCs. More information on this innovative approach is given in section 4 of this report and specific details on the forums are presented below.

3.3.1. Africa Carbon Forum (ACF)

The 8th ACF was held in Kigali, Rwanda, from 28 to 30 June 2016.⁴ It was the first ACF since the adoption of the Paris Climate Change Agreement and addressed the theme “Promoting Collaborative Climate Action in Africa”. The event was attended by over 450 private and public, government and non-state participants, project investors, media representatives and others. The events focused on strengthening, through feedback and buy-in from government representatives, projects proposed by the NFP partners (15 proposals were refined, trimmed and consolidated into 10 projects).

3.3.2. Latin American and Caribbean Carbon Forum (LACCF)

The 10th LACCF⁵ took place in Panama from 28 to 30 September. More than 400 participants registered for the event, which for the first time was held back-to-back with LEDS-LAC as a climate week. The aim of the Forum this year was to promote climate change action in the LAC region and promote dialogue among countries on NDC implementation. Also during this event, the NFPs and members of governments refined project proposals, which were later presented during the Global DNA Forum.

3.3.3. Asia Pacific Carbon Forum (APCF)

Jeju Island, Republic of Korea hosted the 7th APCF⁶ from 5 to 7 September 2016, as part of the Global Green Growth Week 2016, organized by the Global Green Growth Institute. The event addressed the theme “Promoting Collaborative Climate Action in Asia and the Pacific”. Close to 300 participants (private and public, government and non-state) from 60 countries from Africa, Asia-Pacific, Europe, Latin America and North America were present. During the event participants worked together on the project proposals for the region, which were later presented at the Global DNA Forum.

3.3.4. Global DNA Forum

The meeting of Nationally Designated Authorities under the CDM (Global DNA Forum)⁷ in Morocco was held back-to-back with the COP22. It also served as a platform for launching the portfolio of projects designed under the umbrella of the NFP to boost the development of carbon market instruments as a means to help countries achieve their NDC plans. The portfolio of projects promotes to a large extent the use of the CDM and the knowledge and expertise with CDM developed by DNAs to reach their domestic targets.

4. INNOVATIVE APPROACHES IN 2016

4.1. Nationally Determined Contributions survey

As part of the revamped actions under the partnership, in the beginning of 2016 the NFP (through the UNFCCC Regional Collaboration Centre) conducted a survey to collect information on the status of NDCs

through DNAs. The analysis and results are presented in the “Report on NDC survey conducted by Regional Collaboration Centres in 2016”.⁸

It became evident through this survey that the most urgent need required by countries and regions is support in the development of carbon markets and economic instruments for mitigation action. In addition, all countries agreed that it is essential to understand the technological needs and barriers as the first step in implementing NDC activities/programmes.

This work was the first of its kind under the partnership and represents a significant model that can be replicated or expanded over the years. The outcomes of the survey help to enlighten the partnership’s direction and sets out the foundation for the new collaborative approach under the NFP.

4.2. Project proposals

The NFP worked together with DNAs in parallel sessions at each of the three regional Carbon Forums to identify and develop projects that build on CDM expertise and respond to countries’ needs for implementing NDCs, as previously mentioned in this report. The projects fit within the focus areas, such as climate finance, technology transfer and capacity building for mitigation. The project proposals which received the most interest at each of the regional Carbon Forums were launched at the Global DNA Forum prior to the COP22.


The aim of this activity is to provide support in the areas where NFP has built expertise together with the DNAs over the past several years, e.g. market-based approaches and economic instruments, including the CDM.

The final project portfolio consists of 21 projects elaborated over the year by the NFPs, together with some 80 DNAs from Africa, Asia and LAC. The project portfolio encompasses a broad range of areas, including transport, agriculture, financing, power production, urban development, legal frameworks and, of course, capacity building for new markets and market mechanisms.

Several projects relate specifically to cities and include, for example, systems being developed for the transport sector to ensure appropriate data collection, storage and reporting of air quality, and transport-related and greenhouse gas data in urban areas.

The first of the regional-level discussions on the project concepts put together by the NFP partners took place at the 8th ACF in Kigali, Rwanda. The session was attended by 37 country representatives from Africa. From the 15 project concepts that were presented by the partners, the country representatives prioritized 10 projects to further work on. These 10 projects represented a diversity of areas, such as NDC implementation readiness, support for MRV tools, standardized baseline development, NAMA preparation, climate finance solutions to specific sectoral project developments in renewable energy, transport, and solid waste management. Throughout the sessions, the participants worked together to develop the 10 project proposals, with inputs considering the needs of the participating countries.

In the Asia-Pacific region, 10 proposals were refined, trimmed and consolidated to the following eight projects: low-carbon cities; MRV for agriculture; waste circular economy; legislation for carbon markets; standardized baselines; energy-efficient lighting; DNA role and new market mechanisms; and regional carbon markets. The countries engaged in the project selection were Bhutan, Indonesia, Laos, Micronesia, Mongolia, Nepal, Pakistan, Palau, Philippines, Sri Lanka, Syria, Tajikistan and Vietnam. Selected projects and activities were primarily within the area of market-based approaches, to support countries in the region implementing their NDCs.

During the LACCF in September, 10 project proposals were discussed with representatives from Antigua Barbuda, Argentina, Belize, Colombia, Cuba, Dominican Republic, El Salvador, Guatemala, Guyana,

Guyana, Haiti, Jamaica, Saint Lucia and Suriname. The project proposals discussed were: sustainable development in the power sector in small island developing states; circular economy/waste management; regionally integrated market mechanisms; NAMAs for NDC implementation; Article 6 implementation; support to NDC implementation; legal framework for private sector engagement; crowdfunding for mitigation action; mitigation in the transport sector; and legislation for the carbon market. DNAs also expressed interest in the proposals that involve access to new sources of finance – for instance, crowdfunding for mitigation action.

The projects were further screened and merged into global or regional according to five areas: 1-Support to MRV activities; 2-Mitigation frameworks; 3-Carbon market readiness and implementation; 4-Implementation of mitigation measures; and 5-Financing mitigation action.

The selected projects were then packaged and presented at the DNA Global Forum in Morocco, where the second phase of this initiative, the search for financial support, was started. The partners, together with the DNAs, have agreed on the consolidated list, and partners will incorporate this work into the 2017 workplan, in which the search for donors will be intensified in order to implement the project proposals.

5. CONCLUSION

The NFP has proven to be an effective instrument that combines the strengths and experiences that partners have built over the past decade in supporting market-based approaches and economic instruments that can directly contribute to mitigation and to the successful implementation of the Paris Agreement, in particular supporting developing countries to implement their NDC.

The close cooperation between DNAs and international organizations is a good model for how the partners can work together at national and international levels to identify and bring forward the knowledge and support needed to implement NDCs. It also demonstrated that this can be achieved effectively in a short period of time when partners work in synergy.

Focusing on the needs of countries, regions and sectors in relation to their NDCs' implementation is the path for relevant and effective delivery of services. The NFP has already paved the way to identify a set of activities within the partnership's role (i.e. market mechanisms and economic instruments) that will support domestic actions. In this line, the NFP intends to work together with countries to accommodate their needs and design country-specific support plans to be provided on demand.

The project portfolio identified during the 2016 Carbon Forums will play a pivotal role in future NFP joint activities. Further work on how the NFP partners can support the implementation of such projects will be part of the partnership's 2017 workplan.

In conclusion, 2016 marked the 10-year anniversary of the partnership, and was remarkable for the significant achievements made and the momentum that was built with governments and stakeholders. It is important that partners continue to strengthen the work proposed in a collaborative manner in order to guarantee its future success and the solid performance of this inter-agency cooperation.
