#### PROVISIONAL AGENDA AND ANNOTATIONS

#### Note by the Executive Secretary

### I. INTRODUCTION

1. Arrangements have been made for the twelfth session of the Subsidiary Body for Implementation (SBI) to be held at the Hotel Maritim, Bonn, from 12 to 16 June 2000. The session is scheduled to be opened by the Chairman at 11 a.m. on Monday, 12 June 2000.

2. Following agreement reached during the fifth session of the Conference of the Parties (COP 5), the duration of the twelfth session of the SBI will be one week. This week of formal meetings is to be preceded by a week of informal meetings, including workshops, at the same venue. A tentative schedule for this informal week is contained in annex II to this document. These consultations and workshops will be convened under the authority of the chairmen of the subsidiary bodies and will normally be open to all participants, including observers. Facilities will be available for up to two meetings at a time, although there will be no provision for interpretation or documentation during the pre-sessional week. It is hoped that the informal nature of these pre-sessional meetings will facilitate substantial progress being made on the various agenda items under consideration during the session.

#### II. PROVISIONAL AGENDA<sup>1</sup>

3. The provisional agenda for the twelfth session of the SBI, proposed after consultation with the Chairman, is as follows:

#### **III. ANNOTATIONS TO THE PROVISIONAL AGENDA**

#### 1. **Opening of the session**

4. The twelfth session of the SBI is scheduled to be opened by the Chairman at 11 a.m. on Monday, 12 June 2000.

#### 2. Organizational matters

#### (a) <u>Adoption of the agenda</u>

5. The provisional agenda for the twelfth session of the SBI will be presented for adoption. It may need to be adjusted to take account of developments during the week of informal meetings, including workshops, preceding the twelfth sessions of the subsidiary bodies.

6. Items 3, 4, 5 and 6 have been included in the provisional agendas for the twelfth sessions of both the SBI and the Subsidiary Body for Scientific and Technological Advice (SBSTA).

7. In view of the ambitious work programme the SBI has before it in the lead-up to the sixth session of the Conference of the Parties (COP 6), an effort has been made to streamline the agenda.

#### (b) <u>Organization of the work of the session</u>

8. Parties are invited to refer to the proposed schedule of work contained in annex III to this document.

9. It is proposed that items 3, 4, 5 and 6 of the provisional agenda be taken up initially in a joint meeting of the subsidiary bodies scheduled for the afternoon of Monday, 12 June.

10. In line with decisions  $10/\text{CP.5}^2$  and 11/CP.5, the secretariat will hold informal consultations with Parties during the pre-sessional week with a view to developing elements of a draft framework for capacity-building activities for consideration by the subsidiary bodies at their thirteenth sessions.

# 3. <u>Implementation of Article 4.8 and 4.9 of the Convention (decision 3/CP.3 and Articles 2.3 and 3.14 of the Kyoto Protocol)</u>

11. By its decision 5/CP.4,<sup>3</sup> the Conference of the Parties adopted the programme of work set out in the annex to that decision. According to this programme of work, the COP, at its sixth session, is to identify any additional actions needed to address the implementation of Article 4.8 and 4.9 of the Convention, as well as Articles 2.3 and 3.14 of the Kyoto Protocol. In light of this decision, the COP, by its decision 12/CP.5, mandated the organization of two workshops, back to back, before the end of March 2000. The workshops were held in Bonn, from 9 to11 March 2000, and from 13 to15 March 2000, respectively. The report on these workshops is contained in document FCCC/SB/2000/2.

12. The SBI may wish to consider the information provided in the report on the workshops, with a view to giving guidance on the identification of any further actions needed to address the implementation of Article 4.8 and 4.9 of the Convention, as well as Articles 2.3 and 3.14 of the Kyoto Protocol. Also, in accordance with decision 12/CP.5, the SBI may wish to discuss the implementation of the examples of initial actions listed in paragraph 4 (a)-(e) of that decision, and it may also wish to discuss the process of implementation of Article 4.8 and 4.9 of the Convention as provided for in the same decision.

# 4. Matters relating to Article 3.14 of the Kyoto Protocol

13. According to Article 3.14 of the Kyoto Protocol, the first session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (COP/MOP 1) shall consider actions to implement the provisions of Article 3.14. The COP, at its fifth session, having considered this matter along with the implementation of Article 4.8 and 4.9 of the Convention (decision 3/CP.3 and Articles 2.3 and 3.14 of the Kyoto Protocol), decided to consider further, at its sixth session, matters related to Article 3.14 as an input to COP/MOP 1, taking into account its ongoing discussions on the implementation of Article 4.8 and 4.9 of the Convention (decision 12/CP.5).

14. The SBI may wish to initiate deliberations on how the consideration of this item is to proceed.

# 5. Procedures and mechanisms relating to compliance under the Kyoto Protocol

15. By its decision 15/CP.5, the Conference of the Parties decided that the Joint Working Group (JWG) on Compliance should continue its work beyond the fifth session of the COP with the aim of completing its work so as to enable the Conference of the Parties to adopt a decision on a compliance system under the Kyoto Protocol at its sixth session.

16. The JWG, at its meetings during the eleventh sessions of the subsidiary bodies, invited Parties to submit any further proposals on compliance by 31 January 2000 (FCCC/SBI/1999/14, para. 84 (b)). The submissions are contained in document FCCC/SB/2000/MISC.2.

17. The JWG confirmed that a workshop on matters relating to a compliance system was needed and would be convened by the co-chairmen in March 2000 (FCCC/SBI/1999/14, para. 84 (c)). The workshop was held in Bonn from 1 to 3 March 2000.

18. The JWG requested the co-chairmen, with the assistance of the secretariat, to further develop the elements of procedures and mechanisms relating to a compliance system under the Kyoto Protocol (FCCC/SBI/1999/14, para. 84 (d)). The JWG will have before it, for its consideration, a note by the co-chairmen containing the elements for a framework of a compliance system under the Kyoto Protocol (FCCC/SB/2000/1).

19. The JWG may also wish to consider the next steps in the process of developing a compliance system under the Kyoto Protocol, bearing in mind that it must intensify its efforts to fulfil its mandate to recommend such a system to the Conference of the Parties at its sixth session.

# 6. <u>Mechanisms pursuant to Articles 6, 12 and 17 of the Kyoto Protocol</u>

20. Recalling its decision 7/CP.4 on the work programme on mechanisms of the Kyoto Protocol, the COP, at its fifth session, requested the chairmen of the subsidiary bodies to revise their note entitled "Synthesis of proposals by Parties on principles, modalities, rules and guidelines. Note by the chairmen" (FCCC/SB/1999/8 and Add.1), to incorporate further proposals by Parties and to consolidate a text for further negotiation, in accordance with comments by Parties. It also requested the chairmen of the subsidiary bodies to convene inter-sessional meetings and workshops to assist in undertaking preparatory work for the Conference of the Parties at its sixth session, drawing on technical expertise, as appropriate, taking into account the need for transparency and regional balance in representation and the need for Parties to review the work of the experts (decision 14/CP.5).

21. The revised note by the chairmen is contained in document FCCC/SB/2000/3, "Text for further negotiation on principles, modalities, rules and guidelines on mechanisms pursuant to Articles 6, 12 and 17 of the Kyoto Protocol. Note by the chairmen". This text takes into account further proposals submitted by Parties by 31 January 2000 (see document FCCC/SB/2000/MISC.1) and views expressed by Parties during the informal consultations on mechanisms, convened by the chairmen of the subsidiary bodies and chaired by Mr. Kok Kee Chow (Malaysia), held in Kuala Lumpur from 20 to 23 March 2000.

22. The chairmen of the subsidiary bodies will provide a briefing to Parties on the workshop on mechanisms to be held in Bonn during the week of informal meetings, including workshops, preceding the twelfth session of the SBI.

23. By its decision 14/CP.5, the COP also requested the subsidiary bodies, at their sessions prior to the sixth session of the COP, to take forward the consolidated text as a basis for further negotiations on principles, modalities, rules and guidelines, with priority to be given to the clean development mechanism, with a view to the COP taking decisions on all the mechanisms under Articles 6, 12 and 17 of the Kyoto Protocol at its sixth session, including, where appropriate, recommendations to COP/MOP 1.

24. The SBI, at its joint meetings with the SBSTA, may wish to consider the note by the chairmen contained in document FCCC/SB/2000/3 and the submissions by Parties in document FCCC/SB/2000/MISC.1 and to provide further guidance to the chairmen on how to take forward the consolidated text and the work programme on mechanisms under decision 7/CP.4.

## 7. <u>National communications from Parties included in Annex I to the Convention:</u> <u>experience with the review of second national communications</u>

25. The SBI, at its tenth session, requested the secretariat to prepare a report on experience with the review of second national communications, including suggestions for avoiding delays in the publication of reports in the future, for consideration at its twelfth session (FCCC/SBI/1999/8, para. 23 (c)). In response to this request, the secretariat has prepared a paper on experience with the in-depth reviews of national communications (FCCC/SBI/2000/3).

26. The SBI may wish to consider the options contained in this paper. In considering these options, it may wish to provide guidance to the secretariat on the continuation of preparations for the review of third national communications, including the possibility of drafting guidelines for conducting reviews of national communications from Parties included in Annex I to the Convention (Annex I Parties) and the structure of in-depth review reports, for consideration at a future session.

27. The SBI will also have before it a regular progress report on the in-depth reviews of second national communications (FCCC/SBI/2000/INF.6).

# 8. National communications from Parties not included in Annex I to the Convention

## (a) <u>Report of the first meeting of the consultative group of experts</u>

28. By its decision 8/CP.5, the Conference of the Parties decided to establish a consultative group of experts (hereinafter referred to as "the group") on national communications from Parties not included in Annex I to the Convention (non-Annex I Parties) with the objective of improving national communications from non-Annex I Parties. It requested the secretariat to

facilitate the work of the group in accordance with Article 8.2(c) of the Convention and decision 10/CP.2,<sup>4</sup> paragraph 1 (a), by, *inter alia*, coordinating the meetings of the group and compiling reports on its regional workshops and meetings for consideration by the subsidiary bodies.

29. According to the terms of reference of the group, which are annexed to decision 8/CP.5, the group shall meet twice in the year 2000, each time immediately prior to the meetings of the subsidiary bodies. The first of such meetings will take place during the week of informal meetings preceding the first sessional period in 2000. An oral report on the conclusions of this meeting will be presented to the SBI.

30. According to the same terms of reference, there will be one workshop each year in each of the regions (Africa, Asia, and Latin America and the Caribbean) to consider both regional and subregional experience. The Government of Mexico has offered to host the first such workshop for the Latin America and the Caribbean region in Mexico City from 8 to12 May 2000. The report of this workshop will be made available for consideration by the group at its first meeting.

31. The SBI may wish to take note of the oral report of the first meeting of the group, which will include information on the regional workshop for the Latin America and the Caribbean region, and provide further guidance to the group as it deems necessary.

# (b) <u>Provision of financial and technical support</u>

32. By decisions 10/CP.2 and 12/CP.4, the Conference of the Parties requested the secretariat to facilitate assistance to Parties not included in Annex I to the Convention in the preparation of their initial national communications, and to provide a report to the subsidiary bodies at each of their sessions. A report covering this request is contained in document FCCC/2000/SBI/INF.1.

33. Decision 10/CP.2 further requested the secretariat to submit to the SBI, at each of its sessions, details of the financial support made available by the Global Environment Facility (GEF) to Parties not included in Annex I to the Convention for the preparation of their initial national communications. A report covering this request is contained in document FCCC/SBI/2000/INF.2.

34. Decision 12/CP.4 also requested the secretariat to compile and make available to the Parties a list of projects submitted by non-Annex I Parties in accordance with Article 12.4 of the Convention. As of this year, the list of projects will be posted on the UNFCCC web site and will be updated on a regular basis.

35. The SBI may wish to take note of the information contained in the above-mentioned documents and the list of projects mentioned above and provide any guidance it deems necessary to the secretariat.

### 9. Financial mechanism

### (a) <u>Progress report on the review by the Global Environment Facility of enabling</u> <u>activities</u>

36. By its decision 10/CP.5, the Conference of the Parties requested the secretariat to report to the subsidiary bodies, at their twelfth sessions, *inter alia*, on progress in the review by the GEF of its enabling activities. This report is contained in document FCCC/SBI/2000/INF.3.

37. The SBI, at its eleventh session, noted that the GEF, in paragraph 32 of its report to COP 5, had indicated the initiation of a "comprehensive review of its support for the preparation of initial national communications from non-Annex I Parties". The review was expected to examine: (a) the effectiveness of this modality of support; (b) the effectiveness and efficiency of the operational procedures of the Facility; (c) the influence of support on broader capacity-building and/or planning; and (d) the best practice from country experience (FCCC/SBI/1999/14, para. 57 (b)). The GEF secretariat, at that session, assured the SBI that the views and concerns identified by non-Annex I Parties (see FCCC/SBI/1999/INF.10) would be taken fully into account, and that the review would be completed by COP 6 (FCCC/SBI/1999/14, para. 57 (c)-(d)).

38. The SBI may wish to consider the information provided in document FCCC/SBI/2000/INF.3 and make any comments it deems necessary.

### (b) <u>Progress report on the review by the Global Environment Facility of its</u> <u>capacity-building activities</u>

39. By its decision 10/CP.5, the Conference of the Parties requested the secretariat to report to the subsidiary bodies, at their twelfth sessions, *inter alia*, on progress in the review by the GEF of its capacity-building activities in its normal work programme, its Country Dialogue Workshops and its Capacity Development Initiative. This report is contained in document FCCC/SB/2000/INF.4.

40. The SBI may wish to consider the information provided in the above-mentioned document and to make any comments it deems necessary.

#### (c) <u>Additional guidance to the Global Environment Facility: support to the</u> <u>Intergovernmental Panel on Climate Change</u>

41. By its decision 19/CP.5, the Conference of the Parties noted with concern the urgent appeal for additional resources by the Chairman of the Intergovernmental Panel on Climate Change (IPCC). It urged Parties, and organizations in a position to do so, to contribute financial support to the work of the IPCC to enable it to complete its third assessment report and special reports in view of their importance to advancing the Convention process. The COP invited the SBI, at its twelfth session, to consider the issue of support to the IPCC in the context of recommending additional guidance to the GEF. The Chairman of the SBI has been consulting on this matter with the Chairman of the IPCC and the Chairman/CEO of the GEF; he will report the results of these consultations to the twelfth session of the SBI.

42. Parties may wish to come prepared to the session with suggestions relating to this issue. The SBI may wish to make recommendations to the Conference of the Parties at its sixth session on further guidance to the GEF.

# 10. Arrangements for intergovernmental meetings

43. The SBI will have before it document FCCC/SBI/2000/4 prepared by the secretariat for the sixth session of the Conference of the Parties after consultations with the Bureau, containing information on the following items.

(i) <u>Thirteenth sessions of the subsidiary bodies</u>

44. The Government of France offered to host the thirteenth sessions of the subsidiary bodies. Following consultations with the Bureau of COP 5, the Executive Secretary accepted the offer. Consequently the thirteenth sessions of the subsidiary bodies will be held in France from 11 to 15 September 2000, preceded by one week of informal meetings including workshops.

(ii) <u>Sixth session of the Conference of the Parties</u>

45. By its decision 2/CP.5, the Conference of the Parties accepted the offer of the Netherlands to host the sixth session of the Conference of the Parties in The Hague from 13 to 24 November 2000. The sixth session of the COP will be held in conjunction with resumed thirteenth sessions of the subsidiary bodies. The Conference requested the Executive Secretary to conclude a host country agreement with the Government of the Netherlands on arrangements for the sixth session of the COP.

46. This document will include a list of possible elements for a provisional agenda for the session and suggestions concerning the organization of work of the session including the scheduling of the sessions of the subsidiary bodies and the Conference and statements by the

Parties, observer States, intergovernmental organizations and non-governmental organizations. The SBI may wish to take note of the information provided by the secretariat, consider the suggestions presented and provide guidance on those matters.

### (iii) <u>Seventh session of the Conference of the Parties</u>

47. The SBI may wish to invite Parties interested in hosting COP 7 to present their offers for consideration by the SBI at its thirteenth session. The SBI, after considering any such offers, may wish to recommend, for adoption by COP 6, a decision on the date and host country for COP 7, and also to request the secretariat to start planning for COP 7 with the designated host country and enter into the necessary agreement.

### (iv) <u>Calendar of meetings for 2000-2004</u>

48. The Conference of the Parties, at its fifth session, adopted the calendar of meetings of Convention bodies for the period 2000-2003. The secretariat will propose dates for the sessional periods in 2004 for consideration by the SBI.

### 11. Administrative and financial matters

### (i) <u>Possible options to respond to late payment of contributions</u>

49. By its decision 21/CP.5, the Conference of the Parties expressed concern at the continuing trend towards late payment of contributions, some still outstanding from 1996 and 1997, and requested the Executive Secretary to present, through the SBI at its twelfth session, possible options to respond to the situation of late payment of contributions for consideration at its sixth session.

50. The SBI will have before it document FCCC/SBI/2000/2 on this subject. The SBI may wish to consider the various options presented in this document, and make its recommendation to include such options in an omnibus decision on administrative and financial matters to be adopted by the Conference of the Parties at its sixth session. It may also wish to provide the Executive Secretary with further guidance in this matter.

#### (ii) <u>Status of contributions</u>

51. Information on the latest status (as at 15 May 2000) of contributions by Parties to the core budget, the Trust Fund for Participation in the UNFCCC Process and the Trust Fund for Supplementary Activities is contained in document FCCC/SBI/2000/INF.5.

52. The SBI may wish to express its appreciation to the Parties that have made timely contributions to the core budget, especially those which have made voluntary contributions to the

other trust funds. The SBI may also wish to urge Parties that have not made their contributions to do so in a timely manner.

#### 12. <u>Report on the session</u>

53. Because of the time that is likely to be needed for considering all items on the agenda, a complete draft text of the report may not be available at the end of the session. The SBI may wish to adopt conclusions and authorize the Rapporteur to complete the report after the session with the guidance of the Chairman and the assistance of the secretariat. Subject to the availability of sufficient time for their translation, conclusions will be made available in all official languages.
