# Information on arrangements for UNFCCC workshops

Note by the secretariat

#### Summary

This document was prepared in response to a request by the Subsidiary Body for Implementation, at its twentieth session, for the secretariat to provide information on the arrangements for UNFCCC workshops, including such issues as criteria, scheduling and managing with limited funds. The document provides information on the substantive and logistic arrangements for workshops and their reports.

## I. Introduction

#### A. Mandate

1. The Subsidiary Body for Implementation (SBI), at its twentieth session, requested the secretariat to provide information on the arrangements for UNFCCC workshops, including such issues as criteria, scheduling and managing with limited funds (FCCC/SBI/2004/10, para. 131).

## B. Action by the Subsidiary Body for Implementation

2. The SBI is invited to consider the information presented in this paper and to provide guidance to chairs of subsidiary bodies and the secretariat on the organization of workshops.

## C. Background

- 3. Workshops can provide opportunities for informal discussion among smaller groups of Parties about specific issues. Expert meetings are similar, but the matters they address are more technical. Workshops and expert meetings are not meant to take decisions, but rather to explore particular issues in depth, and then report back to the subsidiary bodies for consideration by all Parties, and for eventual conclusions and decisions, as appropriate. The workshops are chaired by the chair of the relevant subsidiary body, a person designated by her/him or some other office holder of the Convention process, or a relevant senior person from a host country. The crucial role of the chair is to ensure that the discussions that take place follow the overall political context agreed by all Parties.
- 4. The secretariat has been requested by the Parties to organize a total of 61 workshops and expert meetings during the period from the adoption of the Marrakesh Accords at the seventh session of the Conference of the Parties (COP 7) to COP 10. A detailed description of these workshops, their mandates, and other relevant information is given in the annex to this note. The arrangements for and the funding of the constituted bodies of the Convention (including expert groups and other such mandated processes) are not within the scope of this note.
- 5. Since COP 7, a total of 1,598 participants have attended workshops and expert meetings, with some 56 per cent of the them coming from Parties not included in Annex I to the Convention (non-Annex I Parties).
- 6. Workshops and expert meetings require considerable staff time from the secretariat for the preparation of substantive papers; organization of the agenda and the invitation of the speakers and resource persons; administrative matters of fund-raising and travel arrangements for funded participants; and logistics relating to the workshop venue.

## II. Arrangements for workshops and expert meetings

- 7. The secretariat has internal arrangements to guide staff in the organization of workshops and expert meetings, including for ensuring geographical balance, effective participation and involvement of observers, as well as funding, logistics, preparing memorandums of understanding with host countries, and other practical details.
- 8. A number of deadlines need to be met before a workshop can be organized. In particular:
  - (a) At least six months is necessary, from the date of the decision, for the secretariat to organize a workshop. The time is needed to ensure high quality, including well prepared agendas, invited speakers and participants. In practical terms, this usually means that a

- workshop called for in a decision by Parties at a particular session cannot be held before the next session, because sessions of the subsidiary bodies are about six months apart
- (b) Funding for a workshop needs to be confirmed at least three months before the proposed date of the workshop
- (c) Invitations to participants can be made only after confirmation of funding; lack of timely funding has been a major reason for delays in the organization of workshops.
- 9. Only in exceptional circumstances, when a chair has judged, in consultation with the secretariat, that the UNFCCC process would be seriously and adversely affected by the cancellation of a planned workshop, would the deadlines be relaxed. This, however, can cause friction if invitations are sent out too late to allow all Parties to prepare themselves fully and the secretariat has insufficient time to attend to logistics.

#### A. Financial considerations

- 10. Most workshops and expert meetings are funded from the Trust Fund for Supplementary Activities. Some are financed from the Bonn Fund (see paragraph 14), and a few workshops have been funded partially or fully from the limited core funds available. Before a workshop can be confirmed, the secretariat needs to ensure that funding is available.
- 11. Timely availability of funding for workshops is a key factor in avoiding delays in invitations and organization, and in ensuring a balanced representation of participants. Parties may wish to consider whether the present situation (unpredictable and often late funding) could be improved upon by more predictable funding approaches, either through increases in the core budget, or through unearmarked contributions to cover workshop needs.
- 12. In some cases, Parties provide earmarked contributions for certain workshops sometimes as a result of fund-raising efforts by the secretariat, and sometimes spontaneously based on their interests and capabilities. Some intergovernmental organizations have also contributed financially to workshops, often by paying for the travel of a certain number of participants.
- 13. For some workshops, for which the secretariat was unable to assure earmarked contributions, it was possible to designate funds from unearmarked contributions to the Trust Fund for Supplementary Activities. Such funds, however, are usually very limited, and there are competing priorities for their use, including to cover ongoing activities. In some cases, with the approval of the original donor, it was possible to make use of unspent resources that had been earmarked for a different purpose. A number of workshops were also funded this way, in part or in full.
- 14. Subject to the availability of resources, the Bonn Fund can also pay for workshops held in Bonn, Germany the seat of the secretariat. This is an option only if the funding of the subsidiary body and COP meetings in Bonn is assured; this is the priority of the Bonn Fund.
- 15. Although in some cases the secretariat was unable to raise funds to organize certain workshops at the times they were requested to be held, eventually funds were usually found for the workshops mandated during the period from COP 7 to COP 10. The exceptions were:
  - (a) Regional workshops in order to facilitate information exchange and integrated assessments, including for adaptation (decision 5/CP.7, paragraph. 32). No deadline was set in the original decision for holding these workshops, and no Party raised the matter of timing of the workshops subsequent to the decision. Nevertheless, one workshop was held responding, at least in part, to this mandate the Expert Workshop

- on Local Coping Strategies and Technologies for Adaptation in New Delhi, India, in November 2003
- (b) Four regional workshops on Article 6 requested by Parties (decision 11/CP.8 and FCCC/SBSTA/2002/13, para. 52.(b)). Of these, the European regional workshop on the New Delhi work programme on Article 6 was funded by the region itself, and hosted by Belgium. The secretariat was able to raise funds for the African regional workshop on Article 6, held in Banjul, Gambia, in January 2004. No funds have yet been pledged for the remaining workshops for Asia and Latin America
- (c) Pre-sessional workshop to receive feedback from interested Parties on the further development of the clearing house, and to provide input to the SBI at its twentieth session for its consideration of future action relating to the clearing house (FCCC/SBI/2003/19, para. 4(d)). Funds could not be raised for this workshop and it was not held
- (d) Workshop on means and mechanisms for development and dissemination of methods and tools for evaluating impacts and adaptation (FCCC/SBSTA/2001/8, para. 23). This workshop was not held because of a lack of resources. However, the subject was included in the Expert Workshop on Local Coping Strategies and Technologies for Adaptation (New Delhi, India, November 2003), and in the Expert Meeting on Methods and Tools to Assess Impacts, Vulnerability and Adaptation (Manila, Philippines, April 2004).

#### **B.** Selection of venue

- 16. Workshops are held in Bonn unless a Party is interested in hosting the event. Some workshops are mandated to be held in a specific geographical or political region. Historically, the secretariat has deliberately opted to accept invitations from Parties to host workshops. This was felt to increase awareness, encourage deeper engagement and often lead to substantial capacity-building on climate change issues in the host country, as well as better understanding by the participants of the situation and context in the host country, even though some workshop locations have given rise to extra costs, complexities in travel and visa arrangements, and security questions. The SBI may wish to consider whether this approach should be continued in the future.
- 17. When workshops are held in Bonn, they are covered under the Host Country Agreement with the Government of Germany. When held elsewhere, following consultations between the secretariat and the potential host country, a memorandum of understanding between the host country and the secretariat is usually concluded.

## C. Invitations and participants

- 18. Workshops and expert meetings are different from formal meetings of the COP or the subsidiary bodies in that they are not open-ended events where all Parties are able to participate. Generally, workshops or expert meetings are planned for between 50 and 100 participants in total, depending on the subject matter to be considered, and the resources the secretariat is able to raise.
- 19. Once funding is secured, the secretariat, in consultation with the workshop chair, sets a date for the event (although in some cases the dates are set earlier, sometimes because workshops are held backto-back with other events). Invitations are then sent out to a selected number of Parties. The selection of participants aims to arrive at a geographically and substantively balanced representation of Parties. In practice, Parties that represent major groups of countries, and Parties that have been particularly active in

the issues that are being considered in the workshops, are the ones selected. Decisions on whom to invite are made by the relevant subsidiary body chair, with advice from the secretariat.

- 20. The secretariat sends the invitations either to the national focal points of the invited Parties, with a request to nominate participants, or, in the case of expert meetings, directly to invited participants who attend in their technical capacity. The invitation has information on the proposed agenda of the meeting, and the national focal points are requested to designate a participant who has knowledge/experience relating to the subject of the workshop. In many cases, the participants are also asked to prepare documents in advance of the meeting.
- 21. The secretariat also sends invitations to the recognized constituencies of non-governmental organizations (NGOs), with a request to nominate representatives for each of these constituencies, the number being dependent on the size of the workshop, and its subject.
- 22. The secretariat may also invite resource persons to present technical papers or to act as facilitators, in which case they may be engaged as consultants. Other resource persons participate and make presentations without fees, though their travel costs are usually reimbursed by the secretariat. The resource persons do not represent any Party or NGO constituency, but rather are there as technical, resource persons under the overall guidance and authority of the secretariat. Nevertheless, the secretariat has sought to ensure geographical balance among the invited resource persons.
- 23. The secretariat may also send invitations to representatives of relevant organizations of the United Nations and its specialized agencies and programmes, as well as to representatives of relevant intergovernmental organizations, depending on the subject matter being considered.
- 24. Once the nominations are received from the Parties and the other organizations that had been invited, the chair, in consultation with the secretariat, makes a final selection of the participants for the workshop. In most cases this means acceptance of the nomination received, but in some cases consultations may be needed to arrive at the most appropriate participation.

## D. Travel and daily subsistence allowance

25. Travel and daily subsistence allowance may be provided to participants from Parties that are developing countries or countries with economies in transition based on the same criteria already followed by the secretariat for the Trust Fund for Participation.

## E. Substantive arrangements for workshops

- 26. Parties provide guidance to the secretariat on the substantive arrangements for workshops in the form of concrete terms of reference or guiding ideas that are expressed in reports of subsidiary bodies or the COP.
- 27. Based on such guidance and guidance from the chair of the event, the secretariat develops a tentative agenda, with a list of proposed speakers and of resource persons which will be discussed with the chair before being circulated to the participants. The tentative agenda is proposed for adoption by the chair during the first session of the event.

# III. Reporting

28. Depending on the mandate of the workshop or expert meeting, reports are prepared under the authority of the chair, or the secretariat. In all cases they are completed by the secretariat following consultations with the chair of the event and of the relevant subsidiary body.

- 29. Workshop reports are normally prepared for the next subsidiary body session, but the timing of the workshop may mean that reports are available only a short time before the subsidiary body sessions and in breach of documentation availability rules set down by the Convention and the United Nations. The SBI may wish to consider whether the secretariat should continue this approach or adopt an approach whereby workshop reports go to a subsequent session of the subsidiary bodies, allowing for stricter adherence to the documentation availability rules.
- 30. In addition to the formal written reports, the secretariat also organizes other means to inform Parties who were unable to attend. The chairs usually make detailed oral reports at the relevant sessions of subsidiary bodies, and the outcomes of many workshops are presented through side events.
- 31. The secretariat has created a page on its web site for information about workshops. In practice, as soon as the date of the workshop is finalized the workshop is listed on the web site, by title, venue and proposed dates. As soon as the agendas and other related documentation (such as provisional list of participants, supporting documents, and presentations) are available, they are posted to the web site. When the workshop report is prepared, it is also usually posted on the web site, in addition to it being available on the main documentation page of the secretariat web site.

## IV. Issues for consideration by the Subsidiary Body for Implementation

- 32. The SBI may wish to consider the following key issues that arise out of the workshop experience of the secretariat:
  - (a) At least six months is necessary for the secretariat to fully organize a workshop. In practical terms, this means that a workshop called for in a decision taken by Parties at a particular session cannot be held implemented before the next session.
  - (b) The secretariat has deliberately opted to accept invitations from Parties to host workshops in different locations, as this was felt to be useful for a Convention process that has close to universal participation, even though some locations have given rise to extra costs, complexities in travel and visa arrangements, and security problems. Should the secretariat continue to follow this approach?
  - (c) Timely availability of sufficient funding is critical for the successful organization of workshops, and to ensure balanced representation. Parties may wish to consider whether the present situation (unpredictable and often late funding) could be improved upon by more predictable funding approaches, either through increases in the core budget, or through unearmarked contributions to cover workshops needs. Parties may also wish to consider whether "late" invitations are preferable to postponing a workshop due to delays in funding availability.
  - (d) The chairs of the subsidiary bodies, with support from the secretariat, have generally accepted nominations from Parties for workshops or expert meetings. Are Parties satisfied with the technical capacity of the nominated participants? If not, what additional steps could be taken to ensure adequate technical capacity of participants?
