I. Introduction

1. A request has been received from a Party to include two items in the provisional agenda of the Subsidiary Body for Implementation (SBI) at its twenty-second session. In accordance with rule 12 of the draft rules of procedure being applied, and in agreement with the Chair of the SBI, these items are included in the supplementary provisional agenda below as sub-items 5 (b) and 5 (c).

In the view of the Government of Saudi Arabia, consideration of this matter was not completed at the twenty-first session of the SBI and, in accordance with rule 16 of the draft rules of procedure being applied, it should be included automatically in the agenda of the next ordinary session unless otherwise decided by the Parties.
