Status of preparation of national communications from Parties not included in Annex I to the Convention

Note by the secretariat

Summary

This note contains information on the status of the preparation of national communications from Parties not included in Annex I to the Convention as at March 2005.

I. Mandate

1. The Conference of the Parties, by its decision 10/CP.2 (FCCC/CP/1996/15/Add.1), requested the secretariat to facilitate assistance to Parties, particularly developing country Parties, in the preparation of their initial national communications and to provide to the subsidiary bodies, at each of their sessions, a report on how it is facilitating such assistance. Further, the Subsidiary Body for Implementation, at its eighteenth session, requested the secretariat to make available to Parties information on the status of preparation of national communications from Parties not included in Annex I to the Convention (non-Annex I Parties) that had not yet submitted them, as well as details of the financial support provided to non-Annex I Parties by the Global Environment Facility (GEF) for the preparation of initial and subsequent national communications (FCCC/SBI/2003/8, para. 19 (b)).

II. Approach and scope of the note

2. In response to this mandate, two tables have been prepared based on responses from non-Annex I Parties to a questionnaire distributed by the secretariat in December 2004, other input from non-Annex I Parties and information provided by the GEF and its implementing agencies. The first table (annex I) indicates the status of preparation of second national communications from non-Annex I Parties; the second table (annex II) contains information on the status of preparation of initial national communications from non-Annex I Parties that have yet to submit them. The status of preparation of third national communications is summarized in chapter III below.

III. Status of preparation of third national communications

3. Two Parties (Mexico and Uruguay) have reported that they have started the process of preparing their third national communication. Mexico has received funding from the GEF under its expedited procedure. Uruguay's proposal for expedited GEF financing is under development.
