QUESTIONS PROPOSED BY THE GROUP OF 77 AND CHINA TO POTENTIAL ENTITIES INTERESTED IN THE OPERATION/MANAGEMENT OF THE ADAPTATION FUND

In view of the guidance previously agreed by the COP and COP/MOP in decisions **28/CMP.1**, **5/CP.7**, **10/CP.7**, and **17/CP.7** for the Adaptation Fund, and to assist the Group in its evaluation of this matter, institutions are invited to respond to the following questions:

- 1. How would you work under the authority of and follow the guidance of the COP/MOP?
- 2. How would you propose to address access to the Adaptation Fund in view of the guidance already agreed?
- 3. How would you operate/manage the fund in the context of a country-driven approach? In the context of a learning by doing approach?
- 4. Would your institution establish its own set of eligibility criteria for access to the Fund? How would this be undertaken and how would this relate to decisions from the COP/MOP?
- 5. Would you propose conditions such as co-financing as a criteria for accessing the Adaptation Fund?
- 6. How would you propose to address the issue of complementarity with respect to the other funds established to address adaptation under the Convention?
- 7. What administrative and management expenses would you apply to the Adaptation Fund, on what basis and for what activities?
- 8. How would you propose to maintain the autonomy of the Adaptation Fund?
- 9. Would you be able to keep a separate account/budget line for these funds?
- 10. How would you keep these funds independent of your guidelines and procedures meant for other funds that you may be managing?
- 11. What decision-making structure would you apply to the operation/management of the Adaptation Fund?
- 12. What decision-making structure would you apply to the implementation of guidance from the COP/MOP?
- 13. What decision-making structure would you propose to apply to any questions arising in connection with the application of guidance from the COP/MOP?
- 14. What approach would you take to facilitate sound financial management and transparency in your management of the Adaptation Fund?
- 15. How would you propose to handle the Adaptation Fund in the context of a possible management committee established by the COP/MOP?
- 16. What independent auditing systems would you apply to the management of the Adaptation Fund?
- 17. How would you propose to handle separate accounts for funds other than those funds coming from the share of the proceeds of CDM projects that come into the Adaptation Fund?
- 18. Would you propose to mobilise additional funds and how?
