



Annual status report of the greenhouse gas inventory of Finland

1. This status report was prepared by the secretariat as part of the initial check of the greenhouse gas inventory submitted in accordance with decision 19/CP.8. It reflects the content of the inventory submission of 2007 as originally submitted by the Party, and of the resubmissions received by 27 May 2007 and on 11 July 2007.

2. Finland has reported the LULUCF tables under the Kyoto Protocol on a voluntary basis in accordance with decision 15/CP.10.
