### Opening

The sessions of the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol (AWG-KP) and the Ad Hoc Working Group on Long-term Cooperative Action under the Convention (AWG-LCA) will commence with an opening ceremony attended by His Excellency Mr. John Agyekum Kufuor, President of the Republic of Ghana.
