4. *Background*: The AWG-KP drew upon the documentation prepared by the Chair to facilitate negotiations at the first part of the ninth session, which resulted in the issuance of documents FCCC/KP/AWG/2009/10/Rev.2, FCCC/KP/AWG/2009/10/Add.3/Rev.2, FCCC/KP/AWG/2009/10/Add.4/Rev.2 and FCCC/KP/AWG/2009/12/Rev.1.

5. *Action*: The AWG-KP will be invited to further intensify its work. In so doing it can continue to draw on the revised documentation prepared by the Chair to facilitate negotiations, with a view to consolidating the text contained therein.
