I. Opening of the session

(Agenda item 1)

- 1. The thirty-first session of the Subsidiary Body for Scientific and Technological Advice (SBSTA) was held at the Bella Center, Copenhagen, Denmark, from 8 to 12 December 2009.
- 2. The Chair of the SBSTA, Ms. Helen Plume (New Zealand), opened the session and welcomed all Parties and observers. She also welcomed Mr. Purushottam Ghimire (Nepal) as Rapporteur of the SBSTA.

II. Organizational matters

(Agenda item 2)

A. Adoption of the agenda

(Agenda item 2 (a))

- 3. At its 1st meeting, on 8 December, the SBSTA considered a note by the Executive Secretary containing the provisional agenda and annotations (FCCC/SBSTA/2009/4). Statements were made by representatives of 12 Parties, including one speaking on behalf of the Group of 77 and China, one on behalf of the Alliance of Small Island States (AOSIS), one on behalf of the Umbrella Group, one on behalf of the least developed countries, one on behalf of the European Union and its member States, and one on behalf of the Environmental Integrity Group (EIG).
- 4. At the same meeting, following the proposal of the Chair, the SBSTA adopted the agenda without amendment, as follows:
 - 1. Opening of the session.
 - 2. Organizational matters:
 - (a) Adoption of the agenda;
 - (b) Organization of the work of the session;
 - (c) Election of officers other than the Chair;
 - (d) Election of replacement officers.
 - 3. Nairobi work programme on impacts, vulnerability and adaptation to climate change.
 - 4. Development and transfer of technologies.
 - 5. Reducing emissions from deforestation in developing countries: approaches to stimulate action.
 - 6. Research and systematic observation.
 - 7. Methodological issues under the Convention:

- 8. Methodological issues under the Kyoto Protocol:

- 10. Other matters.
- 11. Report on the session.

B. Organization of the work of the session

(Agenda item 2 (b))

- 5. The SBSTA considered this sub-item at its 1st meeting, on 8 December, at which the Chair drew attention to the proposed programme of work posted on the UNFCCC website. On a proposal by the Chair, the SBSTA agreed to proceed on the basis of that programme of work. The secretariat informed the SBSTA of the status of documentation and other relevant issues.
- 6. The SBSTA agreed to the admittance of observer organizations that had applied to join the process, on the basis of the provisions of Article 7, paragraph 6, of the Convention.

C. Election of officers other than the Chair

(Agenda item 2 (c))

- 7. The SBSTA considered this sub-item at its 1st and 3rd meetings, on 8 and 12 December, respectively. At the 1st meeting, the Chair recalled rule 27 of the draft rules of procedure being applied,² whereby the SBSTA is expected to elect its Vice-Chair and Rapporteur. Such an election was last held at the twenty-ninth session of the SBSTA. The Chair informed the SBSTA that consultations on nominations were being undertaken and that she would keep delegates informed of progress. In the conduct of these consultations, Parties were invited to recall decision 36/CP.7 and to give active consideration to the nomination of women for elective posts in the SBSTA.
- 8. At the 3rd meeting, the Chair informed the SBSTA that agreement had been reached among the regional groups and proposed the nominees for election. The SBSTA elected Mr. Mihir Kanti Majumder (Bangladesh) as Vice-Chair and re-elected Mr. Ghimire as Rapporteur. The Chair informed the meeting that the Vice-Chair will serve for an initial term of one year, which may be renewed for another year. The Rapporteur will serve for a second term of one year. The Chair noted that the officers will serve for the thirty-second and thirty-third sessions of the SBSTA, or until their successors are elected. She thanked the current Bureau for its work

D. Election of replacement officers

(Agenda item 2 (d))

9. The elected Vice-Chair and Rapporteur represent a Parties to both the Convention and its Kyoto Protocol. Consequently, no election of replacement officers was necessary.

III. Nairobi work programme on impacts, vulnerability and adaptation to climate change

(Agenda item 3)

1. Proceedings

- 10. The SBSTA considered this item at its 1st and 3rd meetings, on 8 and 12 December, respectively. It had before it documents FCCC/SBSTA/2009/5, FCCC/SBSTA/2009/6, FCCC/SBSTA/2009/7, FCCC/SBSTA/2009/INF.5, FCCC/SBSTA/2009/MISC.9/Rev.1, FCCC/SBSTA/2009/MISC.10 and FCCC/TP/2009/2.
- 11. Statements were made by representatives of two Parties, including one speaking on behalf of AOSIS. In addition, statements were made by representatives of the Convention on Biological Diversity (CBD) and the Intergovernmental Panel on Climate Change (IPCC). Statements were also made on behalf of the farmers non-governmental organizations (NGOs) and on behalf of the trade union NGOs.
- 12. At its 1st meeting, the SBSTA agreed to consider this item in informal consultations convened by the Chair with the assistance of Mr. Kishan Kumarsingh (Trinidad and Tobago) and Mr. Don Lemmen (Canada). At the 3rd meeting, Mr. Lemmen reported on these consultations.
- 13. At its 3rd meeting, the SBSTA considered and adopted conclusions³ proposed by the Chair.

2. Conclusions

- 14. The SBSTA welcomed the report of the progress made in the implementation of the Nairobi work programme on impacts, vulnerability and adaptation to climate change since its thirtieth session, and took note of the reports on workshops in the work areas of adaptation planning and practices and economic diversification; a technical paper reviewing existing literature on the potential costs and benefits of adaptation options; a synthesis report on integrating and expanding adaptation planning and action; and documents FCCC/SBSTA/2009/MISC.9/Rev.1 and FCCC/SBSTA/2009/MISC.10, containing submissions from Parties and relevant organizations on efforts undertaken to assess the costs and benefits of adaptation options, and efforts to monitor and evaluate the implementation of adaptation projects, policies and programmes, respectively.
- 15. The SBSTA welcomed the direct engagement of, and the contributions provided by, a wide range of organizations⁹ in the implementation of the Nairobi work programme. It encouraged these organizations to continue and, if possible, further enhance, their efforts, including through action pledges¹⁰ and by providing information to the SBSTA on the implementation of these pledges, to assist

Parties in improving their understanding and assessment of climate change impacts and vulnerability, and to make informed decisions on practical adaptation actions and measures.

- 16. The SBSTA took note of the work being carried out by the secretariat, under the guidance of the Chair of the SBSTA, on further enhancing the outreach of the Nairobi work programme to relevant stakeholders, including the dissemination of user-friendly knowledge products. It requested the secretariat to continue these efforts.
- 17. The SBSTA noted the importance of the technical workshop on how regional centres and networks undertaking work relevant to climate change could collaborate, to be held before its thirty-second session.¹¹
- 18. The SBSTA reaffirmed the need to enhance the catalytic role of the Nairobi work programme and requested the secretariat to continue its efforts in engaging a wide range of organizations, including those implementing education, training and awareness-raising activities and adaptation actions.
- 19. The SBSTA recalled that, at its twenty-eighth session, it agreed to consider, at its thirty-third session, a summary report on the results of the second phase of implementation of the Nairobi work programme, and other information referred to in paragraph 25 of document FCCC/SBSTA/2008/6, with a view to reviewing the effectiveness of the Nairobi work programme.

IV. Development and transfer of technologies

(Agenda item 4)

1. Proceedings

- 20. The SBSTA considered this item at its 1st and 3rd meetings, on 8 and 12 December, respectively. It had before it two reports of the Expert Group on Technology Transfer (EGTT), namely documents FCCC/SB/2009/4 and Summary, and FCCC/SB/2009/INF.6. Statements were made by representatives of three Parties.
- 21. At the 1st meeting, the Chair invited Mr. Arthur Rolle (Bahamas), Chair of the EGTT, to report on the group's activities. At the same meeting, the SBSTA agreed to consider this item together with the Subsidiary Body for Implementation (SBI) 31 agenda item 7, "Development and transfer of technologies" in a joint contact group, co-chaired by Mr. Carlos Fuller (Belize) and Mr. Holger Liptow (Germany). At the 3rd meeting, Mr. Fuller reported on the joint contact group's consultations.
- 22. At its 3rd meeting, the SBSTA considered and adopted conclusions 12 proposed by the Chair.

2. Conclusions

23. The SBSTA and the SBI welcomed the report of the EGTT for 2009.¹³ The SBSTA and the SBI noted the oral report by the Chair of the EGTT on the outcomes of the group's fourth meeting, held from 23 to 25 September 2009 in Bangkok, Thailand. They welcomed the continued dialogue of the EGTT with the business community that took place in conjunction with this meeting. The SBSTA and the SBI recalled their conclusions at their thirtieth sessions that consideration should be given to establishing an effective means of engaging the private sector more fully in the process.¹⁴ One such means may be to provide an ongoing forum for members of the business and finance communities to regularly communicate their assessment of which actions by Parties could be most effective in enhancing the development and transfer of environmentally sound technologies and practices. The SBSTA and the SBI

expressed their appreciation to Mr. Arthur Rolle, the Chair of the EGTT, and Mr. Bruce Wilson (Australia), the Vice-Chair, for their contribution in guiding the EGTT to complete its work programme for 2008–2009.

- 24. The SBSTA and the SBI endorsed the rolling programme of work of the EGTT for 2010–2011. The SBSTA and the SBI noted that the EGTT will convene its special meeting in early 2010 to update this programme of work, taking into account any technology-related agreed outcome of the fifteenth session of the Conference of the Parties (COP), and will submit the updated programme of work for consideration by the SBSTA and the SBI at their thirty-second sessions. The SBSTA and the SBI welcomed the offer by the Government of Australia to host this meeting.
- 25. The SBSTA and the SBI welcomed the final report of the EGTT on performance indicators.¹⁶ The SBSTA noted that the report contains a set of indicators that could be used by the SBI as one of the tools to conduct the review and assessment of the effectiveness of the implementation of Article 4, paragraphs 1(c) and 5, of the Convention, and to regularly monitor and evaluate the effectiveness of the implementation of the technology transfer framework,¹⁷ as requested by decision 4/CP.13.
- 26. The SBSTA noted that the secretariat, in collaboration with the United Nations Environment Programme, United Nations Industrial Development Organization and the Climate Technology Initiative, organized the African regional workshop on preparing technology transfer projects for financing, which took place in Gaborone, Botswana, from 2 to 4 September 2009. The SBSTA also noted with appreciation the offer of the Government of Belize to host the Latin America and Caribbean regional workshop on preparing technology transfer projects for financing, which will be held in 2010.

V. Reducing emissions from deforestation in developing countries: approaches to stimulate action

(Agenda item 5)

1. Proceedings

- 27. The SBSTA considered this item at its 1st and 3rd meetings, on 8 and 12 December, respectively. Statements were made by representatives of 14 Parties, including one speaking on behalf of the EIG and one on behalf of the European Union and its member States.
- 28. In addition, statements were made by a representative of the Food and Agriculture Organization of the United Nations on behalf of the Collaborative Partnership on Forests and by a representative of CBD. A statement was also made on behalf of the indigenous peoples organizations.
- 29. At its 1st meeting, the SBSTA agreed to consider this item in a contact group co-chaired by Ms. Lilian Portillo (Paraguay) and Mr. Audun Rosland (Norway). At the 3rd meeting, Ms. Portillo reported on the contact group's consultations.
- 30. At its 3rd meeting, the SBSTA considered and adopted conclusions¹⁸ proposed by the Chair. It was noted that national circumstances include those of countries with specific circumstances, such as high forest cover and low rates of deforestation.

2. Conclusions

- 31. The SBSTA decided to forward a draft decision on methodological guidance for activities relating to reducing emissions from deforestation and forest degradation in developing countries for adoption by the COP at its fifteenth session.¹⁹
- 32. The SBSTA noted that it may need to consider providing further guidance on methodological issues in accordance with any relevant decisions adopted by the COP at its fifteenth session.
- 33. The SBSTA took note of the oral report by its Chair on ways of facilitating the coordination of the activities relating to decision 2/CP.13. It requested its Chair to continue exploring ways of facilitating such coordination and to report back at its thirty-second session.
- 34. The SBSTA reminded and encouraged Parties, relevant organizations and stakeholders to continue sharing information on activities relating to decision 2/CP.13 and any relevant decisions adopted by the COP at its fifteenth session via the Web Platform on the UNFCCC website.²⁰

VI. Research and systematic observation

(Agenda item 6)

1. Proceedings

- 35. The SBSTA considered this item at its 1st and 3rd meetings, on 8 and 12 December, respectively. It had before it document FCCC/SBSTA/2009/MISC.12. Statements were made by representatives of 12 Parties, including one speaking on behalf of the Group of 77 and China and one on behalf of the European Union and its member States.
- 36. In addition, statements were made by the Deputy Secretary-General of the World Meteorological Organization (WMO), by the Chair of the Global Climate Observing System (GCOS) Steering Committee and by a representative of Brazil speaking on behalf of the Chair of the Committee on Earth Observation Satellites (CEOS).
- 37. At its 1st meeting, the SBSTA agreed that the Chair would draft conclusions and present them to the SBSTA at its 3rd meeting.
- 38. At its 3rd meeting, the SBSTA considered and adopted conclusions²¹ proposed by the Chair.

2. Conclusions

- 39. The SBSTA noted with appreciation the oral statements delivered by the Deputy Secretary-General of WMO, the Chair of the GCOS Steering Committee, and the statement delivered on behalf of CEOS.
- 40. The SBSTA welcomed the provisional updated *Implementation Plan for the Global Observing System for Climate in Support of the UNFCCC*, ²² provided by the secretariat of GCOS in response to an invitation by the SBSTA at its thirtieth session. ²³

- 41. The SBSTA also welcomed the information on the outcome of World Climate Conference-3,²⁴ held in Geneva, Switzerland, from 31 August to 4 September 2009, provided by WMO in response to an invitation by the SBSTA at the same session.²⁵
- 42. The SBSTA decided to recommend draft conclusions on this matter for adoption by the COP at its fifteenth session. ²⁶

VII. Methodological issues under the Convention

(Agenda item 7)

A. Annual report on the technical review of greenhouse gas inventories from Parties included in Annex I to the Convention

(Agenda item 7 (a))

1. Proceedings

- 43. The SBSTA considered this sub-item at its 1st and 3rd meetings, on 8 and 12 December, respectively. It had before it document FCCC/SBSTA/2009/INF.4.
- 44. At its 1st meeting, the SBSTA agreed that the Chair would draft conclusions and present them to the SBSTA at its 3rd meeting.
- 45. At its 3rd meeting, the SBSTA considered and adopted conclusions proposed by the Chair.

2. Conclusions

46. The SBSTA took note of the annual report on the technical review of greenhouse gas inventories from Parties included in Annex I to the Convention.²⁷

B. Emissions from fuel used for international aviation and maritime transport (Agenda item 7 (b))

1. Proceedings

- 47. The SBSTA considered this sub-item at its 2nd and 3rd meetings, on 8 and 12 December, respectively. Statements were made by representatives of 11 Parties. Statements were also made by representatives of the International Civil Aviation Organization (ICAO) and the International Maritime Organization (IMO).
- 48. At its 2^{nd} meeting, the SBSTA agreed that the Chair would draft conclusions and present them to the SBSTA at its 3^{rd} meeting.
- 49. At its 3rd meeting, the SBSTA considered and adopted conclusions²⁸ proposed by the Chair.

2. Conclusions

50. The SBSTA noted the information received from the secretariats of ICAO and IMO on their ongoing work on emissions from fuel used for international aviation and maritime transport, and the views expressed by Parties on this information.

Proceedings

- 52. The SBSTA considered this sub-item at its 2nd and 3rd meetings, on 8 and 12 December, respectively. A statement was made by a representative of one Party.
- 53. At its 2nd meeting, the SBSTA agreed to consider this item in informal consultations convened by the Chair with the assistance of Mr. Samuel Adejuwon (Nigeria). At the 3rd meeting, Mr. Adejuwon reported that these consultations were inconclusive. In accordance with rule 16 of the draft rules of procedure being applied, the item will be forwarded to the thirty-second session of the SBSTA.

B. Carbon dioxide capture and storage in geological formations as clean development mechanism project activities

(Agenda item 8 (b))

1. Proceedings

- 54. The SBSTA considered this sub-item at its 2nd and 3rd meetings, on 8 and 12 December, respectively. It had before it document FCCC/SBSTA/2009/MISC.11. Statements were made by representatives of 13 Parties, including one speaking on behalf of the European Union and its member States and one on behalf of AOSIS.
- 55. At its 2nd meeting, the SBSTA agreed that the Chair would hold consultations and present draft conclusions to the SBSTA at its 3rd meeting.
- 56. At its 3rd meeting, the SBSTA considered and adopted conclusions²⁹ proposed by the Chair.

2. Conclusions

57. The SBSTA agreed to continue its consideration of this matter at its thirty-second session, based on the draft text contained in annex I.

C. Common metrics to calculate the CO₂ equivalence of greenhouse gases (Agenda item 8 (c))

- 58. The SBSTA considered this sub-item at its 2nd and 3rd meetings, on 8 and 12 December, respectively. Statements were made by three Parties, including one speaking on behalf of the European Union and its member States.
- 59. At its 2nd meeting, the SBSTA agreed to consider this sub-item in informal consultations convened by the Chair with the assistance of Mr. Michael Gytarsky (Russian Federation). At the 3rd meeting, Mr. Gytarsky reported that these consultations were inconclusive. In accordance with rule 16 of

the draft rules of procedure being applied, the item will be forwarded to the thirty-second session of the SBSTA.

IX. Matters relating to Article 2, paragraph 3, of the Kyoto Protocol

(Agenda item 9)

- 1. Proceedings
- 60. The SBSTA considered this item at its 1st and 3rd meetings, on 8 and 12 December, respectively.
- 61. At its 1st meeting, the SBSTA agreed to consider this item together with the SBI 31 agenda item 11, "Matters relating to Article 3, paragraph 14, of the Kyoto Protocol" in a joint contact group, co-chaired by Mr. Eduardo Calvo Buendia (Peru) and Ms. Kristin Tilley (Australia). At the 3rd meeting, Ms. Tilley reported on the joint contact group's consultations.
- 62. At its 3rd meeting, the SBSTA considered and adopted conclusions³⁰ proposed by the Chair.

2. Conclusions

- 63. A joint contact group was set up to discuss the SBSTA agenda item "Matters relating to Article 2, paragraph 3, of the Kyoto Protocol" and the SBI agenda item "Matters relating to Article 3, paragraph 14, of the Kyoto Protocol" during the thirty-first sessions of the SBSTA and the SBI. In the establishment of this joint contact group, the Chairs of the SBSTA and the SBI directed that equal time be allocated to the consideration of each item.
- 64. The SBSTA and the SBI agreed to continue their discussions on these matters in a joint contact group to be established by the SBSTA and the SBI at their thirty-second sessions. They agreed to resume the consideration of these matters at their thirty-second sessions, based on the draft text contained in annex II.

X. Other matters

(Agenda item 10)

65. No other matters were raised.

XI. Report on the session

(Agenda item 11)

66. At its 3rd meeting, on 12 December, the SBSTA considered and adopted the draft report on its thirty-first session.³¹ At the same meeting, on a proposal by the Chair, the SBSTA authorized the Rapporteur to complete the report on the session, with the assistance of the secretariat and under the guidance of the Chair.

XII. Closure of the session

67. At the 3rd meeting, on 12 December, a representative of the Executive Secretary provided a preliminary evaluation of the administrative and budgetary implications of conclusions adopted during the session. This follows decision 16/CP.9, paragraph 20, which requests the Executive Secretary to provide an indication of the administrative and budgetary implications of decisions³² if these cannot be met from existing resources within the core budget.

While decision 16/CP.9 refers to "decisions", it also has implications for conclusions of the subsidiary bodies.

- 68. During the session, the SBSTA requested the secretariat to carry out a number of activities that have administrative and budgetary implications. The majority of this work can be covered by the core budget or by resources that have already been included in the secretariat's initial estimated requirements under the Trust Fund for Supplementary Activities for the next biennium. However, under agenda item 5, "Reducing emissions from deforestation in developing countries: approaches to stimulate action", the SBSTA requested the secretariat to enhance the coordination of its capacity-building activities relating to the use of the IPCC guidance and guidelines. The initial work required to support this activity in 2010 presents an unanticipated cost of approximately USD 300,000. Costs for 2011 will be determined at a later date.
- 69. At the same meeting, the Chair thanked delegates, the chairs of contact groups and convenors of informal consultations for their contributions. She also thanked the secretariat for its support.
- 70. Closing statements were made by three Parties, namely, one speaking on behalf of the European Union and its member States, one on behalf of the Group of 77 and China, and one on behalf of the Umbrella Group. Statements were also made on behalf of the business and industry NGOs, the environmental NGOs, the women and gender NGOs and the youth NGOs.

Carbon dioxide capture and storage in geological formations as clean development mechanism project activities

[Recalling decisions 7/CMP.1, 1/CMP.2 and 2/CMP.4,

Recognizing that carbon dioxide capture and storage in geological formations is part of a range of potential options for mitigating greenhouse gas emissions,

Emphasizing that the application of carbon dioxide capture and storage projects shall be environmentally safe and have the objective of avoiding any seepage,

Noting that other conventions have addressed issues and adopted guidelines relevant to the international regulation of the application of carbon dioxide capture and storage, including risk assessment, environmental impact assessment and legal aspects,

Recognizing that carbon dioxide capture and storage in geological formations has been proposed by some Parties for inclusion under the clean development mechanism,

Also recognizing that other Parties have registered concerns regarding the implications of this possible inclusion and highlighted a number of unresolved issues,

- 1. *Takes note* of the final report of the Executive Board of the clean development mechanism on the "Possible implications of the inclusion of carbon dioxide capture and storage as clean development mechanism project activities";¹
- 2. *Recognizes* that the issues referred to in, inter alia, decision 1/CMP.2, paragraph 21, should be addressed:
- 3. Also recognizes that in order for carbon dioxide capture and storage in geological formations to be included under the clean development mechanism, long-term liability for the storage site, including liability for any seepage during and beyond the crediting period of the project, must be clearly assigned and the project boundary must be clearly defined;
- 3 bis. Requests the Subsidiary Body for Scientific and Technological Advice to work on the issues referred to in paragraph 2 above [that if resolved, would lead to the potential] [for the] development of [any] modalities and procedures for clean development mechanism project activities relating to carbon dioxide capture and storage in geological formations [, including the definition of the project boundary and participation requirements as well as the assignment of long-term liability,] and
