Rio Conventions' Ecosystems and Climate Change Pavilion

The **Rio Conventions' Ecosystems and Climate Change Pavilion** is a collaborative outreach activity involving the Rio Convention secretariats, the Global Environment Facility and other important partners. 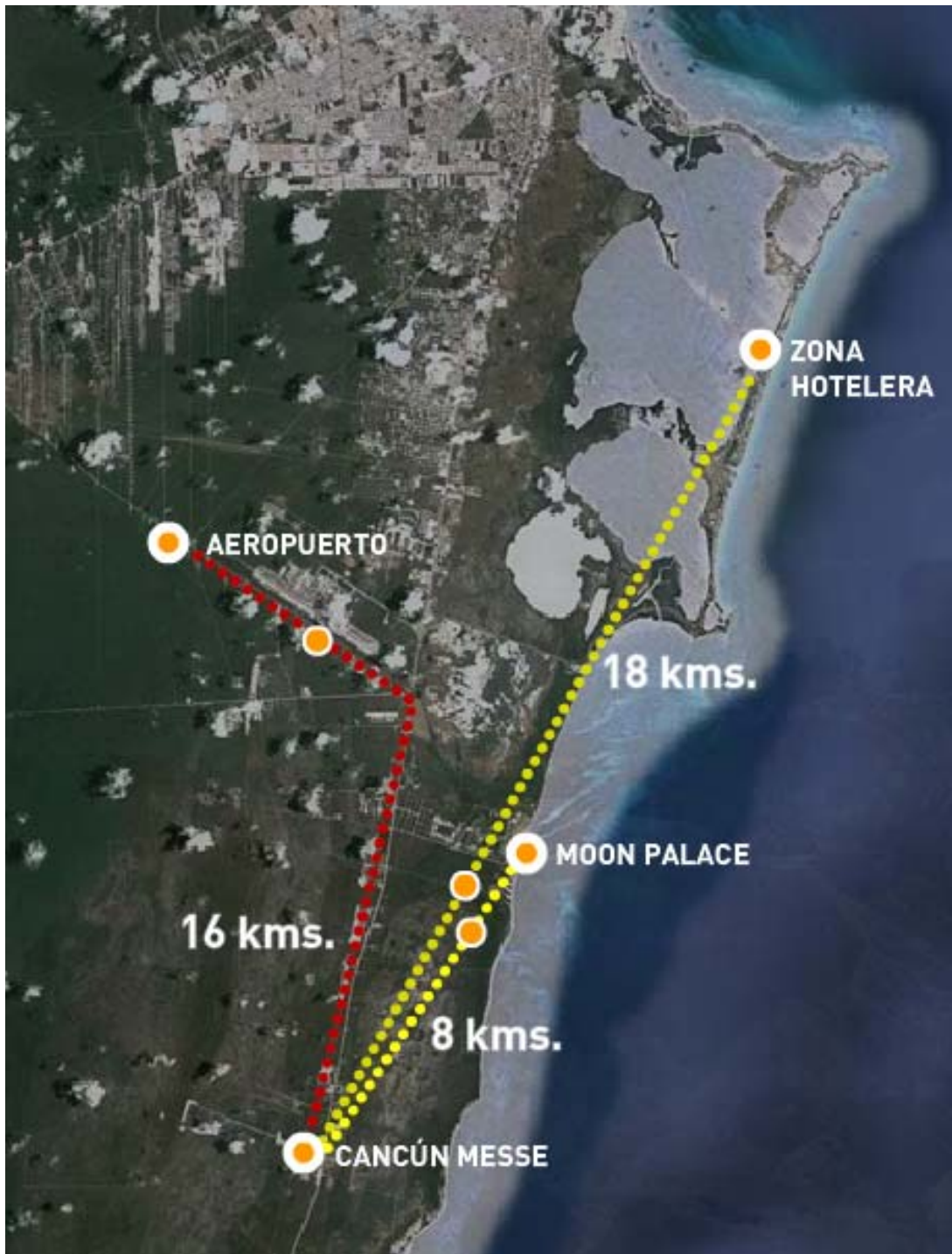
