Rio Conventions' Ecosystems and Climate Change Pavilion

The **Rio Conventions' Ecosystems and Climate Change Pavilion** is a collaborative outreach activity involving the Rio Convention secretariats, the Global Environment Facility and other important partners. In Cancun, the Ecosystems Pavilion will have a physical 'base' at Cancunmesse, but also has events at other locations, providing a diverse range of opportunities to discuss the linkages between biodiversity, climate change and sustainable land management.

During the course of COP 16/CMP 6, negotiators and other key decision-makers, scientists, and practitioners will be able to discuss the links between forest biodiversity and adaptation and mitigation; the role of oceans; indigenous peoples and communities, water, the role of protected areas, climate change biodiversity loss, desertification and land degradation, and financing.
