II. Annotations to the provisional agenda

1. Opening of the session

1. The thirty-second session of the Subsidiary Body for Implementation (SBI) will be opened by the Chair on Monday, 31 May 2010.

2. Organizational matters

(a) <u>Adoption of the agenda</u>

2. The provisional agenda for the session will be presented for adoption.

(b) <u>Organization of the work of the session</u>

3. *Background*: The thirty-second session of the SBI will be held from 31 May to 9 June 2010. A detailed schedule of the session will be posted on the UNFCCC website.

4. Given that four bodies will be meeting during the sessional period, the time available for contact groups and informal consultations will be very limited. To maximize the use of meeting time, the Chairs of the subsidiary bodies may, where possible and appropriate, propose that the co-chairs of negotiating groups facilitate agreement by tabling initial draft conclusions at the first meeting of the negotiating groups, based on relevant submissions and statements made during plenary meetings, and taking into account any previous negotiations and/or conclusions.

5. The SBI, at its thirtieth session,² agreed that all meetings should end by 6 p.m., particularly to give Parties and regional groups sufficient time to prepare for daily meetings, but may, in exceptional circumstances, and on a case by case basis, continue for two to three hours. The session will be organized taking this into account. In order to enable delegations to participate fully in other meetings taking place in parallel, the SBI will be invited to conduct its deliberations as efficiently as possible, including to optimize time used for plenary and for informal negotiations, and to finish its work within the time foreseen. Items that are not concluded at this session will be forwarded to the SBI for consideration at its thirty-third or thirty-fourth session.

6. In accordance with the conclusions adopted by the SBI at its twenty-fourth session,³ representatives of Parties and international organizations are requested to keep their oral statements as brief as possible. Those representatives wishing to make available a written statement should bring copies for distribution.

7. Parties are invited to refer to the overview of the session posted on the UNFCCC website and to consult the Daily Programme, published during the session, for a detailed and up-to-date schedule of the work of the SBI.

8. When considering relevant agenda items, Parties are also invited to take into account information contained in document FCCC/SB/2007/INF.2 on the relationship of various provisions of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States to the work of the Convention and its Kyoto Protocol.

3. National communications and greenhouse gas inventory data from Parties included in Annex I to the Convention

(a) <u>Report on national greenhouse gas inventory data from Parties included in Annex I to the</u> <u>Convention for the period 1990–2007</u>

10. *Background*: The Conference of the Parties (COP), by its decision 19/CP.8, requested⁴ the secretariat to provide information relating to greenhouse gas (GHG) inventory data submitted by Parties included in Annex I to the Convention (Annex I Parties) taken from the latest available inventory submissions for consideration by the COP and the subsidiary bodies. The secretariat has prepared a document annually since 2003 containing statistics on inventory submissions from Annex I Parties, summaries of GHG emissions/removals data for individual Annex I Parties, and some indicative trends for all Annex I Parties taken together, for Annex I Parties with economies in transition and for remaining Annex I Parties.

11. The SBI, at its thirty-first session, considered the agenda item and agreed to continue its consideration of matters under this agenda sub-item at its thirty-second session.⁵

12. *Action*: The SBI will be invited to continue its consideration of the information contained in the document below and consider the implications arising therefrom.

(b) <u>Status of submission and review of fifth national communications</u>

13. *Background*: The COP, by its decision 10/CP.13, requested Annex I Parties to submit to the secretariat a fifth national communication (NC5) by 1 January 2010 in accordance with Article 12, paragraphs 1 and 2, of the Convention, with a view to submitting the sixth national communication four years after this date. As at 16 February 2010, the secretariat had received 34 NC5s from Annex I Parties.

14. In accordance with decisions 2/CP.1, 6/CP.3, 11/CP.4 and 33/CP.7, each national communication submitted by an Annex I Party was subject to review. This included an in-depth in-country review of the submitted national communications, as well as the preparation by the secretariat of a compilation and synthesis of these national communications for consideration by the COP. In accordance with decision 7/CP.11, the review of the fourth national communications submitted by Annex I Parties was organized by the secretariat as a centralized review, except for those Parties that requested an in-depth review.

15. According to the "Guidelines for review under Article 8 of the Kyoto Protocol", each national communication submitted under the Kyoto Protocol by an Annex I Party shall be subject to a scheduled in-country review and the expert review teams shall make every effort to complete the individual review of national communications within two years of their submission. Following these guidelines, the secretariat plans to organize 14 in-country reviews of NC5s in 2010. In addition, the same guidelines request the secretariat to prepare a report on the compilation and synthesis of national communications of Annex I Parties submitted under the Kyoto Protocol in accordance with the decisions of the COP and the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP).

16. *Action*: The SBI will be invited to take note of the report on the status of submission and review of NC5s mentioned below. It will also be invited to prepare a draft decision on the compilation and synthesis of NC5s for adoption by the COP at its sixteenth session, and to prepare a draft decision on the compilation and synthesis of supplementary information under Article 7, paragraph 2, of the Kyoto Protocol contained in the NC5s, for adoption by the CMP at its sixth session. The SBI may wish to provide further guidance on the in-depth review of NC5s, in particular with regard to options for organizing centralized reviews for some Parties with smaller economies.

(c) <u>Date of submission of sixth national communications</u>

17. *Background*: The COP, by its decision 10/CP.13, decided to consider the date of submission of sixth national communications (NC6s) of Annex I Parties at its fifteenth session at the latest. The SBI, at its thirty-first session, began its consideration of the date of submission of the NC6s of Annex I Parties and agreed to set this date at its thirty-second session and to forward a draft decision on this matter for adoption by the COP at its sixteenth session. The SBI also agreed to continue its consideration of the other matters relating to the status of the review of fourth national communications and preparations for the review of fifth national communications at its thirty-second session.

18. *Action*: The SBI will be invited to take note of the document mentioned below. The SBI will also be invited to prepare and forward a draft decision, setting the date of submission of the NC6s of Annex I Parties, to the COP for adoption at its sixteenth session.

4. National communications from Parties not included in Annex I to the Convention

(a) Work of the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention

19. *Background*: The COP, by its decision 5/CP.15, decided to reconstitute the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE) for a period of three years from 2010 to 2012. The terms of reference of the CGE, annexed to decision 5/CP.15, provided for the development of the group's work programme for 2010–2012 at its first meeting. The CGE is scheduled to hold its first meeting from 29 to 31 March 2010 in Bonn, Germany, to develop its work programme and to establish organizational arrangements for implementing its mandate.

20. *Action*: The SBI will be informed about the membership of the CGE and its organizational arrangements and invited to consider and provide further guidance to the CGE in the implementation of its work programme.

(b) Information contained in national communications from Parties not included in Annex I to the Convention⁷

21. *Background*: At SBI 24, Australia, on behalf of the Umbrella Group, the European Community and its member States, and Bosnia and Herzegovina, Romania, Serbia and Montenegro, and Switzerland, requested that, in accordance with the requirements of Article 10, paragraph 2, of the Convention, the SBI consider the information communicated by Parties not included in Annex I to the Convention (non-Annex I Parties) in all of their national communications, including their second and, where appropriate, subsequent national communications.⁸

22. *Action*: The SBI will be invited to provide guidance on how to develop the process for considering information contained in national communications from non-Annex I Parties, in accordance with the requirements of Article 10, paragraph 2, of the Convention.

(c) <u>Further implementation of Article 12, paragraph 5, of the Convention</u>

23. *Background*: The COP, by its decision 8/CP.11, decided to discuss the further implementation of Article 12, paragraph 5, of the Convention at its fifteenth session. At its thirty-first session, the SBI agreed to defer the consideration of this sub-item to its thirty-second session.⁹

24. *Action*: The SBI will be invited to facilitate the deliberations on the frequency of submissions of national communications from non-Annex I Parties, taking into account the differentiated timetable set by Article 12, paragraph 5, of the Convention.

(d) <u>Provision of financial and technical support</u>

25. *Background*: The COP, by its decision 10/CP.2, paragraph 1 (b), requested the secretariat to make available to the SBI, at each of its sessions, details of the financial support made available to non-Annex I Parties by the Global Environment Facility (GEF) for the preparation of their national communications. The SBI, at its thirtieth session,¹⁰ invited the GEF to continue to provide information on its activities relating to the preparation of national communications from non-Annex I Parties, including information on the dates of approval of funding and disbursement of funds. This information was not considered at the thirty-first session of the SBI as it agreed to defer consideration of this agenda sub-item to its thirty-second session.¹¹

26. *Action*: The SBI will be invited to consider the information provided by the GEF contained in the documents below and to make recommendations thereon.

5. Financial mechanism of the Convention

(a) <u>Fourth review of the financial mechanism</u>

27. *Background*: The COP, by its decision 2/CP.12, requested the SBI to initiate the fourth review of the financial mechanism at its twenty-seventh session and report on the outcome to the COP no later than at its sixteenth session. By its decision 6/CP.13, the COP adopted additional guidelines for the review of the financial mechanism and requested the SBI to recommend, in accordance with decision 2/CP.12, a draft decision on the review for adoption by the COP at its fifteenth session.

28. The SBI considered this request at its thirtieth session and decided to continue its consideration of this issue at its thirty-first session on the basis of the draft text contained in annex I to the report of the SBI on its thirtieth session. It also invited Parties to make submissions to the secretariat on the operation of funds under the GEF as an operating entity of the financial mechanism, as well as the Special Climate Change Fund and the Least Developed Countries Fund, for compilation into a miscellaneous document to inform the fourth review of the financial mechanism.¹²

29. As the SBI was unable to complete its work on this matter at its thirty-first session, the COP, by its decision 6/CP.15, requested the SBI to continue its consideration of this issue at its thirty-second session on the basis of the draft text contained in the annex to that decision, with a view to recommending a draft decision for adoption by the COP at its sixteenth session.

30. *Action*: The SBI will be invited to continue its deliberations on this matter with a view to recommending a draft decision for adoption by the COP at its sixteenth session.

(b) <u>Report of the Global Environment Facility to the Conference of the Parties and guidance to the</u> <u>Global Environment Facility</u>

31. *Background*: The COP, by its decision 4/CP.14, requested the GEF to continue to provide, in its regular report to the COP, information in response to the guidance it had provided. The GEF provided this information in its report to the COP.¹³ The COP, by its decision 7/CP.15, noted the report of the GEF to the COP and requested the SBI to continue its consideration of additional guidance to the GEF at its thirty-second session, with a view to recommending a draft decision for adoption by the COP at its sixteenth session.

32. *Action*: The SBI will be invited to consider additional guidance to the GEF with a view to recommending a draft decision for adoption by the COP at its sixteenth session.

(c) Assessment of the Special Climate Change Fund

33. *Background*: The COP, by its decision 1/CP.12, decided to assess, at its fifteenth session, the status of implementation of paragraph 2 of that decision, with a view to considering further guidance on how the fund shall support concrete implementation projects in accordance with paragraphs 22–29 of decision 5/CP.7. The SBI, at its thirty-first session, considered this agenda sub-item but was unable to complete its deliberations. It agreed to continue its consideration of matters under this agenda sub-item at its thirty-second session.

34. *Action*: The SBI will be invited to prepare a draft decision on this matter for adoption by the COP at its sixteenth session.

6. Article 6 of the Convention

35. *Background*: The COP, by its decision 9/CP.13, decided to adopt the amended New Delhi work programme on Article 6 of the Convention as contained in the annex to that decision, and to extend it for five years. The COP further decided to undertake an intermediate review of progress in the implementation of the amended New Delhi work programme in 2010, to evaluate its effectiveness and identify emerging gaps and needs, and a comprehensive review of its implementation in 2012.

36. By the same decision, the COP requested the secretariat to organize thematic regional and subregional workshops to share lessons learned and best practices, in collaboration with relevant partners, and prior to the intermediate review of the work programme in 2010, subject to availability of funds.

37. Following this request, two regional workshops on the implementation of Article 6 in Europe and in Asia and the Pacific were held from 18 to 20 May 2009 in Stockholm, Sweden, and from 14 to 16 October 2009 in Bali, Indonesia, respectively. The reports on these workshops are contained in documents FCCC/SBI/2010/2 and FCCC/SBI/2010/3. A regional workshop on the implementation of Article 6 in Latin America and the Caribbean is scheduled to take place in April 2010 in the Dominican Republic. Further regional workshops for Africa and the small island developing States are planned to be held later in 2010, subject to availability of funds. Reports of these workshops will be used by the secretariat along with information contained in national communications and other sources of information for the preparation of a note on the progress in the implementation of the amended New Delhi work programme for its intermediate review.

38. *Action*: The SBI will be invited to take note of the reports of the regional workshops referred to in paragraph 37 above and determine any appropriate action relating to the convening of the intermediate review of progress in the implementation of the amended New Delhi work programme.

7. Matters relating to Article 4, paragraphs 8 and 9, of the Convention

(a) <u>Progress on the implementation of decision 1/CP.10</u>

39. *Background*: The SBI, at its thirty-first session, took note of documents¹⁴ issued to date on the implementation of Article 4, paragraph 8, of the Convention and decisions 5/CP.7 and 1/CP.10.

40. At the same session, the SBI recalled that, at its thirtieth session, it had invited Parties and relevant organizations to submit to the secretariat, by 22 March 2010, their views on possible further action on this matter, which may include views on the elements to be contained in a possible draft decision text.¹⁵ These submissions are compiled in document FCCC/SBI/2010/MISC.1.

41. Also at the same session, the SBI requested its Chair to continue developing a draft decision text based on the documents referred to in paragraph 39 above and further submissions as mentioned in paragraph 40 above, with a view to the COP adopting a decision at its sixteenth session.

42. *Action*: The SBI will be invited to consider the draft decision text prepared by its Chair mentioned in paragraph 41 above, with a view to recommending a draft decision for adoption by the COP at its sixteenth session.

(b) <u>Matters relating to the least developed countries</u>

43. *Background*: The COP, by its decision 8/CP.13, extended the mandate of the Least Developed Countries Expert Group (LEG) under the terms of reference in decision 29/CP.7.

44. In accordance with its mandate, the LEG is scheduled to conduct its seventeenth meeting in Bonn, Germany, from 12 to 14 April 2010. At this meeting, the LEG will continue to implement its work programme for 2008–2010 and plan specific activities for 2010, taking into account further guidance provided on the work programme of the LEG at SBI 31.¹⁶

45. *Action*: The SBI will be invited to consider the report of the LEG below and provide guidance thereon.

8. Development and transfer of technologies

46. *Background*: The COP, by its decision 3/CP.13, requested the Expert Group on Technology Transfer (EGTT) to provide a report at each session of the subsidiary bodies with a view to seeking guidance for further actions. The SBI and the Subsidiary Body for Scientific and Technological Advice (SBSTA), at their thirty-first sessions, endorsed the rolling programme of work of the EGTT for 2010– 2011¹⁷ and noted that the EGTT would submit an updated programme of work for consideration by the SBI and the SBSTA at their thirty-second sessions.¹⁸ The EGTT convened its special meeting in Sydney, Australia, from 22 to 23 February to update its programme of work, taking into account any technology-

related agreed outcome of COP 15. The report of the EGTT, with its updated programme of work, is contained in document FCCC/SB/2010/INF.1.

47. The SBI, at its twenty-ninth session,¹⁹ agreed on the terms of reference²⁰ for the review and assessment of the effectiveness of the implementation of Article 4, paragraphs 1(c) and 5, of the Convention. At its thirtieth session, it agreed to consider matters relating to the review and assessment at its thirty-second session, in accordance with the terms of reference, taking into account submissions from Parties and relevant organizations, the updated synthesis report referred to in paragraph 48 below and all relevant work of the EGTT, including the final report by the EGTT on performance indicators.²¹

48. The SBI, at its thirtieth session, recalled decision 2/CP.14, paragraph 3, and invited Parties and relevant organizations, particularly those that have not done so, to submit to the secretariat, by 15 February 2010, their views on the areas of focus set out in section IV of the terms of reference. It requested the secretariat to update the synthesis report based on these views and make it available for consideration by the SBI at its thirty-second session.²² The updated synthesis report is contained in document FCCC/SBI/2010/INF.6. The SBI also requested the secretariat to initiate preparatory work required, as appropriate, to support the timely completion of the review.²⁴ The report on progress and initial findings of these activities and preparatory work are contained in document FCCC/SBI/2010/INF.4.

49. The COP, by its decision 2/CP.14, welcomed the Poznan strategic programme on technology transfer²⁵ and requested the GEF to report on the progress made in carrying out the activities contained in the strategic programme at its thirtieth and thirty-first sessions. The SBI, at its thirty-first session, noted the second interim report and invited the GEF to provide a report on the progress made on the implementation of this programme at its thirty-second session, including on the long-term aspects of the Poznan strategic programme. The report of the GEF is contained in document FCCC/SBI/2010/4.

50. *Action*: The SBI will be invited to:

- (a) Take note of the report of the EGTT and endorse its updated rolling programme of work for 2010–2011 and provide further guidance to the EGTT, as appropriate;
- (b) Consider the reports referred to in paragraph 48 above and determine any further actions arising from them;
- (c) Consider the report of the GEF on the progress made in carrying out the Poznan strategic programme on technology transfer and determine any further actions arising from it.

9. Capacity-building under the Convention

51. *Background*: The COP, by its decision 2/CP.10, decided to initiate a second comprehensive review of the implementation of the framework for capacity-building in developing countries established under decision 2/CP.7 (the capacity-building framework) at the twenty-eighth session of the SBI, with a view to completing it at the fifteenth session of the COP.

52. The COP, by its decision 6/CP.14, requested the SBI to prepare, at its thirtieth session, in accordance with the terms of reference for the second comprehensive review of the implementation of the capacity-building framework,²⁶ a draft decision on the outcome of this review for adoption by the COP at its fifteenth session. By the same decision, the COP decided to take into account, in the second comprehensive review, recommendations made by the SBI at its thirtieth session on further steps to regularly monitor and evaluate capacity-building activities undertaken pursuant to decisions 2/CP.7 and 4/CP.12.

53. The SBI, at its thirtieth session, considered this item on the basis of reports prepared by the secretariat in response to requests from the SBI at its twenty-eighth²⁷ and twenty-ninth sessions²⁸ and other documents containing information and views submitted by Parties, intergovernmental organizations (IGOs) and non-governmental organizations (NGOs). The SBI was unable to finalize its deliberations and decided to continue consideration of matters under this item at its thirty-first session.

54. The SBI, at its thirty-first session, agreed to defer consideration of the item to its thirty-second session.

55. The COP, by its decision 8/CP.15, requested the SBI to continue its consideration of the second comprehensive review of the implementation of the capacity-building framework at its thirty-second session, with a view to preparing a draft decision on the outcome of this review for adoption by the COP at its sixteenth session.

56. *Action*: The SBI will be invited to consider the documents mentioned in paragraph 53 above as listed below. The SBI will also be invited to prepare a draft decision on the outcome of the second comprehensive review for adoption by the COP at its sixteenth session.

57. *Background*: The COP, by its decision 2/CP.10, decided to initiate a second comprehensive review of the implementation of the capacity-building framework at the twenty-eighth session of the SBI with a view to completing it at the fifteenth session of the COP.

58. The CMP, by its decision 6/CMP.4:

- (a) Acknowledged that the comprehensive review of the implementation of the capacity-building framework under the Convention is also applicable for capacity-building relating to the implementation of the Kyoto Protocol;
- (b) Requested the SBI to prepare, at its thirtieth session, in accordance with the terms of reference for the second comprehensive review of the implementation of the capacity-building framework,²⁹ a draft decision on the outcome of this review for adoption by the CMP at its fifth session;
- (c) Decided to take into account, in the second comprehensive review, recommendations made by the SBI at its thirtieth session on further steps to regularly monitor and evaluate capacity-building activities undertaken pursuant to decisions 2/CP.7, 29/CMP.1 and 6/CMP.2.

59. 62. *Action*: The SBI will be invited to continue its deliberations on this issue, taking into account the documents referred to in paragraph 59 above and listed below, with a view to recommending a draft decision on the outcome of the second comprehensive review of the capacity-building framework for adoption by the CMP at its sixth session.

11. Review of the Adaptation Fund

63. *Background*: The CMP, at its third session, decided to undertake at its sixth session a review of all matters relating to the Adaptation Fund, including the institutional arrangements, with a view to ensuring the effectiveness and adequacy of the Fund. The review shall take into account the outcome of performance reviews of the secretariat and the trustee servicing the Adaptation Fund, submissions by Parties and other interested IGOs and stakeholders. Furthermore, the CMP decided that the interim institutional arrangements, with the GEF providing secretariat services to the Adaptation Fund Board and the World Bank serving as a trustee of the Adaptation Fund, shall be reviewed at the sixth session of the CMP.³²

64. The CMP, at its fifth session, requested the SBI to initiate the review of the Adaptation Fund at its thirty-second session and to agree on the terms of reference for the review, with a view to reporting back to the CMP at its sixth session so that the review can be undertaken by the CMP at that session.

65. *Action*: The SBI will be invited to consider the views and recommendations submitted by Parties and to agree on the terms of reference for the review of the Adaptation Fund and any further steps that could be taken in preparation for the consideration of this matter by the CMP at its sixth session.

12. Matters relating to Article 3, paragraph 14, of the Kyoto Protocol

66. *Background*: The SBI, at its thirty-first session, considered this agenda item with the SBSTA agenda item "Matters relating to Article 2, paragraph 3, of the Kyoto Protocol" in a joint contact group. At the same session, the SBI and the SBSTA agreed to continue discussing these matters in a joint contact group at their thirty-second sessions, based on the draft text annexed to their respective reports.³³

67. *Action*: The SBI will be invited to consider this matter with a view to agreeing on further action.

13. Annual compilation and accounting report for Annex B Parties under the Kyoto Protocol

68. *Background*: The CMP, by its decision 13/CMP.1, requested the secretariat to publish the annual compilation and accounting reports after completion of the initial review under Article 8 of the Kyoto Protocol and resolution of any question of implementation relating to adjustments under Article 5, paragraph 2, of the Kyoto Protocol, and to forward such reports to the CMP, the Compliance Committee and each Party concerned.

69. The annual compilation and accounting report for Annex B Parties under the Kyoto Protocol containing information for 37 Annex B Parties, for which the initial reviews had been completed and any questions of implementation had been resolved as at 31 August 2009, was forwarded to the CMP at its fifth session.

70. The report presented in the document below contains final values for some of the initial accounting parameters recorded in the compilation and accounting database after the completion of the initial review under the Kyoto Protocol. It also contains provisional information on: (1) the total GHG emissions from the sources listed in Annex A to the Kyoto Protocol reported voluntarily for 2007; (2) emissions and removals of GHGs from land use, land-use change and forestry activities under Article 3, paragraph 3, and elected activities under Article 3, paragraph 4, reported voluntarily for 2007; and (3) transactions and holdings of the Kyoto Protocol units for the first year of the commitment period (2008).

71. The CMP, at its fifth session, referred this agenda item to the SBI for its consideration. The SBI, at its thirty-first session, considered the agenda item and agreed to continue its consideration of matters under this agenda item at its thirty-second session.

72. *Action*: The SBI will be invited to continue its consideration of the information contained in the document below.

14. Amendment of the Kyoto Protocol in respect of procedures and mechanisms relating to compliance

73. *Background*: The SBI, at its thirtieth session,³⁴ agreed to continue to discuss this matter further at its thirty-second session. The agenda item is based on a proposal by Saudi Arabia contained in document FCCC/KP/CMP/2005/2 and on decision 27/CMP.1.

74. *Action*: The SBI will be invited to continue consideration of this issue.

15. Proposal from Kazakhstan to amend Annex B to the Kyoto Protocol

75. *Background*: At its fifth session, the CMP took note of the proposal from Kazakhstan, communicated to the secretariat on 18 September 2009, to amend Annex B to the Kyoto Protocol.³⁵ Kazakhstan proposes to include the name of Kazakhstan in Annex B, with a quantified GHG emission limitation or reduction commitment under Article 3 of the Kyoto Protocol of 100 per cent of the 1992 level in the commitment period 2008 to 2012 and a footnote indicating that the country is undergoing the process of transition to a market economy. The CMP also noted the requirement set out in Article 21, paragraph 3, of the Kyoto Protocol, which stipulates that the text of any proposed annex or amendment to an annex shall be communicated to the Parties by the secretariat at least six months before the meeting at which it is proposed for adoption. The CMP agreed to place the item on the provisional agenda for its sixth session.

76. The CMP requested the secretariat to communicate the text of the proposed amendment to Annex B by Kazakhstan, pursuant to Article 21, paragraph 3, of the Kyoto Protocol, to the Parties to the Kyoto Protocol and the Parties and signatories to the Convention. The secretariat communicated the text of the proposed amendment to Annex B by Kazakhstan to the Parties to the Kyoto Protocol and the Parties and signatories to the Convention by a note verbale dated 21 January 2010 and to the Depositary by a letter dated 6 January 2010.

77. The CMP also requested the SBI to consider the proposal from Kazakhstan to amend Annex B to the Kyoto Protocol at its thirty-second session and to report on the outcome to the CMP at its next session.

78. *Action*: SBI will be invited to consider the proposal from Kazakhstan to amend Annex B to the Kyoto Protocol and report on the outcome to the CMP at its sixth session.

16. Arrangements for intergovernmental meetings

79. *Background*: The COP, by its decision 13/CP.15, accepted with appreciation the offer by the Government of Mexico to host COP 16 and CMP 6 from 29 November to 10 December 2010. In accordance with this decision, it is expected that the Executive Secretary will conclude a Host Country Agreement with the Government of Mexico in preparation for the sessions. Further information on preparations will be provided by the Government of Mexico and the secretariat.

80. The document below includes a list of possible elements for a provisional agenda for COP 16, as well as suggestions concerning the organization of work of the COP, the CMP and the subsidiary bodies. It seeks guidance on when the Ad Hoc Working Group on Long-term Cooperative Action under the Convention should report the results of its work to the COP, and how the COP might take action. The document also addresses possible arrangements for the participation of ministers and other heads of delegation in the high-level segment.

81. *Action*: The SBI will be invited to consider the possible elements for inclusion in the provisional agenda for COP 16 and provide advice to the secretariat thereon. The SBI may also wish to consider the proposals concerning the dates of the high-level segment and organization of the session, as contained in the document below, and provide further guidance.

82. *Background*: In accordance with Article 13, paragraph 6, of the Kyoto Protocol, ordinary sessions of the CMP shall be held in conjunction with ordinary sessions of the COP, unless otherwise decided by the CMP.

83. The document below includes a list of possible elements for a provisional agenda for CMP 6. It also contains suggestions and options concerning the organization of the work of the COP, the CMP and the subsidiary bodies. It seeks guidance on when the Ad Hoc Working Group on Further Commitments for Annex I Parties under the Kyoto Protocol should report the results of its work to the CMP, and how the CMP might take action. The document also addresses possible arrangements for the participation of ministers and other heads of delegation in the high-level segment.

84. *Action*: The SBI will be invited to consider the possible elements for inclusion in the provisional agenda for CMP 6 and provide advice to the secretariat thereon. The SBI may also wish to consider the proposals concerning the dates of the high-level segment and organization of the session, as contained in the document below, and provide further guidance.

(c) <u>Future sessional periods</u>

85. *Background*: Under this sub-item the SBI will consider:

- (a) Issues arising from the scheduling and organization of sessions for the second half of 2010;
- (b) The venue for COP 18 and CMP 8, which are scheduled to be held from 26 November to 7 December 2012;
- (c) Dates for the four sessional periods in 2014 and 2015.

86. The COP, by its decision 13/CP.15, recalled that COP 17 and CMP 7 shall be held in South Africa in 2011 and requested the Executive Secretary to continue consultations with the Government of South Africa.

87. By the same decision, the COP noted that in keeping with the principle of rotation among regional groups, and in light of recent consultations among the groups, the President of COP 18 would come from members of the Asian Group. It invited Parties to come forward in 2010 with offers to host COP 18 and CMP 8. To this end, the secretariat has received two offers to date from the Asian Group.

88. *Action*: The SBI may wish take note of any additional information relating to the intersessional period for the second half of 2010. It may wish to consider any offers to host future sessions of the COP and the CMP and to invite interested Parties to present offers as soon as possible. The SBI may also wish to consider the dates for the four sessional periods in 2014 and 2015 and recommend them for adoption by the COP at its sixteenth session.

(d) <u>Organization of the intergovernmental process</u>

89. *Background*: The May/June session of the SBI has traditionally provided Parties with an opportunity to consider how their intergovernmental process is functioning and to take decisions on relevant matters, including providing guidance to presiding officers and the secretariat. For example, the SBI at its thirtieth session provided guidance on the scheduling of future sessions, the timing of meetings and the timely translation of documents.³⁶

90. As a result of events at COP 15 and CMP 5, Parties will want to take stock of certain elements of the intergovernmental process, consider options for improvements and provide relevant guidance. Issues in question relate to methods of negotiation, transparency, inclusiveness and efficiency in negotiations, how to improve the engagement of ministers and political leaders, the role of the high-level segment and the roles and level of engagement of observer organizations in the process. In this context, the Bureau, at its first meeting in 2010, agreed on the importance of improving negotiation methods, while remaining
