# Progress report on the work of the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention

### Note by the secretariat

#### *Summary*

The first meeting of the reconstituted Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE) took place in Bonn, Germany, from 29 to 31 March 2010. The CGE discussed its work programme for 2010–2012, and the group's cooperation with other expert groups established under the Convention and with the National Communications Support Programme of the United Nations Development Programme, the United Nations Environment Programme and the Global Environment Facility. This report also summarizes discussions related to the organization of the work of the CGE.

# I. Introduction

### A. Mandate

- 1. The Conference of the Parties (COP), by its decision 5/CP.15, reconstituted the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE) for three years from 2010 to 2012 to improve the process of preparation of national communications from Parties not included in Annex I to the Convention (non-Annex I Parties).
- 2. In order to achieve this objective, the COP mandated the CGE to develop its work programme for 2010–2012 at its first meeting. The COP also requested the secretariat to facilitate the work of the CGE by organizing meetings and workshops and compiling reports of its meetings and workshops for consideration by the Subsidiary Body for Implementation (SBI).

### B. Scope of the note

3. This report of the proceedings of the first meeting of the reconstituted CGE includes a summary of discussions on the work programme of the CGE for 2010–2012, the CGE's cooperation with other expert groups established under the Convention and with the National Communications Support Programme (NCSP) of the United Nations Development Programme (UNDP), and the organization of its work.

### C. Possible action by the Subsidiary Body for Implementation

- 4. The SBI, after having considered this report, may wish to endorse the work programme of the CGE and provide further guidance to the CGE in the implementation of its mandate.
- 5. The SBI may also wish to invite Parties in a position to do so to provide financial assistance for the implementation of the work programme of the CGE, and invite multilateral and bilateral support programmes to collaborate with the CGE in the provision of technical support to non-Annex I Parties in preparing their national communications.
- 6. The SBI may wish to propose that the COP request the Global Environment Facility to continue to fund the NCSP beyond 2011 in order to ensure that technical support is provided, particularly for non-Annex I Parties that are preparing their third national communications.

# II. Proceedings of the meeting

- 7. The first meeting of the reconstituted CGE was held in Bonn, Germany, from 29 to 31 March 2010. The objectives of the meeting were, among others, to discuss and formulate the draft work programme of the CGE and discuss ways to cooperate with other expert groups under the Convention and with the NCSP, and to consider ways to organize its work.
- 8. Twenty-one members of the CGE (from Algeria, Angola, Antigua and Barbuda, Brazil, Canada, Chile, China, Denmark, the European Union, Guatemala, Ireland, Japan, Papua New Guinea, Sri Lanka, Swaziland, Switzerland, Thailand, Turkmenistan and the United Republic of Tanzania) attended the meeting, including two experts representing UNDP and the United Nations Environment Programme. Three members, including one representing an international organization, were not able to attend the meeting because of conflicting schedules.

- 9. The Executive Secretary of the UNFCCC, Mr. Yvo de Boer, delivered the opening remarks and stressed the critical role the CGE plays in responding to the mandate from the COP related to providing recommendations on possible elements of future revisions of the UNFCCC "Guidelines for the preparation of national communications from Parties not included in Annex I to the Convention". He also stressed that the work of the CGE in identifying technical problems and constraints affecting non-Annex I Parties in the process of preparing their national communications and assessing their capacity-building needs will provide useful insights in the development and implementation of measurement, reporting and verification as provided in decision 1/CP.13 (the Bali Action Plan).
- 10. The CGE elected Mr. Eric Kamoga Mugurusi (United Republic of Tanzania) and Mr. Vute Wangwacharakul (Thailand) as Chair and Rapporteur, respectively, for a one-year term. Mr. Mugurusi stressed the important role of the CGE in the provision of technical advice and support for the preparation of national communications from non-Annex I Parties.
- 11. The group discussed the draft rules of procedure based on the terms of reference contained in the annex to decision 3/CP.8 and the annex to decision 5/CP.15 and adopted them without amendments.

## **III. Discussions**

# A. Overview of the work of the Consultative Group of Experts from 2003 to 2007

- 12. The secretariat gave a presentation on the activities of the CGE undertaken during the period 2003–2007. Lessons learned from the work of the CGE during this period include the importance of enhancing the training agenda in terms of content, improving synergies with similar training initiatives and strengthening cooperation with the NCSP. The report on the outcomes of the stocktaking exercise for the period 2003–2007 is contained in document FCCC/SBI/2007/10/Add.1. Major outcomes and milestones in that period include:
  - (a) Regional hands-on training workshops conducted on greenhouse gas (GHG) inventories and vulnerability and adaptation assessments, and global workshops on mitigation assessments and exchange of experiences and good practices among non-Annex I Parties in preparing national communications, involving 325 experts from 125 non-Annex I Parties;
  - (b) Provision of reports to the SBI on the outcomes of the examination of 41 initial national communications;
  - (c) Provision of advice and 20 technical reports to the SBI;
  - (d) Development of a user manual for the guidelines on national communications from non-Annex I Parties;
  - (e) Development of training materials on national GHG inventories, vulnerability and adaptation assessments and mitigation.
- 13. Members of the CGE stated that the provision of practical technical advice and support to non-Annex I Parties that are in the process of preparing their national communications should continue to be the area of priority of the work of the group. The CGE highlighted the importance of involving regional and national experts and cooperating with other expert groups established under the Convention and with the NCSP in order to enhance the coordination of support to non-Annex I Parties. The group also took note of the fact that non-Annex I Parties are diverse in terms of level of expertise and stages of preparation of their national communications, with some Parties still preparing their initial national communications while others are working on their third and fourth national communications.

### B. The Consultative Group of Experts work programme

- 14. The draft work programme of the CGE, prepared by the secretariat on the basis of the mandate provided by the COP through its decision 5/CP.15, was presented to the CGE for its consideration. The CGE noted that the work of the group in the period 2003–2007, particularly the provision of technical assistance to developing country experts, provides a good basis for pursuing its current mandate. It also engaged in a constructive discussion to clarify the following aspects of its mandate:
  - (a) To provide technical assistance to non-Annex I Parties for the regular development of national GHG inventories, vulnerability and adaptation assessment, mitigation assessment, research and systematic observation, education, training and public awareness, technology transfer and capacity-building, with a view to improving the accuracy, consistency and transparency of information in their national communications;
  - (b) To provide recommendations, as appropriate, on elements to be considered in a future revision of the UNFCCC guidelines for the preparation of national communications from non-Annex I Parties, taking into account the difficulties they encountered in the preparation of their most recent national communications;
  - (c) To provide technical advice to non-Annex I Parties to facilitate the development and long-term sustainability of processes, and the establishment and maintenance of national technical teams, for the preparation of national communications, including GHG inventories, on a continuous basis;
  - (d) To provide technical advice and support to Parties, upon request, on the provision of information on steps to integrate climate change considerations into relevant social, economic and environmental policies and actions, in accordance with Article 4, paragraph 1(f), of the Convention;
  - (e) To provide non-Annex I Parties, upon request, with information on existing activities and programmes, including bilateral, regional and multilateral sources of financial and technical assistance, to facilitate and support the preparation of national communications by non-Annex I Parties;
  - (f) To provide technical support on issues mentioned in paragraph 14 (c) above, and, to the extent possible, paragraph 14 (a) above, including through workshops, hands-on training and training of trainers, building on experiences of Parties and/or lessons learned in the preparation of national communications, subject to the availability of resources.
- 15. The CGE stressed the need for the group to prioritize its work given the time constraints. It highlighted the need to provide technical assistance and support to non-Annex I Parties, in particular to the 15 non-Annex I Parties that have not yet submitted their initial national communications. The CGE also recognized the need to give equal priority to its work on providing recommendations to the SBI on the future revision of the UNFCCC guidelines for the preparation of national communications from non-Annex I Parties and on providing technical advice to non-Annex I Parties to facilitate the development and long-term sustainability of the processes and the establishment and maintenance of national technical teams for the preparation of national communications, including GHG inventories, on a continuous basis.
- 16. The CGE agreed that, as a first step towards achieving its mandate, it is essential to collect information on the difficulties, challenges, technical problems and constraints faced by non-Annex I Parties in preparing their national communications, in using the UNFCCC guidelines for the preparation of national communications from non-Annex I Parties and in sustaining the national communication process and maintaining national technical teams. In this regard, the group agreed to conduct surveys

and to analyse the information contained in the submitted second national communications as a means of gathering information from non-Annex I Parties. It also plans to collect information from multilateral and bilateral agencies and international organizations involved in supporting non-Annex I Parties in the preparation of their national communications. The group intends to gather data from June to September 2010 and to analyse them.

- 17. The CGE also agreed to provide practical technical advice and support to non-Annex I Parties, including through workshops, hands-on training and/or training of trainers, beginning in 2011, based on the results of the analysis. In preparing for these activities, the group plans to review and update the CGE training materials developed and used for the regional hands-on training workshops conducted from 2004 to 2007. The updating of the training materials will be guided by the results of the surveys and information provided by national experts on the methodological and technical gaps in preparing national communications.
- 18. As mandated by the COP, the CGE will prepare technical papers and reports containing recommendations to the SBI on the provision of technical assistance, support and advice to non-Annex I Parties, as well as on the future revision of the UNFCCC guidelines for the preparation of national communications from non-Annex I Parties. The group will make available to Parties, upon request, information on steps to integrate climate change considerations into relevant social, economic and environmental policies and actions, as well as information on existing activities and programmes, including bilateral, regional and multilateral sources of financial and technical assistance, to facilitate and support the preparation of national communications from non-Annex I Parties.
- 19. The draft work programme agreed upon by the CGE is contained in annex I to this report.

# C. Cooperation with other expert groups and the National Communications Support Programme

- 1. Cooperation with expert groups of the Convention
- 20. The CGE discussed ways to enhance coordination with the Expert Group on Technology Transfer (EGTT) and the Least Developed Countries Expert Group (LEG) in the implementation of its work programme. In the past, the CGE collaborated with the LEG in the development of a technical paper on the integration of information contained in national adaptation programmes of action into second and subsequent national communications. The CGE also collaborated with the EGTT in the preparation of a template on cross-cutting themes in national communications from non-Annex I Parties.<sup>2</sup>
- 21. The CGE agreed that cooperation with these expert groups should continue through possible collaboration in areas such as the Nairobi work programme on impacts, vulnerability and adaptation to climate change, improvement of tools and methodologies for preparing national communications and reporting of cross-cutting themes in national communications. The CGE had the benefit of information provided by an expert from the LEG and former experts of the EGTT, who are members of the group. Members proposed continuing the practice of exchanging information among expert groups on their work programmes.
  - 2. Cooperation with the National Communications Support Programme
- 22. The NCSP presented an overview of its past and current activities, and described its approach to providing technical support to non-Annex I Parties. It also presented the status of the preparation of national communications from non-Annex I Parties and its work plan for 2010, including training and workshops to be conducted. More than 50 countries are expected to complete the technical draft of their second national communications by the end of 2010. The NCSP has also started providing support to a

small number of non-Annex I Parties in the preparation of their third national communications. In this context, the NCSP noted that its mandate and resources are only to support non-Annex I Parties in preparing their second national communications, which will be completed in 2011. There is no provision for technical support for countries preparing their third national communications. The NCSP also outlined the constraints identified by non-Annex I Parties in preparing their national communications and the type of requests it has received for technical support, such as on downscaling climate models and the development of national emission factors.

- 23. The CGE reaffirmed the need to strengthen its communication with the NCSP in pursuit of greater cooperation and collaboration, in terms of collecting and assessing information on the status of preparation of national communications from non-Annex I Parties and in addressing the capacity-building needs of non-Annex I Parties. The group expressed its support for the continued participation of the Chair of the CGE in the Advisory Committee of the NCSP and for the continuation of the NCSP beyond 2011 to assist countries to prepare their third and subsequent national communications.
  - 3. Cooperation with initiatives to strengthen capacity to prepare greenhouse gas inventories
- 24. The secretariat presented details of its technical support for the preparation of GHG inventories, including regional capacity-building for establishing sustainable GHG inventory management systems in South-East Asian countries. This work has led to requests from non-Annex I Parties in other regions for technical assistance in strengthening their capacity to prepare GHG inventories. A CGE member from a Party included in Annex I to the Convention informed the group of the activities of the Intergovernmental Panel on Climate Change (IPCC) Task Force on National Greenhouse Gas Inventories (TFI), which include developing the software for the 2006 IPCC Guidelines for National Greenhouse Gas Inventories, enhancing the Emission Factor Database and other work to address technical issues relating to the preparation of GHG inventories.
- 25. The CGE has maintained close interaction with the IPCC, particularly in the field of preparation of GHG inventories, inter alia through participation of the IPCC TFI in the work of the CGE. Some members raised the issue of the need to strengthen further the capacity of non-Annex I Parties to develop their own emission factors and proposed extending the capacity-building for establishing sustainable GHG management systems beyond South-East Asia. The group also reaffirmed its continued collaboration with international organizations in strengthening the development of tools and methodologies and in enhancing support to developing countries in preparing GHG inventories.

# D. Organization of the work

- 26. Given the number of activities expected to be undertaken by the CGE to fulfil its mandate, the group considered it important to identify the areas of expertise of its members so as to better organize and conduct its work. Key areas of expertise were identified based on the content of the national communications from non-Annex I Parties, namely, national GHG inventories, vulnerability and adaptation assessment, mitigation and other issues.<sup>3</sup> Since some members were not present during the meeting and hence unable to indicate their areas of expertise, it was agreed that discussion on the role of its members based on their identified areas of expertise would continue through CGE Quickplace, a web-based discussion forum established to facilitate communication between the members. Annex II to this report contains the list of areas of expertise of the members.
- 27. The group acknowledged the need to develop a detailed work plan for 2010 in order to undertake the activities listed in its work programme. It was agreed that the discussion on this matter would be

continued through CGE Quickplace. The secretariat, in consultation with the Chair, will facilitate work in this area.

# E. Any other business

28. The next meeting of the CGE is tentatively scheduled for early September 2010, with the date and venue to be determined by the Chair in consultation with the members and the secretariat.
