**AWG-LCA 15-2**

**Draft Decision - 3bi**

**Measurable, reportable and verifiable nationally appropriate mitigation commitments or actions, including quantified emission limitation and reduction objectives, by all developed country Parties, while ensuring the comparability of efforts among them, taking into account differences in their national circumstances**

*The Conference of the Parties,*

*Recalls* that deep cuts in global green house gas emission are required and closing the ambition gap is a matter of urgency;

*Recalls* the quantified emission reduction targets contained in document FCCC/SB/2011/INF.1/Rev.1;

*Urges* developed country Parties to increase their targets as a matter of urgency;

*Notes* that many developed Parties have indicated their willingness to increase ambition in the context of efforts of other Parties and / or a comprehensive global agreement;

1. *Requests* the secretariat to update the technical paper on developed Parties' pledges with the information provided by Parties through the workshops and submissions
2. *Decides* to launch a work programme under SBSTA to further clarify developed Parties' quantified economy-wide emission reduction targets contained in document FCCC/SB/2011/INF.1/Rev.1, including through focused expert meetings, technical briefings, and submissions,
  - a) to clarify the assumptions and conditions related to individual targets related to the elements in paragraph 5 of 2/CP.17, particularly in relation to
    - i. the role of land use, land use change and forestry, and carbon credits from market-based mechanism;
    - ii. associated assumptions and conditions related to the ambition of the pledges;
  - b) to elaborate rigorous, robust and transparent approaches to measure progress towards achieving targets in a systematic manner in order to ensure comparability;
3. *Decides* that the work programme should start in 2013 and be finalized in 2014;
4. *Requests* developed Parties to submit relevant information related to the process outlined above;
5. *Decides* that the outcomes of the work programme should be presented to the COP, including to inform the 2013-15 review process.

**Draft Decision - 3bii****Nationally appropriate mitigation actions by developing country Parties in the context of sustainable development, supported and enabled by technology, financing and capacity-building, in a measurable, reportable and verifiable manner**

*The Conference of the Parties,*

*Recalls* that deep cuts in global green house gas emission are required and closing the ambition gap is a matter of urgency;

*Recalls* the nationally appropriate mitigation actions contained in document FCCC/AWGLCA/2011/INF.1;

*Urges* developing country Parties, particularly who have not yet done so, to submit further NAMAs to be included in document FCCC/AWGLCA/2011/INF.1;

*Notes* that many developing country Parties have indicated the need for support to implement the NAMAs;

1. *Requests* the secretariat to compile in a technical paper the information provided by Parties through the workshops and submissions;
2. *Decides* to launch a work programme under SBSTA to further enhance understanding on the diversity of nationally appropriate mitigation actions by developing country Parties as communicated and contained in document FCCC/AWGLCA/2011/INF.1, to clarify the underlying assumptions and methodologies, related to the elements in para 34 of 2/CP.17
3. *Decides* that the work programme should include focused interactive discussions and technical work including through expert meetings, technical briefings, submissions, and knowledge sharing, *inter alia* on
  - a) underlying assumptions and methodologies, including exploring approaches and tools to estimate baselines of mitigation actions, and to estimated mitigation outcomes
  - b) support needs for implementation, including exploring technical and financial support needs in preparing, piloting, and implementing NAMAs;
4. *Decides* that the work programme should start in 2013 and be finalised in 2014;
5. *Invites* developing country Parties to submit, subject to availability, information related to the process outlined above;
6. *Decides* that the outcomes of the work programme should be presented to the COP, including to inform the 2013-15 review process.
