## Status report of the annual inventory of Malta

1. This status report was prepared by the secretariat pursuant to decision 13/CP.20, as part of the initial assessment of Malta's 2015 annual inventory, submitted in accordance with decision 24/CP.19. It reflects the content of the inventory submission of 2015 as originally submitted by the Party.
