## I. Opening of the session

(Agenda item 1)

1. The first session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement (CMA), convened pursuant Article 16, paragraph 6, of the Paris Agreement, was opened in Bab Ighli, Marrakech, Morocco, on 15 November 2016 by Mr. Salaheddine Mezouar, President of CMA 1.

## A. Adoption of the agenda

2. At its 5<sup>th</sup> meeting, on 16 November, the CMA considered a note by the Executive Secretary, Ms. Patricia Espinosa, containing the provisional agenda and annotations.<sup>1</sup> The provisional agenda was prepared in agreement with Ms. Ségolène Royal (France), President

of Conference of the Parties (COP) at its twenty-first session and the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP) at its eleventh session, after consultations with the Bureau of the COP.

Any other matter concerning the implementation of the Paris Agreement could also be addressed by the CMA under this agenda item, as decided by the CMA. Further details on these mandates are included in the annotations to the provisional agenda in chapter III.

#### **D.** Organization of work

4. At its 5<sup>th</sup> meeting, on 16 November, the President referred the CMA to the annotations to the provisional agenda. He noted that he had, under his own authority, convened open-ended, informal consultations with all Parties on preparations for the first session of the CMA, as well as on agenda item 4 of the COP 22 agenda, "Preparations for the entry into force of the Paris Agreement and the first session of the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement". He also noted that these consultations were being guided by the principles of openness, transparency and inclusiveness. He proposed to undertake consultations, under the CMA, to ensure that the outcomes of these matters were ready for consideration and adoption by the CMA before the end of its first session.

5. The President also noted that the Ad Hoc Working Group on the Paris Agreement (APA) had forwarded a draft decision to the COP on the rules of the procedure for the CMA. Once the COP has considered and adopted this decision, it would be proposed to the CMA for its consideration and adoption.

6. Following a proposal by the President, Parties agreed to proceed on this basis.

7. At the same meeting, statements were made by representatives of Thailand (on behalf of the Group of 77 and China), Slovakia (on behalf of the European Union and its 28 member States), Australia (on behalf of the Umbrella Group), the Plurinational State of Bolivia (on behalf of the Like-Minded Developing Countries on Climate Change), Saudi Arabia (on behalf of the Arab Group), Mexico (on behalf of the Environmental Integrity Group), Maldives (on behalf of the Alliance of Small Island States), Costa Rica (on behalf of the Independent Association for Latin America and the Caribbean), the Democratic Republic of the Congo (on behalf of the least developed countries) and Mali (on behalf of the African Group).

#### E. Status of ratification of the Paris Agreement

8. At its 5<sup>th</sup> meeting, on 16 November, the CMA considered the status report presented by the Executive Secretary on the instruments of acceptance of the Paris Agreement received by the Depositary.

9. The Executive Secretary reported that on 4 November 2016 the Paris Agreement entered into force. As at 16 November 2016, 110 Parties to the Convention deposited their instruments of ratification, acceptance or approval of the Paris Agreement, representing more than half of the Parties to the Convention, and 193 Parties had signed the Paris Agreement. The near universal signing of the Paris Agreement, as well as the daily ratifications, demonstrates the global momentum and ambition on climate action.
