I. Opening of the session

(Agenda item 1)

1. The twelfth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol (CMP), convened pursuant to Article 13, paragraph 6, of the Kyoto Protocol, was opened in Bab Ighli, Marrakech, Morocco, on 7 November 2016 by Mr. Salaheddine Mezouar, President of CMP 12.¹

A. Adoption of the agenda

2. At its 1st meeting,² on 7 November, the CMP considered a note by the Executive Secretary containing the provisional agenda and annotations (FCCC/KP/CMP/2016/1). The provisional agenda was prepared in agreement with the President of CMP 11, after consultation with the Bureau of the CMP.
