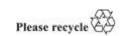

Summary

This analytical paper, prepared by the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE), contains an analysis of recent developments in reporting requirements and constraints, challenges and lessons learned by Parties not included in Annex I to the Convention (non-Annex I Parties) in preparing their national communications. The document is based on an analysis of the inputs provided by non-Annex I Parties through a survey conducted by the CGE between September 2015 and January 2016, and other relevant reports prepared by the CGE since 2011, including workshop reports and technical reports. The document contains the recommendations of the CGE on elements to be considered in a future revision of the "Guidelines for the preparation of national communications from Parties not included in Annex I to the Convention".

I. Introduction

A. Mandate

- 1. The Conference of the Parties (COP), by decision 19/CP.19, decided to continue the Consultative Group of Experts on National Communications from Parties not included in Annex I to the Convention (CGE) for a period of five years, from 2014 to 2018.
- 2. The terms of reference of the CGE¹ specify that it shall provide recommendations, as appropriate, on elements to be considered in a future revision of the guidelines for the preparation of national communications and biennial update reports (BURs) from Parties not included in Annex I to the Convention (non-Annex I Parties), taking into account the difficulties encountered by non-Annex I Parties in the preparation of their national communications and BURs.
- 3. The CGE, in response to this mandate, agreed to prepare, as a part of its work programme for 2016, an analytical paper compiling and synthesizing available information on the problems, constraints, lessons learned and best practices in the process of and the preparation of national communications by non-Annex I Parties.
- 4. The CGE also agreed to conduct a survey to gather more up-to-date feedback from non-Annex I Parties, as well as multilateral agencies involved in the process of and the preparation of national communications, with a view to complementing the compiled and synthesized information.

B. Scope of the note

- 5. The analytical paper analyses and synthesizes the past CGE reports on challenges and lessons learned and best practices in applying the "Guidelines for the preparation of national communications from Parties not included in Annex I to the Convention",² the feedback from non-Annex I Parties on their experiences, challenges faced and suggestions for improvements in using those guidelines,³ as well as from multilateral agencies involved in the process of and the preparation of national communications, and the reports of CGE training workshops on the preparation of national communications and BURs.
- 6. This paper contains the recommendations of the CGE on elements to be considered in a future revision of the UNFCCC guidelines for the preparation of national communications from non-Annex I Parties.

C. Possible action by the Subsidiary Body for Implementation

7. The Subsidiary Body for Implementation, having considered this report, may wish to provide further guidance to the CGE on the implementation of its mandate relating to paragraph 2(d) of its terms of reference⁴ on the provision of recommendations, as appropriate, on elements to be considered in a future revision of the UNFCCC guidelines for the preparation of national communications from non-Annex I Parties, taking into account the difficulties encountered by non-Annex I Parties in the preparation of their most recent national communications.

II. Context

A. Recent developments

- 8. In accordance with Article 4, paragraph 1, and Article 12, paragraphs 1 and 5, of the Convention, each non-Annex I Party shall make its initial communication within three years of the entry into force of the Convention for that Party, or of the availability of financial resources in accordance with Article 4, paragraph 3. Parties that are least developed countries may make their initial communication at their discretion. The communication shall include information on anthropogenic emissions by sources and removals by sinks of all greenhouse gases (GHGs) not controlled by the Montreal Protocol, steps taken or envisaged by the Party to implement the Convention and any other information that the Party considers relevant to the achievement of the objective of the Convention and suitable for inclusion in its communication, including, if feasible, material relevant for the calculation of global emission trends.
- 9. Further, with a view to enhancing reporting in national communications, COP 16 decided that non-Annex I Parties should submit their national communications every four years or in accordance with any further decisions on frequency by the COP, taking into account a differentiated timetable and the prompt provision of financial resources to cover the agreed full costs incurred by non-Annex I Parties in preparing their national communications.⁵
- 10. Non-Annex I Parties prepare their national communications following the guidelines contained in decision 17/CP.8 and its annex.
- 11. COP 16 also decided that developing countries, consistent with their capabilities and the level of support provided for reporting, should also submit BURs⁶ as an update⁷ to the most recently submitted national communication. COP 17 adopted the "UNFCCC biennial update reporting guidelines for Parties not included in Annex I to the Convention".⁸
- 12. Further, COP 21 adopted the Paris Agreement. Article 13 of the Paris Agreement established an enhanced transparency framework for action and support with built-in flexibility which takes into account Parties' different capacities and builds upon collective experience. The modalities, procedures and guidelines of this transparency framework shall build upon and eventually supersede the measurement, reporting and verification system established by decision 1/CP.16, paragraphs 40–47 and 60–64, and decision 2/CP.17, paragraphs 12–62, immediately following the submission of the final biennial reports and BURs.⁹

B. Experiences in using the existing guidelines for the preparation of national communications

13. In 2014, the CGE prepared a technical report¹⁰ on problems and constraints, as well as lessons learned and best practices, in the process of and the preparation of national communications and BURs by non-Annex I Parties.

- 14. The CGE, with support from the secretariat, conducted an online survey, from 7 September 2015 to 26 January 2016, seeking to identify challenges and improvements in the elements of the guidelines for the preparation of national communications from non-Annex I Parties. A total of 42 respondents from 28 non-Annex I Parties and one multilateral agency responded to the survey. The non-Annex I Party respondents comprised 20 from African States, 3 from Asia-Pacific States, 4 from Latin American and Caribbean States, 1 from Eastern European States, 5 additional respondents who did not provide information on their country representation and 4 respondents who provided more than one response.
- 15. The survey results reconfirmed most of the challenges identified in the technical report referred to in paragraph 13 above.
- 16. In general, while acknowledging the different national circumstances and capacities of non-Annex I Parties, there appears to be some commonly encountered challenges in using the guidelines for the preparation of national communications, such as:
- (a) Understanding the level and format of information to be reported across different areas covered in the national communications;
- (b) A lack of specificity in some areas, for example on what exactly needs to be reported on national circumstances and institutional arrangements. In that regard, the templates for documenting the institutional arrangements disseminated by the CGE were noted to be a very helpful tool by many participants of the 2016 workshops on the building of sustainable national greenhouse gas inventory management systems, and the use of the 2006 Intergovernmental Panel on Climate Change (IPCC) Guidelines for National Greenhouse Gas Inventories organized by the secretariat in collaboration with the IPCC and the CGE:
- (c) Choice and use of *IPCC Guidelines for National Greenhouse Gas Inventories* many experts from non-Annex I Parties have expressed confusion on which guidelines should be used for their national GHG inventories;
- (d) Reconciling the preparation of national communications with other information being prepared and submitted, for example on national adaptation plans, nationally appropriate mitigation actions, intended nationally determined contributions and technology needs assessments.
- 17. The hands-on regional training workshops on BURs¹¹ conducted by the CGE in 2016 further substantiated the observations mentioned in paragraph 16 above. In addition to capacity and data constraints, the participants have highlighted the following issues: the need for reporting templates, harmonization between the information reported on the intended nationally determined contributions, and the mitigation actions and their effects reported in the BURs. They also emphasized the benefits of undertaking work on the preparation of national communications and BURs on a continuous basis.

III. Recommendations

18. The CGE decided at its 17th meeting, taking into account the recent developments with regard to reporting from non-Annex I Parties and the CGE survey results, as well as the lessons learned by non-Annex I Parties in applying the guidelines for the preparation of their national communications, to develop recommendations on elements to be considered in a future revision of the "Guidelines for the preparation of national communications from non-Annex I Parties". The recommendations are contained in the annex.
