PRELIMINARY INFORMATION FOR PARTICIPANTS AT THE FIRST SESSION OF THE CONFERENCE OF THE PARTIES

The first session of the Conference of the Parties will be held from 28 March to 7 April 1995 at Berlin, Germany. The present document contains some general information that may be helpful for participants both when making their arrangements to attend the Conference and during COP 1.

The first session of the Conference of the Parties (COP 1) to the United Nations Framework Convention on Climate Change will be convened by the head of the interim secretariat of the Convention and hosted by the Government of the Federal Republic of Germany in accordance with Article 7.4 of the Convention and General Assembly resolutions 48/189 of 21 December 1993 and 49/120 of 19 December 1994. It will be organized in two segments, one at the level of senior officials (28 March - 4 April 1995) and one at ministerial level (5 - 7 April 1995).

1. <u>Venue of the meeting</u>

The Conference will take place at the International Congress Centre (ICC) Berlin:

The Conference will be opened on Tuesday, 28 March 1995 at 10.00 a.m. in the ICC Plenary Hall. This room will be the venue for all plenary meetings. In addition to the Plenary Hall, other meeting rooms will be available for two concurrent meetings with interpretation during normal working hours. There will also be some facilities for informal meetings without interpretation.

3. <u>National Organization Committee</u>

4. <u>Hotel accommodation</u>

Each delegation is requested to arrange its own hotel accommodation. The National Organization Committee has made provisional bookings at a number of hotels in Berlin at different locations and with different price ranges. If required, reservations for hotel rooms can be arranged by:

which will inform participants of the conditions and procedures as necessary.

Please note that in order to secure hotel accommodation through this channel, reservations must be made <u>by 20 January 1995</u>, at the latest.

5. <u>Accreditation</u>

The credentials of representatives of Parties and the names of alternate representatives and advisers must be issued either by the head of State or Government or by the Minister of Foreign Affairs. To ensure full participation in the work of the Conference, it is recommended that representatives of Parties be provided with full powers to participate in the session, and, if necessary, to serve as officers of COP 1 and any sessional committees or working groups, as well as officers of the subsidiary bodies established by the Convention.

Credentials must be submitted to the interim secretariat of the Convention. The Bureau of COP 1 will examine the credentials and report to the session.

6. <u>Immigration formalities</u>

The Federal Government will ensure that immigration formalities are facilitated. Nevertheless, all participants at the Conference are requested to check whether they require a visa.

Should a visa be required, applications may be submitted, with reference to the Conference, to the nearest German diplomatic representation.

7. <u>Customs regulations</u>

Information on customs regulations in Germany may be obtained from any German diplomatic representation.

8. <u>Berlin airports</u>

Berlin has three international airports: Tegel, Tempelhof and Schönefeld.

9. <u>Transport</u>

Delegations are requested to organize their own transport in Berlin. Berlin has a wide public transport network which will be available <u>free of charge</u> to all delegates throughout the Conference upon presentation of their official badge.

In addition, shuttle buses will be available in the mornings and evenings between the conference centre (ICC) and the main hotels lodging the delegates (in the city centre).

10. Additional services for participants at the conference centre (ICC)

The conference centre has a post office, banking facilities, a travel agency, a Lufthansa check-in desk, restaurants and medical services.

Office space is available subject to the following conditions:

Three sizes are available: 23 sq m, 37 sq m and 52 sq m with the additional possibility of combining different sizes.

The price per square metre amounts to DM 547,-- for the duration of the conference.

The offices are equipped with office furniture, lighting, electricity supply, ventilation and heating.

Telephone and fax machines may be ordered and rented separately from the National Organization Committee. Delegations are kindly requested to organize any other technical equipment themselves.

In order to ensure that for the required office space will be provided, delegations are kindly requested to inform the National Organization Committee of their needs by 10 February 1995, at the latest.

Delegations that do not need offices may, upon payment, make use of the services available at the conference centre (secretaries, telephones, fax machines, personal computers, photocopying machines).

(b) Offices for non-governmental organizations

12. General information on Berlin

Climate: Continental climate with changeable weather, cool with an average temperature of 8° to 13° Celsius during the day. The highest observed maximum has been 23° Celsius, the lowest observed maximum 4° Celsius. Periods of rain and possibly light snow likely on some 6 days out of the 11 days of the Conference.

Electricity: 220 Volt, 50 Hertz.

Local currency: Deutsche mark (Exchange rate of US\$1 = DM1.56 at 15 December 1994).
