High-Level Segment and Ministerial Round Tables

The High-level segment will begin at 10 a.m. on Wednesday, 30 October with statements from Heads of United Nations agencies and intergovernmental and non-governmental organizations. A Youth Charter will be presented to the President of COP 8, His Excellency Mr. T.R. Baalu. The inauguration of the High-level segment, with the participation of His Excellency Mr. Atal Bihari Vajpayee, Prime Minister of India, will begin at 11.30 a.m. Access to the plenary will be limited after 11.15 a.m. For security reasons, cell phones will be jammed.

Ministerial round tables will begin in the afternoon of Wednesday, 30 October and conclude in the afternoon of Thursday, 31 October. The round tables will be open to all ministers and heads of delegation and each delegation will have two seats. The general theme of the round tables will be implementation of the Convention and the Kyoto Protocol. The first round table, "Taking Stock", will be held from 3 p.m. to 6 p.m. on 30 October. The second, "Climate Change and Sustainable Development", will be held on 31 October from 10 a.m. to 1 p.m. The third, "Wrap Up", will be held from 3 p.m. to 6 p.m.

Due to time constraints, ministers may wish to reflect upon which of the three round tables would be most appropriate for their intervention. To facilitate this informal exchange, ministers and heads of delegations are invited to provide short and focused commentaries. The President has requested that speakers leave prepared statements "in their pockets".

His Excellency Mr. Mohammed Valli Moosa, Minister of Environmental Affairs and Tourism (South Africa), and Her Excellency Ms. Margaret Beckett, Secretary of State for Environment, Food and Rural Affairs (United Kingdom) will assist the President by co-chairing the first and second round-table sessions.
