

High Integrity Carbon Markets

High-integrity carbon markets must be consistent with ambitious, science-aligned emissions pathways to achieve net-zero emissions by 2050.

✓ Supply-Side Integrity:

MRV + high environmental integrity

✓ Demand-Side Integrity:

The use and disclosure of credits must align with net-zero emissions by 2050

✓ Market Integrity:

Transparent information and public tracking for carbon credits.

The A6IP Center has a global remit to promote these principles through capacity-building

helping to develop the know-how, institutional arrangements, and international links needed to leverage Article 6.

The A6IP Center was established on **April 27**, **2023**, to serve as the secretariat of A6IP and promote its activities.


The Ministry of Environment, Japan, assigned the Institute for Global Environmental Strategies (IGES) to manage the A6IP Center.



- > Thus far, seven (7) in-country capacity-building workshops have been conducted.



A6IP Center provides capacity-building tools on authorization, tracking, and reporting to support partner countries in understanding the rulebook and its application.






Dissemination of Trainings/CB Events on A6IP website
