

#### 2.1 National Communications

National Communication	Article 4 of the Convention Article 2 of the Convention Decision 17/CP.8 Decision 1/CP.16	Every 4 years	Submission Portal

#### **National Communications**

- ✓ Non-Annex I Parties should submit their national communications every four years or in accordance with any further decisions on frequency by the COP, taking into account a differentiated timetable and the prompt provision of financial resources to cover the agreed full costs incurred by Non-Annex I Parties in preparing their national communications.
- ✓ Non- Annex I Parties should submit their National Communication in one of the official UN languages. Parties who submit their National Communication in a language other than English should include an executive summary translated to English.
- ✓ Non-Annex I Parties are also encouraged to submit, to the extent possible and where relevant, English translations of their communications.

## 2.2 Biennial Update Reports

Submission	Mandate	Frequency	Submission Tool
Biennial Update	Decision 1/CP.16	Every 2 years.	Submission Portal
Report	Decision 2/CP.17	Least developed country Parties and small island developing States may submit biennial update reports at their discretion.	

## **Biennial Update Reports**

- ✓ Non- Annex I Parties should submit their Biennial Update Report in one of the official UN languages. Parties who submit their Biennial Update Report in a language other than English are also encouraged to submit a English translation.
- ✓ Non-Annex I Parties can submit the Biennial Update Report either as a summary of parts of their national communication in the year in which the national communication is submitted or as a stand-alone update report.

## 3. SUBMISSION TOOLS

## **National Report Submission Portal**

The National Report Submission Portal (herein referred to as submission portal) is a simple and userfriendly web-based system which allows Parties to upload their official submissions of:

- **National Communications**
- **Biennial Update Reports**



# Need access to the Submission Portal?

- ☐ The access to submission portal is **granted to maximum of two users per Party**.
- ☑ The user must be **nominated by the National Focal Point (NFP)** to submit the report on behalf of the Party. The request should be sent to secretariat via email to Reporting-NAI@unfccc.int.
- ☑ In order to access the submission portal, the user must first have an UNFCCC user account. If the user already has an UNFCCC user account for other applications such as Roster of Experts, MA Portal, BR-CTF, Virtual Team Rooms, NAMA Registry:
  - then the secretariat will provide access rights to the requested user and notify the user via email.
  - but has forgotten the username and/or password, then the user should send an email to tools.support@unfccc.int indicating the issue that the user is facing with relevant information.
- ☑ If a Party wish to replace the previous users, the **NFP should send email to the secretariat** via Reporting-NAI@unfccc.int indicating which of the two existing accounts shall be replaced. The request should include: first name, last name and email address.

## 4. WHERE TO FIND THE SUBMITTED REPORTS?

- All official reports submitted by Parties (including National Communication and Biennial Update Report) are posted on the secretariat website after validation. The additional files (such as confidential information, cover letters) submitted along with the official reports are not published but are stored in the record management system of the secretariat (official repository).
- Moreover, the National Communication and Biennial Update Report that are submitted using the submission portal are also posted on the submission microsite. The reports submitted using the submission portal and marked as "Published" in the submission portal are available automatically in the submission microsite.
