Bonn climate change conference (17-27 June 2019)

- 50th session of SBI and the SBSTA
- Advance work on issues to facilitate implementation of the UNFCCC and the Paris Agreement (Article 6, reporting tables related to the transparency framework)
- Some items related to technology (Poznan strategic programme)
- Many meetings and events of relevance to the TEC (TEM-M, TEC/WIM dialogue on coastal technologies)



Poznan strategic programme on technology transfer

- SBI considered two reports:
 - a) GEF progress report on the Poznan strategic programme on technology transfer
 - b) TEC updated evaluation report of the Poznan strategic programme
- The SBI noted the information ... on the collaboration between the GEF focal points and NDEs for technology development and transfer ... and encouraged strengthened collaboration so as to enhance coherence between the support provided by the GEF and that provided by the CTCN for technology transfer activities. It also encouraged the GEF and the CTCN to facilitate the collaboration, as appropriate.
- It welcomed the information on the experience and lessons learned identified in the PSP evaluation report and encouraged relevant stakeholders to consider best practices and lessons learned, including challenges, regarding each regional centre.



Poznan strategic programme on technology transfer

- The SBI invited the CTCN and the TEC to include in their joint annual report for 2019 information on how they will address the key messages and relevant recommendations contained in the TEC updated evaluation report of the PSP.
- The SBI agreed to continue to consider the recommendations contained in the PSP evaluation report at SBI 51 (December 2019).
- The SBI requested the secretariat to prepare an updated synthesis report on technology needs assessments (TNAs), including the TNAs and technology action plans of Parties that participated in phase II of the global TNA project and taking into account the terminal evaluation of phase I and phase II of the project, for consideration at SBI 52 (June 2020).
