### Joint annual report of the TEC and CTCN for 2023

- The COP/CMA welcomed the annual report of the TEC and CTCN and progress of implementation of the joint work programme of the Technology Mechanism for 2023–2027 and welcomed the enhanced coordination between TEC and CTCN
- Invited TEC and CTCN to continue efforts on systematic feedback on their work
- Welcomed the engagement with the NDEs
- Noted the Technology Mechanism Initiative on AI
- Encourages TEC and the CTCN to continue collaborating with the operating entities of the Financial Mechanism and relevant financial institutions with a view to enhancing the capacity of developing countries
- Commended TEC and CTCN on gender mainstreaming in its JWP
- Noted with appreciation reporting on action taken in response to mandates



### Linkages between the Technology Mechanism and Financial Mechanism

- Invited submission on views on maintaining and enhancing collaboration and cooperation between the Technology Mechanism and the Financial Mechanism, including on linkages between the Mechanisms
- Synthesis report prepared by the secretariat.
  - Total of 11 Parties, on behalf of 169 Parties made submission.
  - 6 other stakeholders also made submission
- Requested the TEC and CTCN, in consultation with the Chair of the SBI, to organize an in-session workshop SBI 60.
- SBI 60 to initiate discussion



## Overview of the GST outcome

### GST Decision text 1/CMA 5

#### Collective progress and informing action and support



**Mitigation:** Keep 1.5° in reach, Urgent deep GHG emissions reduction, Transitioning away from fossil fuels, Tripling renewable energy, doubling energy efficiency, Encourage economy wide NDCs



**Adaptation:** Incremental, multisectoral and transformational actions, universal Early Warning Systems, adaptation targets to reach global goal on adaptation, Enhance national adaptation plans and adaptation communications



**MOI:** Scaling up mobilization, \$100bn commitment, doubling adaptation finance, support NCQG, Technology Implementation Programme, Capacity building support



Avert and minimize **loss and damage**, Data management



Advances **Just transition and consideration of response measures**

### Technology in the GST

#### - Established the Technology Implementation Programme

Decision 1/CMA.5 on the outcome of the first GST, para 110, established a technology implementation programme (TIP):

- Supported by, inter alia, the operating entities of the Financial Mechanism
- To strengthen support for the implementation of technology priorities identified by developing countries
- To address challenges identified in the first periodic assessment of the Technology Mechanism
- The TIP will for the first time be discussed at SBI 61 under the PSP item
