Background

- **Joint activities of the TEC and CTCN for 2022 - 2023**
 - Initial discussion on potential future joint activities held at the virtual joint TEC-CTCN AB session on 13 September 2021
 - Joint task force mandated to work inter-sessionally to further work on identifying potential new joint activities and prepare a proposal for consideration at the next joint session
 - Joint taskforce met in early 2022 virtually and considered activities that could be undertaken jointly and initiated discussion on the potential of developing a joint work programme for the Technology Mechanism
 - UNFCCC and CTCN Secretariats tasked with preparing a comparison of TEC rolling workplan and CTCN PoW

➤ Technology and gender (activity 3)

- Collect evidence of the benefits of developing **gender-responsive climate technologies**
- Case studies on **local and indigenous knowledge and practices**
- Include these in the update of the joint technology and NDC publication for 2023.

Annex 1 – Proposed new joint activities 2022-2023

➤ Technology and NDCs

- Prepare **guidelines for developing Technology Roadmaps (TRMs)**
- Regularly **update the joint publication** on technology and NDCs
- **Disseminate and raise awareness** of the joint publication

Annex 1 – Proposed new joint activities 2022-2023

➤ **Monitoring and Evaluation – Joint NDE Survey**

- **Joint analysis on the implementation of the biannual survey**
- **Jointly develop and disseminate the second joint NDE survey in the first quarter of 2022**

Annex 1 – Proposed new joint activities 2022-2023

➤ **Communication and Outreach**

- **Promote joint activities and invite contributions from TEC members** in the CTCN's quarterly newsletter
- Joint messaging on the **strategic added-value of the Technology Mechanism**
- Joint outreach during COP27 and the NDE Regional Forums

Annex 1 – Proposed new joint activities 2022-2023

- **Enhancing systematic feedback between the two bodies**
 - Utilize the **joint TEC/CTCN AB sessions** to strengthen the mutual feedback
 - **Dedicated session** in the year between the TEC and CTCN AB
 - Consider establishing **sub-groups within the joint task force** to develop collaborative work

Annex 1 – Proposed new joint activities 2022-2023

- **Development of an overarching work programme for the Technology Mechanism**
 - **Conduct a comparative analysis of the TEC rolling workplan & the CTCN Programme of Work**
 - **Identify gaps, complementarities and synergies** that can be built upon
 - **Identify impactful activity(ies)**

Annex 2 – Summary of views of the joint task force on elements of a Technology Mechanism work programme

- **Purpose:**
 - to focus efforts on defined programme areas, while allowing for joint or separate activities
 - to ensure implementation of all Technology Framework mandates

- **Format:**
 - a single TM work programme with flexibility for respective annual work plans
 - a chapter that links the TEC rolling work plan and CTCN PoW

- **Implementation period:** five-year period 2023-2027

➤ **Overarching theme:**

- “Accelerating Climate Action through Technology”
- “Accelerating Climate Action through Technology Development and Transfer

➤ **Structure / key themes:**

- limited set of focus areas
- alignment with the key themes of the Technology Framework

➤ **Timeline for developing the work programme:**

- at TEC 25 and CTCN AB 20 (autumn 2022) or in the Spring of 2023
- alignment with the timeline of development of the CTCN’s third PoW

Annex 3 – Comparison of TEC rolling workplan and CTCN Programme of Work

- Both incorporate the 5 key themes of the Technology Framework
- Both describe the types of services/activities to be undertaken
- TEC WP: **more concise working document that is updated yearly**; lists activities and deliverables by year over 4 years; no information on budget for activities.
- CTCN PoW: **more general strategy document**; complemented by AOPs that contain details of activities and outputs and detailed annual budgets.
- TEC and CTCN activities provide complementarities across the 5 themes of the Technology Framework

- TEC and CTCN AB are invited to consider the proposal and provide guidance, taking into consideration possible resource implications for implementing the new activities
- Joint TEC-CTCN task force to work inter-sessionally to finalize the new joint activities of the TEC and the CTCN
