PROCEDIMIENTOS FINANCIEROS

Escalas indicativas de cuotas para el presupuesto administrativo
de la Convención correspondiente a 1996 y 1997

1. En su 11º período de sesiones, el Comité Intergubernamental de Negociación de una Convención Marco sobre el Cambio Climático recomendó que la Conferencia de las Partes aprobara, en su primer período de sesiones, un conjunto de procedimientos financieros para la Conferencia de las Partes en la Convención Marco de las Naciones Unidas sobre el Cambio Climático, sus órganos subsidiarios y su secretaría permanente (A/AC.237/91/Add.1, conclusión k)). Entre los procedimientos recomendados figura la siguiente disposición relativa a las cuotas para el presupuesto administrativo de la Convención:

"7. Los recursos de la Conferencia de las Partes comprenderán:

a) Las cuotas que paguen cada año las Partes conforme a la escala indicativa aprobada por consenso por la Conferencia de las Partes sobre la base de las escalas de cuotas de las Naciones Unidas que la Asamblea General apruebe en su oportunidad, ajustada de manera de asegurar que ninguna Parte contribuya menos del 0,01% del total; que ninguna contribución rebase del 25% del total y que ninguna contribución de una Parte que sea país menos desarrollado rebase del 0,01% del total;"

2. En el anexo al presente documento figuran dos cuadros (en inglés únicamente) en los que se presentan las escalas indicativas de cuotas para 1996 y 1997, en consonancia con los criterios antes señalados. Esas escalas han sido elaboradas sobre la base de las escalas de cuotas de las Naciones Unidas para 1996 y 1997, aprobadas por la Asamblea General en su 49º período de sesiones, así como de la información existente al 28 de febrero de 1995 sobre la situación en materia de ratificación de la Convención.

3. La Conferencia tal vez desee aprobar las escalas indicativas que figuran en el anexo, en relación con el párrafo 7 a) de los procedimientos financieros, como base para las cuotas del presupuesto administrativo de la Convención correspondientes a 1996 y 1997.
