Parties wishing to communicate information to the secretariat concerning the list of speakers for the policy statements to be made on 2 November during the high-level segment may do so at the table near to the Conference support office (open 13.00 - 15.00 from 26 to 27 October). Delegates are requested to note that new inscriptions will not be accepted after 15.00 on Wednesday 27 October. The list of Parties (by country name) that have requested to make policy statements will be published on Thursday 28 October. Information concerning the exact order of speakers and time of intervention will not be made available until Tuesday 2 November.

Because of the limited time available, the length of speeches will be limited to 3 minutes. Parties are encouraged to consider having statements made on behalf of groups of Parties, in which case a time limit of 5 minutes would apply and preference in the speaking order will be accorded.

Credentials

Credentials of representatives, alternate representatives and advisers shall be issued either by the Head of State or Government or by the Minister for Foreign Affairs. Delegations are kindly requested to forward the corresponding letter of credentials to the secretariat in La Marée (Carrie Bullington).

Funding for delegates

Delegates from Parties eligible for funding are requested to contact the secretariat upon their arrival at the Administrative office in the foyer. The office will be open daily from 9.30 to 18.30. Participants are kindly requested to present their passports or other official identity document (photo ID), tickets and boarding pass stubs to the travel officer when claiming DSA payment. The travel officer will make a photocopy of the boarding pass stub and the ticket. The passport or photo ID will be used to confirm the identity of the traveller.

Bank holiday

Monday 1 November is a German public holiday. Neither the bank in the Maritim nor elsewhere in Bonn will be open that day.

Parking

Each delegation is entitled to two parking permits. Heads of delegations are requested to send someone with the necessary

authorization to pick up the request form from the Registration desk and collect the parking stickers on the day of the accreditation or thereafter. Cars will be allowed to drive to the barrier to drop passengers. Only cars bearing these stickers will be allowed to park in the reserved parking area outside the conference premises. Parking in the Maritim garage requires stickers, but the parking fee is at participants' own cost.
