PROVISIONAL ADMITTANCE OF OBSERVER ORGANIZATIONS

Note by the secretariat

I. INTRODUCTION

Applications have been received from a number of intergovernmental (IGOs) and non-governmental organizations (NGOs) for admission as observers. The Bureau of the Conference of the Parties (COP) has recommended that each subsidiary body may admit new applicant organizations that have been screened by the secretariat to attend the sessions of the body for which they have applied, without prejudice to subsequent action by the COP. The secretariat has screened these applications on the basis of the provisions of Article 7.6 of the Convention and in accordance with the procedures established by the COP for the admission of organizations as observers, that is, that the organizations be non-profit oriented (tax exempt) in the case of non-governmental organizations, and that they be qualified in matters covered by the Convention.
